OUTCOME OF THE REVIEW: DECISIONS OF THE RETURNING OFFICER/ELECTORAL REGISTRATION OFFICER FOLLOWING CONSULTATION WITH THE CHAIR OF THE GENERAL PURPOSES COMMITTEE

1. INTRODUCTION

- 1.1 The General Purposes Committee on 10th December 2014 received a report from the Returning Officer/Electoral Registration Officer on the review of polling districts and polling places that was underway in accordance with the Representation of the People Act 1983 and the Electoral Registration and Administration Act 2013.
- 1.2 In order to enable the review to be completed by 31st January 2015 as required by the legislation, the General Purposes Committee delegated authority to the Returning Officer/Electoral Registration Officer to agree the final arrangements following consultation with the Chair of the Committee. The final proposals were also to be copied to the other members of the General Purposes Committee.
- 1.3 Following the General Purposes Committee on 10th December and in accordance with the legislation, the representations of the Returning Officer on the review were published for consultation, including information on the location of polling stations (existing or proposed) within polling places (existing or proposed). The consultation ended on 26th January 2015.

2. OUTCOME OF THE REVIEW

2.1 The representations received during the consultation period and the proposals for polling districts and polling places to apply with effect from 31st January 2015 are set out below and in the attached schedule.

3. POLLING DISTRICTS

- 3.1 The Electoral Commission guidance states that the following should be considered as part of the assessment of the suitability of polling district boundaries:
 - Are the boundaries well-defined? For example, do they follow the natural boundaries of the area? If not, is it clear which properties belong in the polling district?
 - Are there suitable transport links within the polling district, and how do they relate
 to the areas of the polling district that are most highly populated? Are there any
 obstacles to voters crossing the current polling district and reaching the polling
 place e.g., steep hills, major roads, railway lines, rivers?
- 3.2 Further to the review and consideration of the representations received during consultation, consideration has been given to a number of matters in connection with polling districts as follows. With the exception of the changes recommended below,

no other amendments are proposed to the existing polling districts within the borough.

Blackwall and Cubitt Town Ward – Polling districts BC1 & BC2

Representations were received to move all of New Providence Wharf and Ontario Tower into polling district BC2. This suggestion was welcomed by the Returning Officer. Outcome of review:- all of New Providence Wharf and Ontario Tower to be moved into polling district BC2.

Blackwall and Cubitt Town Ward – Polling districts BC2 & BC3

During consultation on the Returning Officer's proposals, representations were received to move the houseboats on the north side of Blackwall Basin (currently Arpad, Noelle, Maid of Steel and Jessica) into polling district BC2 because access to the boats is via Boardwalk Place. This suggestion is proposed for agreement.

Outcome of review:- the houseboats on the north side of Blackwall Basin to be moved into polling district BC2.

Bethnal Green Ward - Polling district BG5

Representations were received to split the polling district BG5 so as to create a separate district in the east of the existing area, specifically for the Queen Mary University campus. This suggestion was welcomed by the Returning Officer.

Outcome of review:- Polling district BG5 to be split so as to create a separate district in the east of the existing area, specifically for the Queen Mary University campus.

Canary Wharf Ward – Polling districts CW1 & CW2

Representations were received to amend the boundary on the west of Westferry Road to include the whole of the Millennium Harbour development within CW1, thereby making the boundary run to the south of Edison and Vanguard Buildings. This suggestion was welcomed by the Returning Officer. Outcome of review:- The boundary on the west of Westferry Road to be amended to run to the south of Edison and Vanguard Buildings, to include the whole of the Millennium Harbour development within polling district CW1.

Canary Wharf Ward – Polling districts CW2 and CW3

Representations were received to amend the boundary between the two polling districts above but no detailed suggestions were provided. Outcome of review:- No change to existing boundary between polling districts CW2 and CW3.

St Katharine's and Wapping Ward – Polling districts SK1 and SK2

Representations were received to revise the boundary between these districts to run north/south along Garnet Street, rather than east/west as at present. The Returning Officer did not support this suggestion as he considered that it would result in an

increase in the number of electors having to vote at a polling station other than the one closest to their home. **Outcome of review:- No change to existing boundary between polling districts SK1 and SK2.** The Returning Officer however noted the representations made during consultation on his proposals that this boundary, which currently splits in two the Riverside Estate, could be reconsidered in the future.

St Peter's Ward – Polling districts SP2 and SP3

Representations were received to move the boundary between these polling districts so that it continues along Old Bethnal Green Road rather than through the middle of the Mansford Estate. The Returning Officer welcomed this suggestion. Outcome of review:- The boundary between polling districts SP2 and SP3 to be moved so that it continues along Old Bethnal Green Road rather than through the middle of the Mansford Estate.

Whitechapel Ward - Polling district WH3

Representations were received to split WH3 into two polling districts, using Backchurch Lane as the boundary between the two new polling districts. The Returning Officer welcomed the suggestion to split polling district WH3 but proposed that the boundary should run through Gowers Walk and not Backchurch Lane, as the residents in Backchurch Lane are very close to Harry Gosling Primary School.

During consultation on the Returning Officer's proposals, representations were received to support this proposal but further suggesting that at the southern end of Gowers Walk, the boundary should turn east along Hooper Street and then south along Backchurch Lane to the southern boundary of the existing polling district. This proposal was included in the initial draft decision note for consultation with the Chair of the General Purposes Committee. However, following further detailed examination of the area, officers identified that this would leave the properties in the small area bounded by Hooper Street, Backchurch Lane, the railway line and Leman Steet potentially having to walk further to a new polling station than to the one they are familiar with, and in addition they would have to cross Leman Street. An alternative solution was therefore proposed to amend the boundary to instead run from the southern end of Gowers Walk, west along Hooper Street to the junction with Leman Street and then south along that street.

Late representations were subsequently received, proposing that polling district WH3 should not be divided at all but should remain as at present. This proposal was considered during the final consultation stage. On balance for reasons of elector convenience, accessibility and efficient management of the venues, it is proposed that division of the polling district should proceed. Outcome of review:- Polling district WH3 to be split into two polling districts, using Gowers Walk as the boundary between the two new polling districts and at the southern end of Gowers Walk, the boundary to turn west along Hooper Street and then south along Leman Street to the southern boundary of the existing polling district.

Note: Ward name

3.3 Alongside the above, the Returning Officer has received representations that the name of the Canary Wharf Ward should be amended to 'Millwall' to reflect its history and geographical location. The Returning Officer does understand that this is not a unanimous view and that other local residents may support retaining the current name for reasons of continuity and stability. In any case, this is not a matter for which the Returning Officer has responsibility or which can be taken forward as part of the current review. There is provision in law for the Council to change the name of a ward by a two-thirds majority vote at a Council meeting called for the purpose, but if such a decision were to be made within five years of the most recent (2013) electoral review, the prior agreement of the Local Government Boundary Commission for England would be required.

4. PROPOSALS – POLLING PLACES

- 4.1 In relation to polling places, the Electoral Commission advises that factors including location, size, availability and accessibility should be considered when reviewing existing polling places or when assessing new polling places.
- 4.2 The Council must have particular regard to the accessibility needs of disabled persons and as part of the consultation exercise the authority actively sought representations from persons with particular expertise in relation to access to premises, or facilities for persons who have different forms of disability. Each proposed venue is inspected and assessed for suitability, safety and compliance with the provisions of the Disability Discrimination Acts (DDA).
- 4.3 Further to the review and consideration of the representations received during consultation, consideration has been given to a number of matters in connection with polling places as follows. With the exception of the changes recommended below, no other amendments are proposed to the existing polling places within the borough.

		However, during site visits a potentially suitable permanent building was identified and discussions are underway with the proprietors of the Radisson Blu Edwardian Hotel, New Providence Wharf regarding use of that venue as a polling place.

The Bromley-by-Bow Centre is therefore proposed as the new polling place.

The Returning Officer agreed and was keen to identify an alternative polling place. He received representations and proposed the use of East Wintergarden, Canary Wharf.	
		During consultation on the Returning Officer's proposals, representations were received that East Wintergarden would not be suitable as the location is remote for all residential areas of the polling district. Two alternative locations for a portable polling station were suggested.	
		Following site visits by officers the initial draft decision note proposed that the polling place be a portable structure on the paved area at the western end of Cuba Street, near West India Pier. However, further representations were received that this would be unsuitable for reasons of inaccessibility and location. Following consultation with the Chair of the	

		General Purposes Committee the decision has been taken, as previously proposed, to use East Wintergarden, Canary Wharf.
