Mayor's Report to Council 21st September 2016

John Biggs, Mayor of Tower Hamlets

This is the first Mayor's Report since the Summer. It has again been a very busy period, although a little quieter in August.

Work has continued with thinking about next year's budget, and the need to protect services while making savings.

We have hopefully reached a point of greater progress in exiting the Directions imposed on us under the previous Mayoral administration.

Further to the 'Organisational Review' announced in my last report, a consultation is currently under way on a new, leaner council structure at its top three tiers. This will better focus on my administration's priorities, and will contribute to our budget savings target.

I held my fifth 'Mayoral Assembly' in Poplar recently. It was well-attended and as always helped to make my administration more transparent and introduced me to or reminded me of a range of resident concerns.

The Mela took place successfully at the end of July. I am pleased to report that not only does it appear to have been an enjoyable day but that the anxieties which led to a deputation to the last Council meeting appear not to have been borne out.

A few other points:

I am delighted that Phillip Glanville has been elected as the new Mayor of Hackney.

As a civic duty, I recently had the pleasure of meeting Prince Charles at the reopening of Shadwell Fire Station.

I recently attended a 100th birthday party of a resident in Bow. Her family, as are many, are now scattered across the country but it was great to see and congratulate a resident who has 'seen it all'.

Next month sees the 80th Anniversary of the 'Battle of Cable Street', an historic occasion at which of course there will be a very small number of residents present who remember those events directly. Keeping the memory alive is important and the commemorations will help us to do this.

Key Events/Announcements

Budget Over the Summer myself, cabinet members and officers have been discussing and working up proposals to balance the Council's budget, while meeting existing and new priorities and reducing spend by approximately £60million over the next three years. This is going to be an extremely difficult exercise, but it is my duty to help us steer our way through it. The exercise is, after all, one which many other councils have carried out. I will work with colleagues to try to ensure that we develop proposals which protect the most vulnerable, continue to improve services for all, are underpinned by a commitment to equalities, and which promote community cohesion.

Organisational Review On 14th Sept General Purposes Committee received a report on the proposed new top level organisational structure of the Council.

This will be subject to consultation over the next few weeks. I have been engaged in conversations with the Chief Executive, my Cabinet and others about the principle of these changes and believe they represent a good set of ideas as to how we can better manage our resources, achieve stronger corporate governance, meet our new priorities and serve local people, while helping us to meet our budget challenges.

Youth service Audit Committee last night received a report on the youth service. While I believe that even now not all has been disclosed I am pleased that, finally, we are able to discuss more openly the events of the past few years. It places in a new context the role of some local politicians and the recent protests at a Council meeting about the service. I am committed to us providing an excellent service. Returning to the investigations, I understand that over £2million has gone 'missing', and one may assume this was effectively stolen. My outrage is added to by the understanding that the Metropolitan Police appear unable to secure enough evidence to mount any prosecutions. This is a blot on the recent history of our borough, which sits alongside, and was possibly connected in some ways with, the political events of last year.

Commissioners: I have just written to the Secretary of State with our latest six month review of progress against the Directions. I am hopeful that three of the seven directions – on Staffing, Procurement and Elections – will end. I was hoping for a fourth – on Communications – but with a new service head in post the new proposals for the delivery of our communications remain fresh and I understand that the Commissioners wish to see further progress with them. On Grants, I am hoping that we might regain our grant making powers, but with a modified direction, in which decisions will be made by my cabinet, subject to the new scrutiny arrangements and subject also to a continued oversight Direction. This would mean that Commissioners would no longer hold executive powers. On property, there remain some matters to resolve, principally about the use and charging of community buildings.

The Commissioners have discussed at length 'whistle blowing' and we have reviewed and relaunched our policy and processing in a way that should regain confidence. As regards historic complaints, a '**Clear Up**' Team' has been set up to deal with any remaining allegations of impropriety or serious concerns residents or staff might have. The team will investigate outstanding allegations which may have taken place between October 2010 and June 2016.

Early Years: The consultation on Early Years savings has finished. We are considering the options. It seems likely that the core 'offer' of 12 Childrens Centres will be confirmed, together with I hope a number of 'satellites'. However a proper analysis of the consultation responses is required and more information will be provided when this has happened and a decision can be made.

Air Quality & its link to road vehicles: I am progressing with Ayas Miah, Amy Whitelock Gibbs and Rachel Blake our policy development on Air Quality. This will sit alongside the Mayor of London's priority, which will be announced soon. I am instructing officers to develop a comprehensive approach to the Silvertown Crossing application, designed to take account of

these matters and the other interests of our borough, including tackling the appalling congestion and poor air quality at Blackwall.

Community Language Service: There will be a 'petition debate' at tonight's meeting. I will make a statement at that time and I hope that this will be appended to the minutes of the meeting. I do value the service, and I know that many in our community do. I do however recognise that many others question its appropriateness for public funding. I will be recommending that we retain support for the service but that regardless of the final choices, which the Council must consider in its budget making, we must consider the findings of an Audit report, received by the Audit Committee last night. We will need to make some tough choices about the way the service operates, both in the short term and into the future.

Somali Taskforce: My taskforce concluded its evidence and has drafted a report. I have asked Cllr Amina Ali to Chair, and Cllr Whitelock Gibbs to be the Deputy Chair of the Group as it moves into an implementation phase. I am impatient for progress and look forward to hearing, and making, announcements soon.

Housing Strategy: A draft housing strategy has been published for consultation. We are making progress with housing and will make further announcements soon.

Health & Wellbeing Board: I have stood down from the Board, but with a commitment to attending when required, and from time-to-time. I appointed Amy Whitelock Gibbs as its Chair and meet with her, the Directors of Adult Services and of Public Health and representatives of the CCG and various Health Trusts regularly. Good health outcomes, and a particular interest in progressing our joint responsibilities including for public health remain a priority.

Tower Hamlets Community Housing: I wanted to record my appreciation for the work of Mike Tyrrell as Chief Executive of THCH over the past few years. While I should declare that he happens to be an old friend, I believe that he is widely acknowledged to have done a fantastic, and caring, job in launching and establishing THCH. It is in many ways an exemplar and, while all such organisations face challenges, I wish all of our Social Landlords showed the same level of attentiveness, entrenched in their culture, to the well-being of their residents.

Election Petitioners: I am of course here following the election petition, disqualification of my predecessor and subsequent by-election. It distresses me that following the success of their challenge they now face ruinous legal bills. I will be writing urgently to the Prime Minister on this matter, as it appears to defy the rules of natural justice that this should happen.
