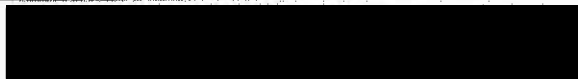

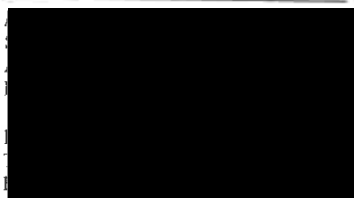
Thank you for inviting me to the consultation on 7th Feb 2017 to discuss your proposal for an alcohol license at the Rochelle Canteen.

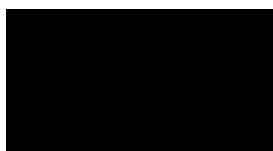
Thank you for presenting your case to the the local community yesterday evening.
