Mealworm dumplings and virtual reality: the best date ever?

The Shuffle festival in east London runs until this Saturday, and its science programming is genuinely exciting. And that's before we get to eating worms ...

It was about the time that the starter arrived that I began to fear for my four-month-old marriage.

Let's be clear: I hadn't exactly lied to my husband. I had told him that I was taking him out to lunch and then to see a short film.

I just hadn't told him that the restaurant was in a tree in Tower Hamlets cemetery park, lunch was mealworm dumplings and a sort of corn fungus or that the film was a virtual reality trip into a refugee camp in Jordan.

I'm the best wife. The best.

I'd like to make it clear that the day I had planned wasn't entirely a stab in the dark in terms of enjoyment. We both like food and films, and the Shuffle festival promised both, with its week-long programme of science, film, storytelling and more, all linked to this year's theme: Movement, Migration and Place. The two elements which had caught my eye were the Symbiosis treehouse restaurant and a virtual reality film experience called the Feelies.

The festival is funded in part by the Wellcome Trust, who have had a bumper year at festivals across the country this year, with science seemingly more popular with the public than ever before. Grace Boyle, science programmer for Shuffle, sees this outreach as being key to the spirit of Shuffle.

"It's a community festival first and foremost" she says. In the face of gentrification of urban areas and the middle-class lionisation of London's arts scene, she points to the community engagement that is central to the ethos of Shuffle. "The low price point is very important - a fifth of the tickets for the Feelies were set aside as concessions, we went to all the local schools and colleges, we're working with 50 local organisations and four of the lunches in the restaurant were charity lunches."

The restaurant is a pop-up treehouse, designed by Jessica Sutton and with the kitchen run by forensic-scientist-turned-chef India Hamilton. For £15 we were promised a three-course meal which would make us consider our relationship with food, the environment and, as it turned out, each other.

As the name suggests, the restaurant is working to a theme: symbiosis. The menu was put together according to the different types of symbiotic relationship: mutualism (a relationship which is mutually beneficial to both organisms); commensalism (in which one organism benefits and the other isn't significantly harmed or helped); amensalism (one organism adversely affects the other, but derives neither benefit nor harm itself) and parasitism (in which one organism benefits to the detriment of the other).

The menu was varied, with influences ranging from Europe to Asia and south America, and excitingly (to me, anyway) some dishes contained ingredients foraged from the cemetery park itself.

Having been on a Gap Yah in south-east Asia many, many years ago, I have already experienced the delights of fried insects and the lesser joys of boiled insects. With this and the importance of investigative journalism in mind I chose the mealworm dumpling starter, fully expecting my husband to go down the squid or blue cheese route. However, he gamely opted for the dumplings too, with a corn smut chicken taco main. I chose the orzotto-fungi-algae combination for my main course, and we sat back to wait. I spent the time enjoying the feeling of being high up in the forest, watching the leaves sway around us and sniffing the enticing smells emanating from the ground below. My husband spent the wait anxiously looking at the plates of other diners and saying fretfully: "Corn smut is a fungus? I'm going to be sitting in a tree eating fungus and worms? I think society might be moving backwards." It's fair to say he was nervous.

The mealworm starters arrived, looking extremely unwormy, which I'm going to say was a plus. It was liberally laced with chilli, giving it a good kick, and the kimchi was all that fermented cabbage should be. The dumplings themselves were pretty tasty, although seemed slightly rubbery and undercooked (possibly a consequence of the torrential downpour the day before, which had disrupted power and construction across the site). However, they were pretty enjoyable; well, my husband said "not horribly offensive" and rather enjoyed the kimchi, so we'll take that as a win. The very nice chap sitting next to me at our communal table offered me a taste of his blue cheese starter, which was gorgeous: rich, creamy with the slight bite of mould.

The main courses impressed in their simple tastiness. This in fact was a real triumph: to introduce new and potentially challenging foods such as algae and corn smut (also known as Mexican truffle or huitlacoche) and turn them into something that was more than palatable as well as being unconfounding seemed to me to be the beginning of a great conversation about food sources and security.

The dessert was absolutely gorgeous in taste and presentation: a lemon and gooseberry posset with edible violet flowers which , pleased everyone at the table. We left the restaurant impressed and thinking about cooking orzotto with algae at home: a definite win for sustainable food.

Next up were the Feelies, two multisensory films using virtual reality headsets. Boyle explained that the idea for the installation came from a long-standing desire to create a version The Feelies as conceived by Aldous Huxley in Brave New World. “In Brave New World it’s quite a clunky experience, so this was about thinking ‘in 2015, what’s the next natural step?’”

The films were the work of production company Vrse.works and produced by Patrick Milling Smith and digital artist Chris Milk. They were chosen for their relevance to the festival’s theme and an experience was then created around them by Boyle with Charles Spence and Charles Michel from the Crossmodal Research Laboratory at the University of Oxford. What they have devised is a fantastic small-scale, intimate experience. Only four audience members are admitted at a time. Assigned a volunteer technician each, audience members are fitted with headsets and headphones and led into the the viewing rooms. Neither my husband nor I had used a VR headset before, much less in a truly immersive setting like The Feelies, and it blew us away.

Without wanting to give too much away, the first film, *Walking New York*, placed us squarely amongst the sights, sounds and sensations of the city and in the midst of the construction of a huge artwork. The second, *Clouds over Sidra*, took us across real sand to sit in the Za'atari refugee camp in Jordan to observe the life of families living there. The feel of the desert in winter, and the smell of baking bread, among other sights and sounds, were captivating. Both films are provocations on the idea of migration and place, and if that sounds like a rather heavy way to spend your leisure time I have to urge you: go and try it. We left informed, uplifted, moved and with a fresh perspective on the human stories behind both films.

Both pieces of footage are available on the Vrse.works app, which is a key part of taking this campaigning filmmaking further, but if you're in east London this weekend, I recommend you go and check it out for yourself at Shuffle.

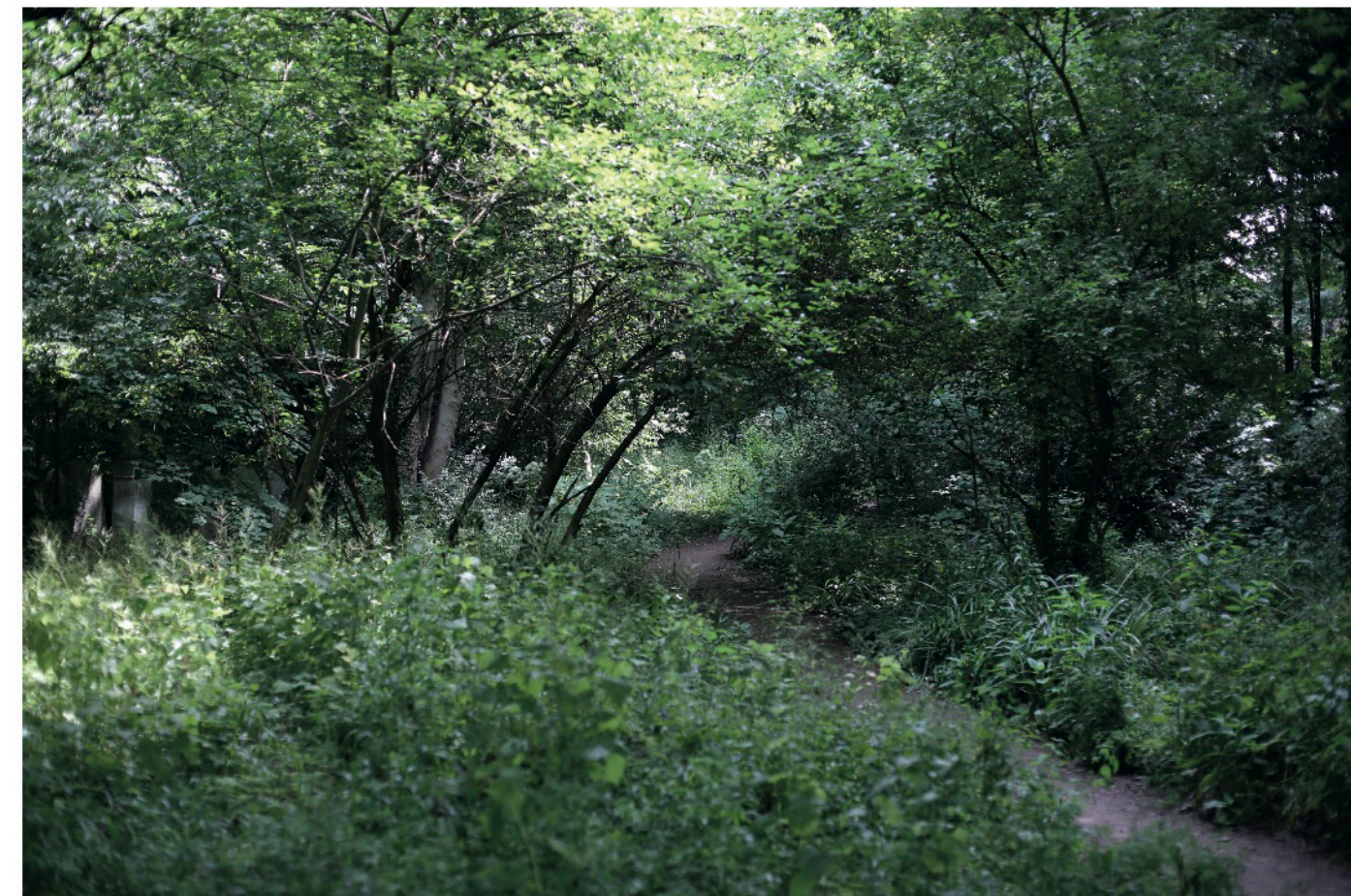

REINVENT THE LODGE

THE CEMETERY'S VALUE IS IN ITS MYSTERY

Tower Hamlets Cemetery Park is 31 acres of semi-wild woodland in London's Mile End. Under-used and languishing, the park is a walk-through, but few people hang out there.



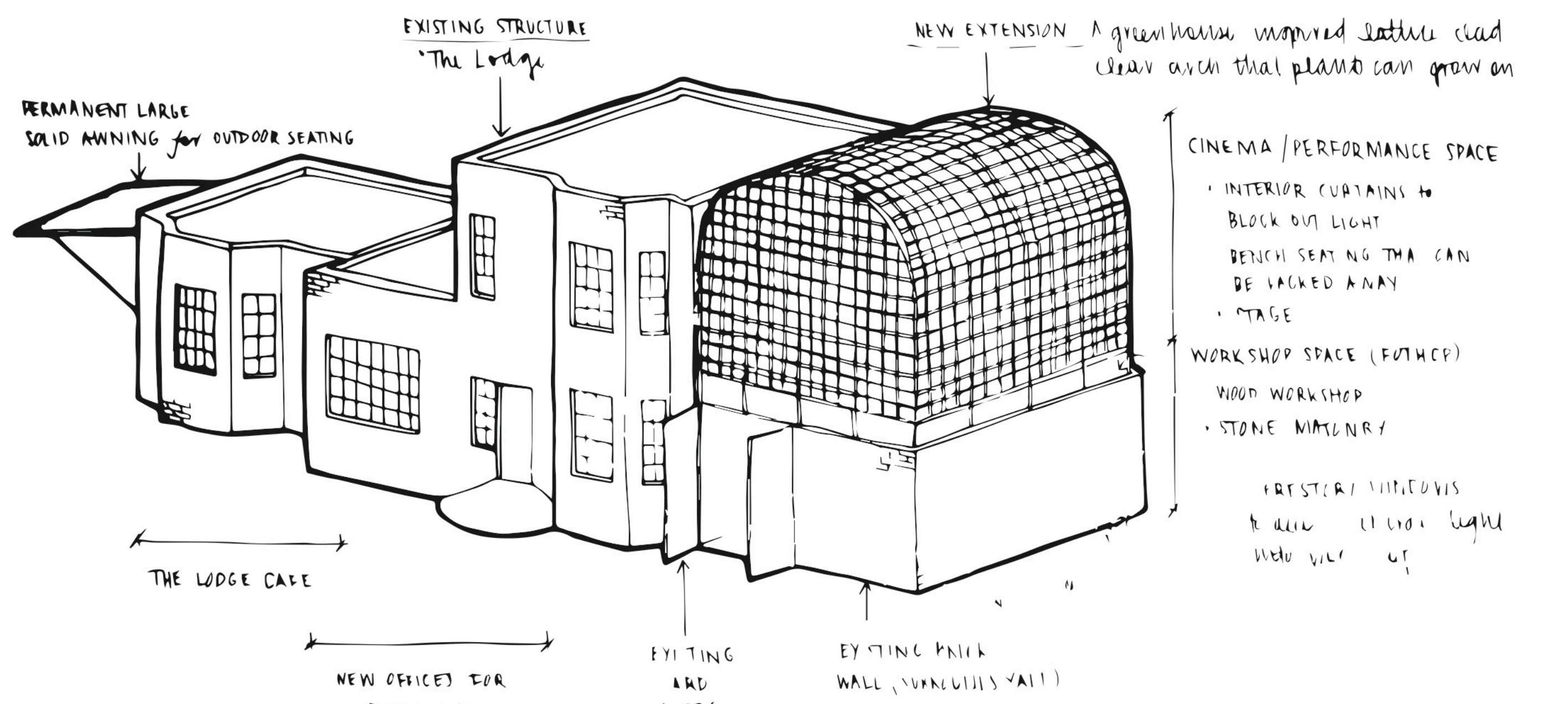
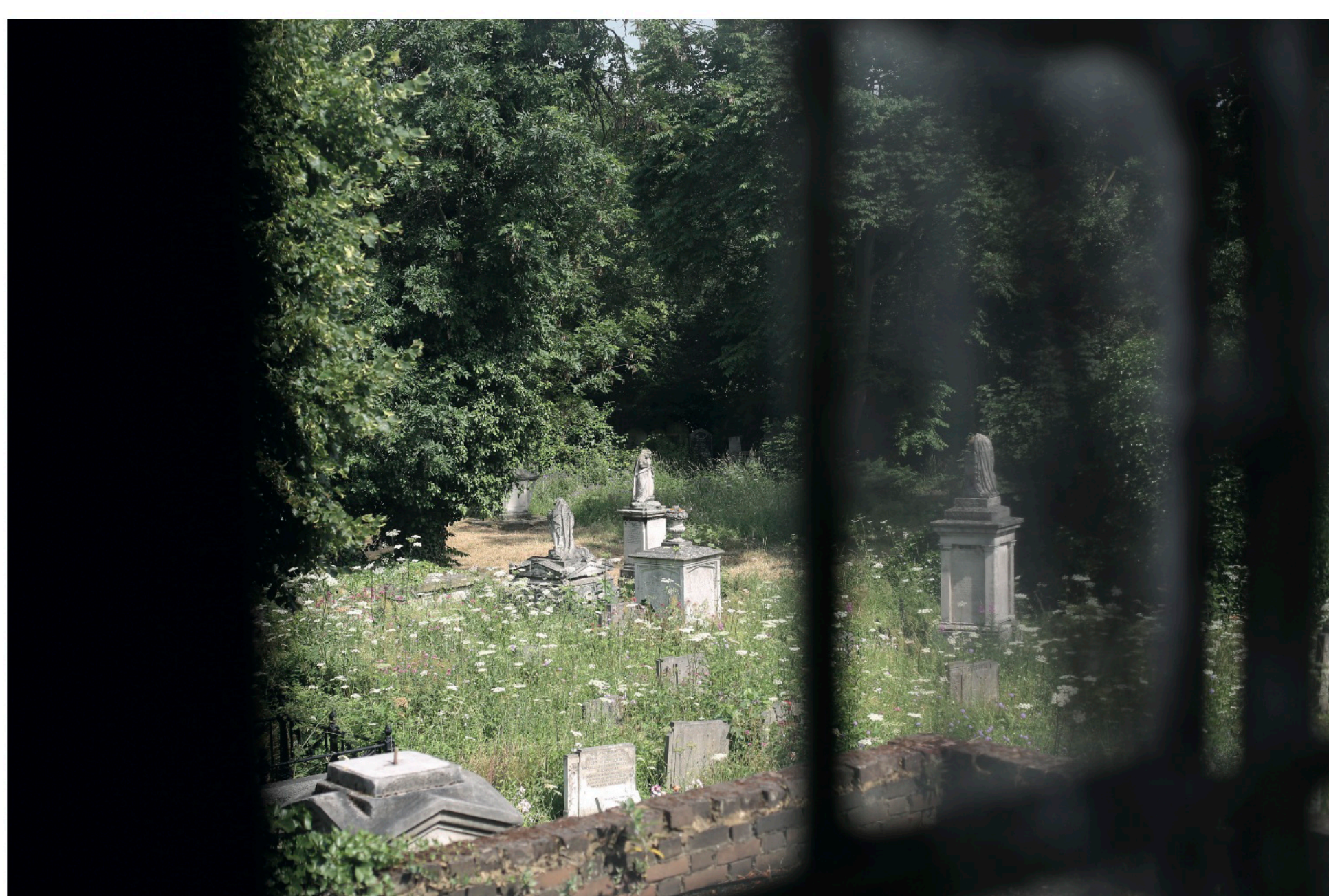
THERE IS MORE VALUE TO BE HAD FROM ITS USE

Project re-imagines the derelict Lodge, which once housed a park-keeper, as a year-round community café and events space, with a laboratory for explorations of science and ecology. It seeks to create a much-needed hub for the park, where art, nature and traditional skills can be taught and celebrated. Uses include workshops, film screenings, education, training, science activity and cultural events.



SHUFFLE FESTIVAL: FEASIBILITY STUDY

The hugely popular and well-received Shuffle Film Festival has been held in the park for previous two years. Ephemeral and imaginative, these events have been building up energy, forging relationships, growing capacity and generating legitimacy for permanent change. The festival has steered and moulded the project to make it what is wanted locally. The recent crowd-funding campaign has raised the full £58,000 needed.



OBJECT RATIONALE

Shuffle has been staging cultural events in the site and surrounding area for three years, bringing people in and catalysing change. Through its crowd-funding campaign, Shuffle has raised £58,000 to renovate the existing cemetery Lodge building into a unique cultural facility. Seeking to create a model that people can use again, the intention is to have a functioning business in place after three years with local people trained and running it.

Social processes that flow from this project are a mixture of formal and informal, structured and spontaneous. It draws in individuals and brings together local interest and support groups with schools, youth groups and institutions such as universities.

THE MODEL

Revenue is generated by café and by renting out space in evening. The facility is maintained by volunteer input; the Friends of Tower Hamlets Cemetery Park annually engages 3000 volunteers. The project also creates 4 to 5 new jobs, sustained by project revenue, rather than fund-raising, which would be vulnerable to cuts.

The local authority retains ownership of the Lodge, which is leased to Friends of Tower Hamlets Cemetery Park rent-free for three years, and sub-leased to in turn Shuffle.

The partnership with Friends of Tower Hamlets Cemetery Park, a well-established organisation, sustains and channels local long-term engagement with the project.

The project is protected from attempts at external capitalization by its ownership by the local authority and its specificity as a historic cemetery and a nature reserve. Its partnership with Shuffle - and the 331 donors to its recent crowd-funding campaign - gives the project a voice and a constituency that will speak out protect it from any such attempt.

CREATING VALUE

The value in this project is in its creation of a place to meet, a place to be and things to do. Giving people permission to inhabit this large space in new ways will help local people enjoy a greater sense of belonging and pride, a feeling of being at home.

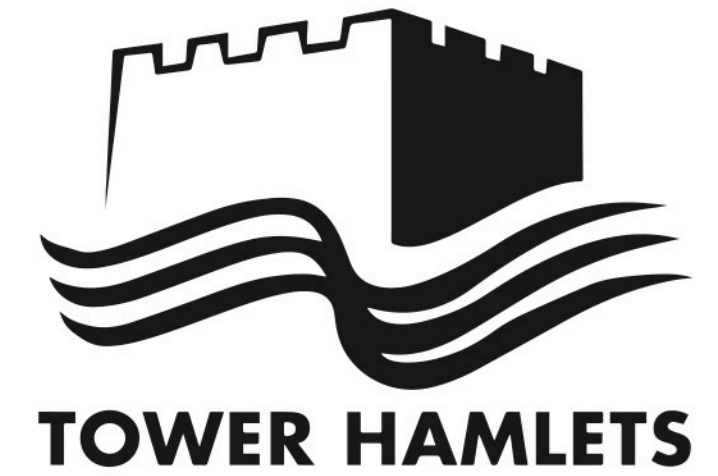

It'll serve as a community club house of sorts and permanent venue that will allow Shuffle's cultural knees-up to run all year round.

I'm please to say that since Shuffle arrived in Mile End in 2013 there have been no crimes recorded within the footprint of Tower Hamlets Cemetery Park during the days and weeks the festival was operating. In comparison to other festivals within Tower Hamlets, that is quite an achievement and one that you and everyone involved in Shuffle can be proud of.

In the years that my team and I have policed Shuffle, the feedback from operation debrief has always been positive, especially of the security provided to attendees. This year was no exception. We are thankful for the opportunity Shuffle has provided us in the past to invite different cross sections of the community to come together and find common ground. As you can probably imagine, occasionally the Police struggle to meet with and communicate with some sections of the community, sometimes this comes down to a lack of trust of the police or an understanding of our role. However Shuffle has enabled the Police in Mile End to get together with these groups and find common ground. Whether discussing a common interest in film, music, comedy or the arts. This has enabled us to work with these groups on future projects and in some instances helped us to prevent anti-social behaviour from continuing in some areas.

£59,000 target, the building will include a café, music venue and a gallery space, all to be used by the community.

Shuffle Festival moves around Mile End and hosts events such as film screenings and exhibitions in different areas.

Previous locations included St Clements, a former mental institution, which was reopened by Shuffle. Director Penny Boyle, known for being the artistic director for [the London 2012 Olympics opening ceremony](#), is a strong advocate of Shuffle Festival, helping them find a location for their inaugural festival, as well as giving public support for the festival's, and Mile End's, community causes. Boyle annually curates a selection of films, art and community workshops to show off the Mile End community spirit.

Alongside the newer additions to The Lodge, the space will also be used as an educational area, where Shuffle will hopefully stage workshops for children and adults. While The Lodge now finds itself in Cemetery Park nature reserve, run by the Friends of Tower Hamlets Cemetery Park (FTHCP), it continues to hold free nature and science based classes that work alongside the national curriculum for members of the Tower Hamlets community. After being held at St Clements last year, Shuffle quickly saw an opportunity to begin a permanent addition to the community.

"10,000 people came and we knew we were onto something", said Kate MacTeirnan, director of Shuffle Festival. She began to construct a festival that worked to better the community, as well as showing strong elements of Tower Hamlet's culture, not just specific an anti-gentrification message.

It's win or bust for park lodge appeal

Fundraisers have one week to hit £59,000 target... or lose the lot

BY JAMES MARTIN

A SPITALFIELDS community group needs to find £18,000 in just a week to reach an all-or-nothing fundraising target to renovate part of a nature reserve.

Shuffle is seeking backers for its plan to redevelop the Lodge - a rundown former house in the grounds of Tower Hamlets Cemetery Park. With just over a week to go, the local group was a shade under £18,000 short of its fundraising target of £58,399. Because of the rules of

the 'Spacehive' funding scheme, if the full target is not raised, none of the money pledged so far can be collected.

The money will go towards both renovating and extending the Lodge, part of which will be a new office for the Friends of Tower Hamlets Cemetery Park. The volunteer organisation manages the park, which is now a nature reserve having closed for burials in 1966. A year-round community café and events space are part of the redevelopment plans. Additionally, a lab will be built for science and conservation workshops aimed at children and adults.

Cemetery Park manager Ken Greenway said: "Our park offers residents unrivalled access to nature and enjoyment of the natural world. "These funds would help us build a much-needed green hub for the park, where art, nature and traditional skills can be taught and celebrated. "As the only woodland in the borough, we want to create a hub for learning and training

around how you manage and care for biodiversity.

"We need this space to enhance the health and wealth of tomorrow's generation."

Mr Greenway, who has been with the Friends for 13 years, said the expansion would benefit the whole community.

He added: "7,000 children from local schools already visit the park each year to learn about wildlife.

"We also want businesses

to use the park as a place to have meetings in affordable office space.

"We would like to improve what we already offer. We want to run workshops and apprenticeships in traditional crafts - and to extend our forest school to help children enjoy nature.

"The extension would give somewhere for indoor classes and a place to get changed into wellies and waterproofs."

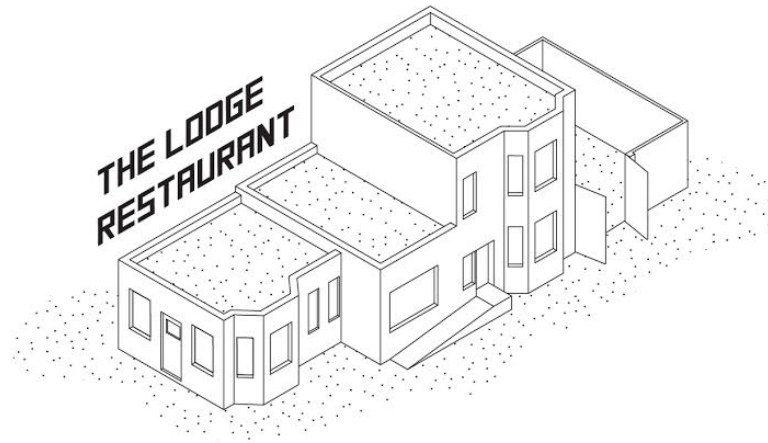
