**Licensing Act 2003
Re: Suito, 90 Brick Lane, London, E1 6RL**

Further to my representation made on 5th February 2018 I wish to bring the following to the attention of the Licensing Committee.

I have now received the following information from the Local Authority waste enforcement team.

The business known as Suito at 90 Brick Lane, has been issued with a total of 34 fixed penalty tickets for illegally discarding their rubbish. A total of 8 tickets were issued in 2016 and a total of 26 tickets were issued in 2017. These can be seen on the attached spreadsheet.

16 tickets, dating back to 16/03/17, were all paid by cheque on 25/1/18.

There are currently 8 outstanding fines remaining from December 2017 which have yet to be paid. Of these, 7 tickets were issued on 15th December 2017. This means that the premises were seen by the Local Authority CCTV team to discard their waste on seven different occasions on the 15th December 2017.

To continually flout the law despite receiving a large number of fixed penalty tickets is not how a responsible business operates. The management have a total disregard of the law. This undermines the crime and disorder and public nuisance tenet of the Licensing Act 2003. This is not how a responsible management team should operate a premise within the Borough.
