#### Appointment of Committee Chairs

Part B Section 26 (Council Procedure Rules) of the Council's Constitution states that the Council will appoint a Member to serve as Chair of each Committee established as part of this report. If the Council does not, the Committee may appoint a Chair from amongst the Members appointed to the Committee by the Council. Each Committee may appoint a Vice-Chair from amongst its Members.
