1.0 FURTHER LOCAL REPRESENTATIONS

- 1.1 Following the publication of the committee report, the Council have received two additional objections, one of which is unsigned.
- 1.2 The issues raised relate to noise, transport and access issues. These have been discussed within the report to committee.

2.0 FURTHER STATUTORY CONSULTATIONS

Greater London Authority (GLA)

2.1 Officers have been advised informally that the proposal does not raise any strategic planning issues. The impact of the will be minimal and is only for a temporary period. The GLA have advised that due to the nature of the proposal, no further consultation will be required on the application (Stage 2) and the Local Authority should proceed to determine the application.

Lea Valley Regional Park Authority

- 2.2 No objections raised on the understanding that the tree protection measures in the Arboricultural Report are to be undertaken so as to protect trees within the site and Hertford Union Canal.
- 2.3 (Officer comment: This is noted and a condition requiring the measures to be put in place has been recommended)

3.0 Further information

- 3.1 Since, the publication of the report the applicant has submitted a Traffic Management Proposal and an Egress Crowd Management Plan.
- 3.2 The Traffic Management Plan is an additional document which outlines the various contingencies in place should crowd control exceeds capacity along the main exit at Grove Road.
- 3.3 In summary, it is likely temporary road closures may be required during the opening and closing days of the Olympics when crowds are likely to be the greatest.
- 3.4 Additional contingency plans have been put into place should crowd levels exceed the



capacity of the footways on any other dates.

- 3.5 The Council's Highways Department in liaison with Transport for London, have advised that they are supportive of these measure. The final Road Traffic Order will be completed once final clearance is obtained by the Olympic Development Authority (ODA)
- 3.6 Given, the Live Nations Event is run on behalf of the ODA an objection to this management order is not envisaged.
- 3.7 With regards to the Egress Crowd Management Plan, its main responsibilities are to monitor the egress of visitors away from the event site in a safe and orderly manner, to proactively employ crowd management methods to ensure a safe egress and to implement and remove road closures if required by the Traffic Management Order.

The plan states Live Nations staff will be present at the main exit routes from the site, including the following:

- Crown gate entrance- to direct visitors to Bethnal Green Station or Mile End Station
- Route to Hackney Wick Station
- Route to Bethnal Green Station
- Grove Road/ Roman Road Crossing
- Grove Road
- Mile End Station
- Bethnal Green Station
- 3.8 Officer's welcome the publication of these documents in ensuring the event is adequately managed.
