The public are welcome to attend meetings of the Committee. However seating is limited and offered on a first come first served basis.

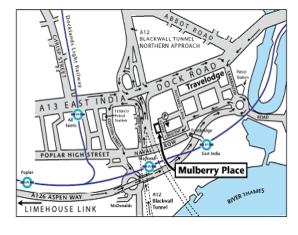

Bus: Routes: 15, 277, 108, D6, D7, D8 all stop near the Town Hall.

Docklands Light Railway: Nearest stations are East India: Head across the bridge and then through complex to the Town Hall, Mulberry Place Blackwall station.
