

Annex 1 - Mandatory conditions

- b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

Annex 2 - Conditions consistent with the operating Schedule

1. CCTV to be maintained inside and outside the premises. Recordings to be kept for minimum of 31 days and made available to Police or Licensing Authority.
2. Refusal book to be kept at the premises to record all refused sales of alcohol.
3. A recognised ID, such as passport or driving licence, shall be requested for all persons appearing to be minors.
