6. UNRESTRICTED REPORTS FOR CONSIDERATION

6.1 Pension Committee Terms of Reference, Membership and Quorum (PC/001/910)

The Service Head Corporate Finance introduced the report.

The Committee briefly discussed the report and having due regard to the current variable economic conditions it was suggested that if required additional meetings and/or briefings for the Pension Committee be held to allow Members to be fully appraised as to any significant changes to the investment portfolio. It was agreed that training would be arranged for members of the Committee

It was therefore **RESOLVED** that the Terms of Reference, Members and Quorum as set out in Appendix A of the report be approved.

6.2 Composition of the Pension Fund Investment Panel (PC/002/910)

Having due regard to the commitments of Members it was **RESOLVED** that

- (i) The Investment Panel be established;
- (ii) That membership of the Investment Panel comprise:-

- All Members of the Pensions Committee or their designated deputies and including the 2 non-voting Members
- A Investment Professional as Chair
- An Independent Financial Advisor
- The Corporate Director of Resources or nominee
- 2 Trade Union Representatives and 1 Admitted Body
- (iii) Provide that up to two Trade Union representatives (or their designated deputies) as nominated by the Staffside Secretary attend the Investment Panel as observers;
- (iv) That the terms of reference for the Investment Panel as set out in Appendix 1 of the report be approved; and
- (v) That meetings of the Investment Panel commence at 6.30p.m. with meetings of the Pension Committee to start at 8.30p.m.

6.3 Draft Pension Fund Financial Accounts 2008/09 (PC/003/910)

The Service Head Corporate Finance comprehensively introduced the report.

Members expressed disquiet at the financial performance over the past 12-18 months and debate the performance of the Fund Managers.

In reply to points raised by Members the Capital and Investment Manager (Resources) agreed to circulate financial data which would allow Members to compare fund performance especially in light of the risk parameters of the fund portfolios.

Having due regard to investment opportunities it was noted that at future meetings of the Investment Panel debate could be opened in respect of options for inward investment in the Borough to support and nurture local enterprise.

It was therefore **RESOLVED** that the report be noted.
