2. I was instructed by [REDACTED] to attend 'Gao Medical Healthcare', Unit 27 Skylines Village, London, E14 9TS in order to conduct a test purchase task on behalf of the London Borough of Tower Hamlets.
3. At approximately 13:03 hrs on the 20/06/2017 I visited 'Gao Medical Healthcare', Unit 27 Skylines Village, London, E14 9TS.
4. Upon entering the premises I was greeted by a female who appeared to be from Eastern Europe and was wearing jeans and a t-shirt. She then escorted me to a female of Asian appearance and I purchased a thirty minute massage for £25.

I was then led to a cubicle by the first female. She told me to take off my clothes and she then exited the room.

I undressed down to my underwear and then lay on the massage table. The female returned and proceeded with the massage.

As the massage came to an end she stated that there were extra services available. I asked what these were and she replied "Hand relief £30 or body on body". I declined this.

She then suggested that she does not work at the location on a regular basis but was covering for another worker. However she did mention that she worked there previously.

2. I was instructed by [REDACTED] to attend 'Gao Medical Healthcare', Unit 27 Skylines Village, London, E14 9TS in order to conduct a test purchase task on behalf of the London Borough of Tower Hamlets.
3. At approximately 12:13 hrs on the 23/06/2017 I visited 'Gao Medical Healthcare', Unit 27 Skylines Village, London, E14 9TS.
4. I was greeted at the front entrance by a female (F1) who then led me to another female (F2) within the premises. This female was wearing a short dress and heels. Both females were of Asian appearance.

I was asked if I would like a thirty minute massage or a one hour massage. I chose a thirty minute massage and paid £25 by card. I was then led into a private room by F2 who told me to undress before she walked out, I took off my clothes but remained in my underwear and then lay face down on the massage table.

The female returned and asked me what sort of massage I would like and I asked if she could focus on my back and shoulders.

During the massage she lowered my underwear and asked if I would like my legs massaging, an offer which I declined. A short time later she then asked if I would like a 'happy ending', I asked what this was and she simply replied "Yes? No?" I declined the offer but asked her how much the extra service would cost and she replied "Twenty, you try?" I declined once again.
