Statement

1. I am [REDACTED] and I am employed by [REDACTED].
2. I was instructed on the 12/03/2018 by [REDACTED] to attend 'Gao Medical Healthcare', Unit 27 Skylines Village, London, E14 9TS in order to conduct a test purchase task on behalf of the London Borough of Tower Hamlets.
3. At approximately 14:00 hrs on the 12/03/2018 I visited 'Gao Medical Healthcare', Unit 27 Skylines Village, London, E14 9TS.
4. After pressing the doorbell, I was greeted by a female of Asian appearance. She had long dark hair and looked mid- thirties. She was wearing a black dress, dark tights, and black heeled shoes. She asked me if I would like a massage, to which I replied "Yes, how much is it?" The female stated it would cost £45 and that I could pay this by cash or card, I handed over £45 cash.
5. She then who led me upstairs to a room which was painted red and had a massage bed, a brown sofa, and black blinds within. There was soft music playing in the background.
6. The female asked that I remove my clothing and lay face down on the bed. She then exited the room.
7. She then knocked and re-entered the room once I had unchanged and began to massage me.

Towards the end of the massage, the female asked if I would like to remove my underwear, to which I replied "No."

She continued to massage me but began to touch my groin area, before asking if I would like a 'happy ending' for £20 or 'body on body' for £45. I declined both offers. She then began to

compliment me stating "You have a nice body" and "You have a nice bum". She also stated that her friend would really like me. The female told me that the parlour has a different girl working each day and that she works Mondays only.

8. *During this visit I was offered, without any previous suggestion by myself, services of an apparent sexual nature.*
9. *I declined all offers of such services.*
10. *Following my visit I immediately returned to my vehicle and wrote notes on the details of the event within a document on my work-issued smart-phone on 12/03/2018. I exhibit these as DH.001*
