3. At approximately 13:47 hrs on the 23/06/2017 I visited Health One, 66 Middlesex Street, London, E. 7EZ, in order to conduct a test purchase task.		
4. Upon entering the premises I was greeted by two females who appeared to be Asian and one female who appeared to be European. I purchased a one hour massage for £55 which I paid for in cash as was told there was no card machine.		
One of the females, who was wearing a sleeveless top and a short skirt, then led me to a roon downstairs. She asked if it was my first time and I replied "Yes." She told me to undress and then exited the room.		
I undressed down to my underwear and then lay on the massage table. Upon her return, the female asked if I was sore anywhere and I stated that my back was sore. During the massage she moved her hands to the area of my groins, at which point I stated that my legs were fine, it was mainly my back that I wanted massaging.		
She then asked me if I would like a "happy ending' and gestured towards my genitals with her hands. I asked her what the cost was of this and she replied "£30", I then declined the offer. She then asked if I "liked it" and I replied "On my back, yes."
