This e-mail, its attachments and links comprise the documentation we're presenting for our Licence hearing next Thursday 26th June.

I've attached this e-mail to mine to Mr Lisowski from yesterday responding to Ms Jane Miller's e-mail from last week as I'd like that to be included in documentation forwarded to the licencing committee.

The attachments are:

- 1. Our central business case, explaining who we are, what we do and intend to do, and documenting with explanation our refutation of the objections to our licence application
- 2. Our communiques with residents both before and after our licence application
- 3. A consolidated file of on-line reviews of The Hawkhurst Vault, which unambiguously show us as a Tearoom and Lounge
- 4. A consolidated file of references and testimonials, more than three-quarters from very local residents. With apologies that some of the formatting looks odd, but we have copied without editing or changing from a range of different formats
- 5. For reference, our Waste Disposal Contract with Violia, and a trade price list from East London Brewing Company our proposed/ preferred local premium beer supplier.

It is perhaps easiest for readers to access The Hawkhurst Vault facebook page via our website www.hawkhurstvault.com where you will see many pictures of the premises, plus links to reviews and comments.

Contrary to assertions by Ms Jane Miller and perhaps one or two others, we are unambiguously a Tearoom and lounge, regular opening 8 to 8 (to 9.00 p.m. on Friday and Saturday, and sometimes for events such as Life Drawing Classes), which would like the opportunity to serve customers a very limited range of premium alcoholic beverages, similarly to many other relatively up-market catering and hospitality outlets.

We are very happy for this e-mail and its attachments to be forwarded to the Licencing Sub Committeeand objectors, in its entirety, and look forward to meeting with you and them next Thursday at 5.30.

Summary of the Business

The Hawkhurst Vault is a high quality old-fashioned tea room and lounge offering a 'laid back' ambience whilst providing luxury products and service. The tea room serves a range of teas/coffees/soft drinks and food, with as much as possible sourced locally. We also offer events such as live music/exhibitions/readings from local artists with the intent of building on the sense of community already present in East London. We are family-friendly, and welcome children and pets.

Our market is the population of E2, comprising residents, local businesses and their employees, shoppers to Brick Lane and Columbia Road, and tourists. As we establish our brand reputation, and develop regular events, we anticipate attracting people with special interests, e.g. specialist music genres and literature/ poetry, from the area. Our intimate basement lounge area is ideal for small meetings, e.g. working lunches, business meetings, pop-up shops, poetry clubs, art classes, knitting/ sewing circles.

Accessing our facebook page through our web address www.hawkhurstvault.com will give information, pictures, reviews, video-clips, etc. We have included much of this information with this submission, but for readers with on-line access the website is most easily accessible.

- We are a tea led operation offering up to 17 different teas from the Jing tea company, a London based tea operation. The range includes black tea, pu-ehr, Green, Earl Grey, and more
- We also sell coffee from Climpsons and Sons, an east London independent, new coffee roastery
- Soft drinks are from the Fentimans range, a premium product
- Alcoholic drinks are conditional upon appropriate licencing. We intend to sell a limited range of premium beer from the East London Brewing company, and wine sourced from close to London. Price lists for these products are included in the pack.

Food and snacks

- We offer a simple range of food, locally sourced croissants, pastries and cakes. (See photographs in "Reviews" attachment)
- We plan to offer a simple range of freshly made sandwiches to cater to the lunchtime 'diners'. Made in front of the customer with freshly delivered bloomer or croissant, and fresh filling.
- We run the tearooms with a hands-on presence by the owners 7 days per week, regular opening times 8.00 a.m. to 8.00 p.m. Sunday to Thursday, and to 9.00 p.m. on Friday and Saturday. For some events, e.g., Life Drawing Classes, we may remain open to 9.00. We may occasionally extend hours to 11.00 p.m for alcohol sales at special events, and use the TEN (Temporary Events Notice) as required by law.
- The property at 240 Brick Lane is a corner property on the walk from Brick Lane to Columbia Road and Hackney Road and has a very recognisable front that can be seen from 3 different angles. It has famous 'Mollie Sugden' shutters with wellknown graffiti on the outside, as well as a distinct purple exterior which we are

keeping as is, re-finished with our hand-written signage. The property is over 2 levels. The quirks of the property will be used to the advantage of the business, with the downstairs being more of a 'lounge area' and the upstairs with more traditional café seating.

- The lounge area basement consists of a mix match of comfortable furniture, bohemian rugs and an eclectic selection of ornaments and fixtures
- The walls are hung with a selection of art from local artists that we know who
 wish to get their art out to the wider audience, through our teashop. Other
 features include lots of books and vinyl records in the various alcoves
 available. We offer a book/ record share system.

The precedent for independent cafés in east London exists. The aim of The Vault is to build on this base, moving it to the next level. We are at the vintage store end of Brick Lane, or 'Beigel town'. Brick Lane and nearby Shoreditch High Street and Hackney Road have become the epicentre for the east London revival with a good selection of bars, restaurants and cafés open and busy.

The Brick Lane postcode already has an established network of cafés, with accompanying positive reputation, which we would try to integrate with and expand.

Events

- We want to run regular events on the property
- We are looking to have specific event nights, poetry readings, knitting clubs, film showings and art exhibitions, others' pop-up shops and business partnering
- · Events so far:
 - 17/5/14. A charity event for Raleigh International. A lovely afternoon of Tea drinking, money raising and Tea Quizzes. The first of what we hope will be many such events. Louise Wang's reference is on the attached consolidated reference file
 - 24/5/14- Blair Jollands gig with Russell Frost exhibition. Locally based musician and artist. Brought together community, including kids playing. (See video and leaflet attached)
 - 8/6/14- Matt Pound and Lieutenant Leek, and King Eider. Lovely live gig on Sunday afternoon. Drew crowds in walking past from the market. Created a nice atmosphere for the community and immediate street outside (video attached, and Matt's reference is on the consolidated reference file)
 - 13/6/14- Guido Spannochi. Locally based Jazz flautist Guido Spannochi turned up and played a very special little Jazz set for our clientele. Locals invited and attended (video attached)
 - 14/6/14- Wool and Water pop up show. Sold bespoke bowties for the day from an Amsterdam company. The perfect fathers' day gift idea
 - 18/6/14 and weekly after. Life drawing classes from Tony at Life Drawing UK. A great constant event that can be enjoyed by locals and passers-by
- Planned events:
 - 20/6/14. Nuala from the Haggerston Tearoom is running a little stand-up comedy night for her class at stand-up comedy school. If all goes well we can be a basis for this kind of thing to keep on happening and spread the feel outwards to other tearooms.

- 29/6/14. Paulina Mikolajzyk playing a Sunday afternoon classical music set. Paulina is a local and upcoming cellist who lives round the corner from the Tearoom
- o 12/7/14. Art print sale and spoken word poetry
- 13/7/14 Lieutenant Leek looking to start a monthly Sunday afternoon residency
- 18/7/14. "Voices in the Vault" a planned monthly themed poetry night with local and famous poets
- 24/7/14 Locally based florist Larissa Hrstic running a monthly flower workshop in the Vault – "The Vaulted Flower Workshop".
- 22/8/14. Afternoon and evening of collaborative music by local musicians
- 27/9/14 and 22/10/14- Carlos Reyes-Manzo, another local and poet will be running a charity event for Poets for Change to raise money
- local singer songwriter Ellie Hall for another Sunday afternoon gig
- Vintage clothing pop-up shop

Environment

- 240 Brick Lane is a corner property. The ground floor is 562 sq ft and the basement is 403sq ft. There is no parking, but a small outside area which can fit 2 or 3 small tables/ 4 or 6 chairs. We have comfortable space for 35 customers
- There is a high level of physical property security shutters, bars, security locks
 – as the premises was used in the past as a high-quality leather workshop
- We opened on 18th April 2014 with initial equipment sufficient to serve our initial range of tea, coffee, soft drinks and limited pastries and cakes
- We have ensured we open with appropriate compliance and risk management at all levels:
 - We have full business insurance including public and employers liability
 - Our refurbishment has ensured we comply with all local council, fire, health and safety regulations, including those required for an alcohol licence (e.g., emergency lighting, smoke and heat detectors, signage, etc)
 - Theo and James are experienced hosts and caterers with appropriate food safety, and security, health and safety compliance knowledge.

The Hawkhurst Vault is primarily a community-based tearoom. We offer local residents a place to meet, socialise, and enjoy a friendly and family-friendly atmosphere that is not pub- and alcohol based. However we recognise that many customers would like the choice to buy locally-sourced beer and other alcoholic beverages.

Our opening hours, pricing, range of drinks and food, and environment all clearly distinguish us as NOT a pub, bar or nightclub. People will not want to buy excessive amounts of alcohol from us at our prices – small bottles of premium beer or glasses of wine at £4.50/ £5.00 or more. Attached is the East London Brewery trade price list which shows that we need to sell at minimum £4.50 per bottle to make sufficient margin. Chapel Down Vinyards wine trade price is £8.99 per bottle – thus requiring similar £4.50/ £5.00 price per glass. Excessive drinkers will not buy from us, nor will they be welcomed.

Our communications with residents

We have consistently been open and comprehensive in our communications with nearby residents. The attached (separate) file contains:

- First written communique to residents on 10 March 2014 (6 days after we acquired the premises)
- Second written communique to residents on 20 March 2014, inviting them to talk with us and come to an "open house" on 29 March
- Third written communique to residents on 3 April, thanking them for their feedback and explaining how and why we modified our licence application
- Our communique at the beginning of June flagging upcoming events.

We have a (literally) open-door policy and approach, engaging whenever possible with residents passing by, without any pressure or expectation on residents, and constantly seeking their opinions and feedback on the tearoom and how it can be improved.

We also post openly and comprehensively on our facebook link, which is directly accessible through our website address www.hawkhurstvault.com. We have encouraged all residents and customers to access this site.

Residents' objections - and our response

A number of the objections appear very similar, many are identically worded. It has been suggested verbally by several of our customers that there has been aggressive canvassing of local residents by a very small minority (one or two people), aggressively against the very presence of the Tearoom, and that several signatories have subsequently been surprised at the inaccuracies portrayed by the lead petitioners in their efforts to canvass against us. Below we have attempted to summarise our response avoiding unnecessary duplication

- 1. The residents' petition: this took as its starting point our original licence application, and, we have been told, petition canvassers made significant (and exaggerated) verbal references to the original application which was changed. After listening to residents' feedback, and taking advice from officials from Tower Hamlets, police, and environmental protection, we substantially revised the application to clarify our intent, and communicated this to local residents verbally, by mailshot, and by revised notices. We have been informed by several residents that the lead petitioners did not clarify to them our revised licence application, and in fact actively misrepresented our intent by stating we were applying for a late night refreshment licence and were planning a late-night bar, which as we have clearly stated we are not. However it is clear from representations received prior to opening that this misunderstanding was not clarified by the lead petitioners as many mention a late night 'bar' or club, some suggesting until 3.00 a.m. Not surprisingly, residents generally do not wish to get involved in local residents' conflicts and differences of opinion so we only have a few references confirming this.
- We have been informed that our original request for live performance licence for non-amplified music is redundant, as this licence is no longer a legal requirement, and our stated and planned closing times minimise the disruption to local residents
- 3. Disruption of routine access: this will be minimal. We plan a maximum of 2 small tables and four chairs to the front of the premises, and possibly one small table and two chairs to the side, all physically placed on our own property

- 4. We do not have a separate or rear courtyard, nor rear access to any such area, so there will be no space or opportunity for further seating or outside activity
- 5. We completely refute the suggestion that our presence will lead to further degradation of the surrounding environment. From before we acquired the premises, long before opening, we noticed the green and surrounding streets being used by a range of people, including down-and-outs, drunks, hard drug users and dealers, and petty criminals. Unfortunately many of these individuals do contribute to litter, vomit and other mess but this situation long predates our presence, and we sincerely believe that the clientele we attract serve to improve the area and drive away the "low-life" who, it appears, prefer to operate in the half-light and away from activity. See references from local residents. Our presence, if anything, has had a noticeably positive impact on the area and acts as a deterrent to criminal activity.
- 6. From the start we have been very conscientious in ensuring that any of the waste that we produce is removed timely and thoroughly. We have a commercial waste collection agreement with Veolia Environmental Services, a Tower Hamlets partner. (Attached) This compares very favourably with the piles of uncollected domestic waste on pavements in the area about which we frequently progress-chase Tower Hamlets to ensure its timely clearance. We also make a conscious effort to regularly sweep the exterior of the shop front to ensure minimal cigarette butts and litter
- 7. Many of the objections to our licence are frankly contradictory as well as inaccurate, for example the suggestion that the area is wholly residential ignores our adjacent business neighbours, and is contradicted by the acknowledgement that our location is on a busy pedestrian through-route from Brick Lane to Columbia Road. Representations at first reference how there are enough 'bars' in the area, but then state how the area at this current time had no 'bars'
- 8. There is little or no noise "spilling" from the tea room. Our basement area by its location provides significant sound insulation, and as noted, our maximum capacity as determined by the authorities means there will never be large crowds attracted to the tearooms milling in the area unless special events occur, when a TEN will be applied for
- 9. Many of the representations are based on assumptions of what effect we will have on the area and what trouble will be caused, for example the assertion that there will be an escalation of 'tampons, syringes, glass phials, condoms'. However as can be seen from the attached references from residents who have visited our establishment, both regularly and for events, these assumptions and assertions have no factual evidence to support them and are incorrect. In fact these assertions are offensive
- 10. Representations reference an application in 2007 for a change of use from A1 to A4 and cite this as a reason for the Hawkhurst Vault not to be granted a licence. The 2007 application significantly pre-dates our business and is nothing to do with the Hawkhurst Vault. We are operating on an A3 licence on a temporary change of use from A1. Our application is completely different from the 2007 application, and we are aware that any licence granted would be specific to the business and current business owners, and not be transferable or changeable without a completely new application. We see this objection as completely irrelevant to our application.

Positive references and reviews

The reviews generally confirm our market positioning – we are a tea rooms, not a bar, and our marketing focus represents us exactly thus.

The references generally refute the concerns and fears expressed by objectors.

We have also attached a file with three video clips of some of our live events. We believe these clips show the friendly, family-friendly civilised nature of our events, whether with or without alcohol served.

in conclusion

We do acknowledge that there is some genuine, although entirely unfounded, fear of our new, different venture, which does attract some different people to the top end of Brick Lane. The east end/ E2 postcode, is constantly changing – with different communities and ethnic groups living and working in close proximity, peacefully and cooperatively.

We shall continue to positively listen to feedback from our neighbours, and address their concerns appropriately. As a matter of principle, we shall not be drawn in to a "vendetta", with neighbours being encouraged to "take sides", which, we confess, it sometimes sadly feels is the approach of one or two of our neighbours.

The Hawkhurst Vault is just one dimension of our constantly changing community, and, we believe, adds to the diversity of local life. We are responsible, mature individuals who will ensure that our business complements the area – it is in our interests to ensure we live harmoniously with our neighbours and play our part in maintaining the many positive aspects of living and working in Tower Hamlets.




One of the many things that Peachy and I have in common is a fondness for all things tea, tearoom and cake-related, so I jumped at the chance to visit the Hawkhurst Vault boys. Theo and James: - tucked just a hop, skip and a jump from the Truman Brewery and spiralling queues leading in to the Beigel Bake of Brick Lane.

A former hairdressing salon. Theo explained that it was "all hands on deck" to transform the space in to the amazing treasure that it has become. Family and friends helped to make this beautiful tearoom and lounge the eelectic mix of blue and white china, art nouveau mirrors, books, vinyl and chesterfield-style sofas.

Upon entering the 'Vault, a warm welcome was given by the boys who hook you in to 'tea talk' straight away! Theo took us on a tour of the space; the downstairs is very much a relaxed lounge feel, while upstairs is light and airy. The lounge area downstairs appealed to me and once I'd been given a fun and informative look and smell of the amazing aromas of the loose leaf teas on offer (from peppermint to dragon well green tea); I opted for a raspberry and hibiscus tea and a slice of carrot and pecan cake.

While James catered to the customers upstairs. Theo brought my order down to the lounge, along with a teeny 3 minute timer to ensure that I'd give my tea the minimum brewing time. As Theo sat across from me it was quite easy to forget that we had just met. The atmosphere of the lounge triggered a feeling of comfort, friendliness and calm. 




On Saturday I ventured down to the Brick Lane area for nothing other than a spot of tea and cake at brand new tearoom *The Hawkhurst Vault*, which had just opened its doors for the first time the previous day. Earlier that week I had an email drop into my inbox telling me all about the new tearoom from the people behind it, aka Theodore and James, who left their previous jobs as a landlord and accountant to set up their dream. I loved their vision and so headed down to check it out!

The Hawkhurst Vault name comes from an 18th century tea smuggling gang and so the guys have recreated that inside with a whole host of old furniture, you sort of feel like you're in your granny's living room. Upstairs is nice and bright with tables and chairs and a chalkboard menu and downstairs is the vault with quirky teapots, a Moet & Chandon mirror which actually came from the guys mum's home who was throwing it out and various books and antique lamps to create a really nice lounging atmosphere perfect to drink tea in!

• The Hawkurst Vault is a wonderful tea room at the Shoreditch end of Brick lane. We came across it by dint of the fact our youngest was going to a sale at the nearby jewellery store. We needed to find somewhere to have a drink and rest from our long journey. This very inviting façade greeted us, and we went inside. The list of teas and infusions was impressive, as was the knowledge of our hosts. My fiancé wanted a strong tea and was presented with a Lapsang Souchong and a Phuer tea to smell from which she chose the latter. Our eldest daughter wanted something milder and sweeter and was recommended a yellow oolong. For my grandson a blackcurrant and hibiscus infusion was selected and I had the dragon well tea. A chocolate croissant, butter croissant and a slice of courgette cake completed the order.

The teas were beautifully served in teapots along with a bottle of water between us. Each teapot was at the correct temperature for the specific tea and an egg timer indicating the ideal steeping time was also provided. The owner, Theodore, recommended that my fiancé keep the Phuer steeping just a little longer, and he was right. The courgette cake was absolutely amazing and the other pastries flaky and delicious. The service was so friendly, enthusiastic and expert from the staff, it made for a very pleasant treat. The staff play old vinyl records from Manfred Mann to the Rolling Stones, by way of Hawkwind and Jimi Hendrix which just adds to the atmosphere. And the delightful china teacups and original tea spoons add to the magic. Downstairs is a room with amazing ambiance, decorated with old early 20th century furniture and reminiscent of days not long past with sofas, tables and chairs. An ideal place to spend chatting with friends over a civilised cup of tea.

Make no mistake, this is tea done well and is a little more expensive than you would usually expect but this is very good value.

This is a new venture and with the enthusiasm, skill, attentiveness and friendliness of the staff, it deserves to do well. I will return

The Hawkhurst Vault is a speciality Tearoom selling 17 varieties of loose-leaf tea from Assam Breakfast to the rarest of yellow teas. Also serving locally sourced coffee, cakes and pastries to give a taste of the East-end it operates in a charming saloon bar setting. The Vault also specialises in

vinyl music with a very large and eclectic selection celebrating all things musical. Operating a bring-your-own vinyl and a book swap comprising over 300 books it aims for a personal and living room-esque atmosphere to be enjoyed by all ages.

History

Established in 2014.

The Hawkhurst Vault was set up early this year by two friends, Theodore and James. Set up through a love of all things tea and music it was converted from a hair saloon to a speciality tearoom over the course of 6 very stressful weeks. 

East End Explorations: The Discovery of The Hawkhurst Vault A Review by Laura C. Nicholson

Tucked away down a quiet side-street that is nestled within the rest of Brick Lane's bustle, lies The Hawkhurst Vault; a quaint and cosy independent café, specializing in a vast collection of fine teas sourced from across the world. The building itself has a rather sordid history: rumour has it that it previously functioned as a brothel, playing host to a fair share of 'less-than-salubrious' clients. Thankfully the vault now stands testament to the restoration of the local area: what was previously a neighbourhood black-spot now has the potential to become a focal point of the East end community.

Stepping through the shop's mahogany threshold, I am quickly greeted by the cheerful smiles of two affable young men, each sporting meticulously trimmed moustaches (one with an impressively lengthy beard) and jaunty suspenders to complete their look. "What can I get you?" the bearded man (who I soon learn is Theo; co-owner of the café) eagerly asks. I stop for a few moments to examine the endless wonders the menu has to offer: countless loose leaf teas, each with their own signature scent and taste; soft hints of syrupy sweetness, refreshing mint brews and the connoisseur's take on the bog-standard favourites, Earl-greys, Greens and English Breakfasts. When my mind is finally made up, I settle on an Oolong: a soft and subtle traditional Chinese tea that incidentally compliments the sugary pleasantries of the tasty almond croissant I picked out almost immediately. Sat comfortably and snug in my seat, I begin to peruse the front page of the newspaper as I sip slowly on my warm and soothing beverage, from the intricately decorated, china cup. Taking in the rest of the vault's surroundings, I spot a pile of vinyl records stacked next to the till: The Beatles, The Stones and an ancient Top of the Pops are but a few that Theo, keen to satisfy my curiosity, delights in showing me. I enquire as to whether the owners could slide on some Hendrix to earn them a bit of extra praise in their review; before I know it the mellow tones of The Wind Cries Mary wash over me, while I sink serenely into my chair.

I cannot recommend an experience at *The Hawkhurst Vault* enough. The café offers a cool and calming environment for anyone wishing to escape the ubiquity of corporate chains. Perhaps even more exciting is the communal network that the tea room is developing with other independent businesses in the local area, hosting frequent afternoon music events and pop-up shops. What is especially endearing is the creative passion of the two young owners, Theodore and James, who quit their jobs in order to pursue the unique vision of this unassuming cafe. Alive and kicking with 'good vibes, funk and soul', *The Hawkhurst Vault* is open to anyone looking for a good, refreshing brew. So, what are you waiting for?





As the children grew up and moved on the area began to change and is now quite different with lots of properties owned by property developers and because of the transient tenants the sense of community has suffered.

Whenever a new business opens in the area it invariably has an influence on the people that live near it so when rumours of a 'nightclub' opening on the site previously occupied by a hairdressing salon started to circulate many local residents became worried. There is an ongoing problem on the grass area between Brick Lane/Rhoda Street/Swanfield Street involving alcohol/drugs so the worry was that a nightclub opening would exacerbate the problem and I understand a local resident began collecting signatures on a petition to prevent the opening of the venue and/or obtaining a drinking license.

I have been told that the venue - The Hawkhurst Vault - would be applying for a 24 hour drinking license and would create further problems e.g. crowds drinking on the pavement from early morning and throughout the day then moving onto the grass area adding to the problem of noise, mess and antisocial behaviour.

I have not added my signature to the petition preferring to visit the venue and see for myself what it offers. Imagine my surprise to find a wonderful tea room run by Theo & James! They immediately made myself and my daughter feel welcome, came and chatted to us and we very quickly realised that the information we had been given about the venue was completely erroneous and that the tea room was actually a wonderful asset to the neighbourhood.

I've been asked to write a reference for the Hawkhurst Vault on Brick Lane by Theo Holder the Co-owner. I'm in a band called Matt Pound & Lieutenant Leek and Theo asked us to play at his event on the 8th June 2014.

The band is often reduced to a duo to play smaller venues like the Hawkhurst Vault; we have been doing this for about 4 years and are happy to just plug in and play in order – usually – to sell a few CDs after the show. This is often a good way of promoting the music to those who want to listen and the venue tend to be grateful for a bit of background music at the weekends.

However, nothing could have prepared us for what was in store last Sunday. We arrived a little late, set up, and before we'd even started playing people were pouring into the room. The audience were unbelievably quiet and respectful of our playing; listening to each song in almost absolute silence (whereas normally there are at least a few chattering away in the corner). The atmosphere/vibe in the room was fantastic and you could really tell that people had come to the event to hear something a bit different and were actually interested in the entertainment.

My only criticism might be that they seemed to run out of beer fairly early. Nevertheless, I would be incredibly excited if this were to become a regular event and will be volunteering my own band to play at it on every available occasion.





Dear MrLisowski,

Thank you for forwarding Ms Jane Miller's e-mail and photographs last week.

We acknowledge that Ms Miller and some other local residents have some concerns about the impact of the Tearoom on the community, but we do not accept many of their assertions and assumptions.

We have heard significant verbal feedback from other residents that Ms Miller has consistently misrepresented our intentions, with exaggerated, fanciful and unfounded scaremongering. For example, claims of a growth in "glass phials, condoms, etc" as a consequence of the tearoom are frankly nonsense. The clientele we attract are patently not "street low-life" and we cannot imagine any of our customers indulging in the practices she suggests. It does feel like a "hate" campaign, without any foundation except she appears to have taken a personal dislike to Theodore.

To respond to Ms Miller's e-mail point by point:

- 1. On the night in question we had a late TENS for the event until 10pm and as per her email the premises was empty before 10pm.
- 2. The 13th of June was an unamplified jazz event whereby the music was finished by 10pm. It was marketed as Tea and Jazz and no alcohol was provided. This is in line with the Music Act 2012 whereby unamplified music is allowed 'in all venues between 8am and 11pm'.
- 3. Ms Miller seems to be objecting to Theodore doing his job on a number of occasions. Upon noticing a man with glass, Theodore retreived the glass and made the gentlemen re-enter the Vault. Then, as is his responsibility, Theodore checked the adjacent green and the area outside the front of the tearoom. Theodore was made aware of Ms Miller across the road by customers who mentioned that a lady was taking pictures of them opposite. It seems not only bizarre but also affects business when customers feel threatened by this unauthorised photographing of them.
- 4. The event on the May Bank Holiday only occurred on the Saturday with a 2 hour long set from acoustic local musician Blair and a relaxed art sale from a local artist. Attached is a video of Blair playing his gig downstairs. Once again the Vault was closed before 11pm. We did not and have not had any direct complaints from either event.
- 5. The pictures attached.
 - 1. We sold tea, beer and wine as per a late TEN. We let the residents know of events as an invitation and also out of courtesy.
 - 2,3,4 & 6,7,8 Ms Millers pictures show a nice event with no evident street drinking causing problems and in actual fact shows friendly people and a friendly community atmosphere. There were no complaints from residents, many of whom attended the event

We cannot accept the implication that there was such a problem with the event from the pictures, which show people happily passing by,

poppingtheir head in to the tearoom, and no one feeling threatened. This is well illustrated by Ms Miller's pictures.

- 9. A picture of Theodore checking off-site drinking on the Green opposite. This shows awareness of potential problems that may arise and a conscious effort to fix them, as per his job.
- 5. A picture of alcohol and a few people on the Green also seems farfetched and unrelated. The man with the wine glass was moved on and the area was checked for bottles. Theodore found no other debris from The Hawkhurst Vault on the Green.

The problem of people drinking from cans on the park has nothing to do with an event at The Hawkhurst Vault. This behaviour pre-datedthe opening of the tearoom, and any potential risk of problems emanating from our establishment is regulated and will continue to be regulated by Theodore and James.

Actually, we would like to use Ms Miller's photographs on our website to promote our business.

We are happy for you to share this e-mail with Ms Miller, and will willingly engage in direct dialogue with her. Please note however that previously when Ms Miller has engaged with Theodore, she has audio-recorded their conversations, without asking Theodore's permission. In future if Ms Miller insists on recording our conversations, we shall require her to share the unedited recordings with us, as we are sure that they will show us to be consistently polite, open and reasonable. We do not believe they would show Ms Miller to be similarly polite, open and reasonable.

We do understand that Ms Miller will want to present her photographs and assertions at next week's hearing. We will want to respond to her, and refer to this e-mail correspondence.

Please note, by end of business tomorrow we shall have completed our dossier of evidence to support our licence application, which we shall e-mail to you and request that you share with the council attendees at the licence hearing next week.

We look forward to hearing from you.
