REASONS FOR URGENCY

This report was not circulated with the Committee agenda and was unavailable for inspection within the timescales set out in the Authority's constitution because work to assess the various options is ongoing and it was not possible to collate the necessary information prior to agenda despatch. The report is nevertheless recommended for consideration at this meeting in order to ensure that the committee is updated on the polling district and polling place review and that there is no delay in the consideration of the proposals.

1. SUMMARY

- 1.1 The Electoral Registration and Administration Act 2013 introduced a change to the timing of compulsory reviews of UK Parliamentary polling districts and polling places. A compulsory review must be completed by 31 January 2015.
- 1.2 This report sets out the initial representations received on the review of polling districts and polling places and the steps which must be taken to complete this process.

2. RECOMMENDATIONS

- 2.1 That the Committee note the report and comment on the review of polling districts and polling places and the initial representations received.
- 2.2 That in relation to the completion of the review, either:-
 - (a) The Committee delegate to the Returning Officer/Electoral Registration Officer authority to agree the final arrangements following consultation with the Chair of the Committee; or
 - (b) The Committee agree to hold an extraordinary meeting during January 2015 in order to agree the final arrangements following completion of the consultation.

3. BACKGROUND

- 3.1 The Electoral Registration and Administration Act 2013 (the '2013 Act') introduced a change to the timing of compulsory reviews of UK Parliamentary polling districts and polling places. The next compulsory review must be started and completed between 1 October 2013 and 31 January 2015 (inclusive).
- 3.2 Subsequent compulsory reviews must be started and completed within the period of 16 months that starts on 1 October of every fifth year after 1 October 2013.
- 3.3 Although the Council reviewed all polling districts and polling places in 2012/13, following the review of Council size and warding arrangements undertaken by the Local Government Boundary Commission boundaries effective for the elections held on 22 May 2014, there is now a requirement to conduct a review again to ensure compliance with the 2013 Act.

Definitions

3.4 In accordance with the relevant legislation, Polling districts, polling places and polling stations are defined as follows:-

Polling District - the area created by the division of a constituency, ward or division into smaller parts, within which a polling place can be determined which is convenient to electors.

Polling Place - the building(s) or area(s) within each polling district in which polling stations will be selected by the Returning Officer.

Polling Station - the actual room or building chosen by the Returning Officer, within the polling place, where the process of voting takes place at an election.

Roles and Responsibilities

- 3.5 The Electoral Registration Officer:- Where a local authority makes any alterations to the polling districts within its area, the ERO must amend the register of electors accordingly either on a notice of alteration or by publishing a revised register. The changes to the register take effect on the date that the ERO publishes a separate notice stating that the alterations have been made, which should be done to coincide with the publication of a notice of alteration/publication of a revised register.
- 3.6 The (Acting) Returning Officer:- The (Acting) Returning Officer must comment during any review of UK Parliamentary polling districts and polling places on both existing polling stations and the polling stations that would likely be used if any new proposal for polling places were accepted. The election rules require the (Acting) Returning Officer to decide how many polling stations are

required for each polling place and they must allocate electors to the polling stations in such manner as they think most convenient.

The process for the review

- 3.7 The Electoral Commission has issued guidance on the practical procedures involved in conducting a review of polling districts and polling places, including measures to ensure compliance with the provisions of the Disability Discrimination Act. In determining polling places, an authority must:
 - (a) seek to ensure that all the electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances; and
 - (b) seek to ensure that so far as is reasonable and practicable, the polling places they are responsible for are accessible to all electors, including those who are disabled, and when considering the designation of a polling place, must have regard to the accessibility needs of disabled persons
- 3.8 The length of the review process is not prescribed, provided all the steps required by the legislation can be undertaken within it. However, the time allowed for consultation should be sufficient to enable interested persons and groups to read and understand the proposals, gather comments and respond with any alternative arrangements that they may wish to submit.

Statutory requirements

- 3.9 Schedule A1 to the Representation of the People Act 1983 sets out the steps that authorities must follow in undertaking any review of polling districts and/or polling places. The authority must:-
 - Publish notice of the holding of the review
 - Consult the Returning Officer for every parliamentary election held in a
 constituency that is wholly or partly within its area. The Returning
 Officer must make representations which must include information as
 to the location of polling stations (both existing and proposed) within
 polling places (both existing and proposed).
 - Within thirty calendar days of their receipt, the relevant authority is required to publish the Returning Officer's representations
 - Actively seek representations from such persons as it thinks have particular expertise in relation to: access to premises; or facilities for persons who have different forms of disability
- 3.10 On completion of a review, the authority is required to give reasons for its decisions in respect of the designation of both polling districts and polling places. In addition, the authority must publish:
 - all correspondence sent to a Returning Officer in connection with the review;

- all correspondence sent to any person whom the authority thinks has particular expertise in relation to access to premises or facilities for persons who have different forms of disability;
- all representations made by any person in connection with the review;
- the minutes of any meetings held by the authority where details of the review have been considered;
- details of the actual designations of polling districts and polling places agreed as a result of the review; and
- details of where the results of the review have been published.

4. REVIEW OF POLLING DISTRICTS AND POLLING PLACES 2014 - UPDATE

- 4.1 In view of the very recent (2012/13) review that was carried out following the ward boundary changes, it is expected that the 2014 review of polling districts and polling places will be a fairly light-touch exercise. However, it does provide the opportunity to respond to feedback from stakeholders on the arrangements in place for polling stations at the combined elections in May 2014. The list of the polling stations used in May 2014 is attached at Appendix A.
- 4.2 On 12th September 2014 the Returning Officer wrote to the Mayor, Group Leaders and all Councillors to advise them of the review and invite their initial comments to inform his draft proposals which will then be published for public consultation. Persons or bodies making representations should, if possible, give alternative places that may be used as polling places.

Criteria

- 4.3 The Electoral Commission guidance states that the following should be considered as part of the assessment of the suitability of polling district boundaries:
- Are the boundaries well-defined? For example, do they follow the natural boundaries of the area? If not, is it clear which properties belong in the polling district?
- Are there suitable transport links within the polling district, and how do they
 relate to the areas of the polling district that are most highly populated? Are
 there any obstacles to voters crossing the current polling district and reaching
 the polling place e.g., steep hills, major roads, railway lines, rivers?
- 4.4 In relation to polling places, the Commission advises that there are a number of factors that will need to be considered when reviewing existing polling places or when assessing new polling places, including:
- Location: Is it reasonably accessible within the polling district? Does it avoid barriers for the voter such as steep hills, major roads, rivers, etc.? Are there any convenient transport links?

- Size: Can it accommodate more than one polling station if required? If multiple
 polling stations are required, is the polling place capable of accommodating all
 voters going into and out of the polling stations, even where there is a high
 turnout?
- Availability: Is the building readily available in the event of any unscheduled elections? Is there any possibility that the building may be demolished as part of a new development?
- Accessibility: Is the building accessible to all those entitled to attend the polling place?

5. INITIAL REPRESENTATIONS RECEIVED

5.1 The Returning Officer has received a number of representations in response to his invitation of 12th September. These are set out below along with the Returning Officer's initial comments:-

(a) - Representations regarding Polling Districts

Blackwall and Cubitt Town – BC1 & BC2 – to move all of New Providence Wharf and Ontario Tower into BC2

The RO welcomes this suggestion

Canary Wharf – to consider amending the ward name to 'Millwall' to reflect its geographical location – the river wall on which the mills stood forming the western boundary, Millwall Inner Dock forming the eastern boundary and Millwall Outer Dock forming the southern boundary.

This proposal can be pursued separately from the review of polling districts and polling stations. There is provision in law for the Council to change the name of a ward but depending on the timing of such a decision, due to the proximity to the 2013 boundary review the agreement of the Local Government Boundary Commission for England may be required. The Canary Wharf Group has previously also made representations on this matter.

Canary Wharf – CW1 & CW2 – to amend the west of Westferry Road to include the whole of Millennium Harbour development within CW1, making the boundary running to the south of Edison and Vanguard Buildings

The RO welcomes this suggestion

Canary Wharf - CW2 and CW3

Representations have been received to amend the boundary between the two polling districts above but details have not so far been provided. Officers to seek further information.

St Katharine's and Wapping – SK1 and SK2 – split the boundary straight down Garnet Street.

The RO will consider this suggestion, but is concerned that residents from Wine Close would have a longer journey to cast their vote at St Paul's Institute as geographically their journey would be closer to St Peter's London Docks.

St Peter's – to move the boundary between SP2 and SP3 so that it continues along Old Bethnal Green Road rather than through the middle of the Mansford Estate.

The RO welcomes these suggestions – it would be possible for SP2 residents to use St Peter's Bethnal Green Church (subject to visit on 11 December) and SP3 residents to use Lawdale Primary School.

Whitechapel – to consider splitting WH3 into two polling districts, using Backchuch Lane as the new boundary between polling districts.

The RO considers that it may be more appropriate to split the boundary through Gowers Walk, not Backchurch Lane as the residents in Backchurch Lane are very close to Harry Gosling Primary School. Residents in the split (WH4) could vote at English Martyrs Catholic Primary School (pending visit on 11 December).

5.2 If implemented, the amendments above would result in the following changes to the composition of the polling districts:-

(b) - Representations received regarding Polling Places

5.3 The Returning Officer has also received a number of representations about specific polling places within the above polling districts. A detailed breakdown of these comments and the potential polling places identified under this review is shown in the table below:-

- 5.4 The Council continues to make every effort to find suitable alternative polling places for those polling places where there is uncertainty about their availability for future elections and enhance the convenience, suitability and practical electoral arrangements for electors.
- 5.5 In 2013, all the premises to be used as polling stations were visited with a particular emphasis on access and the requirements of the Disability Discrimination Act 1995 as amended on 1st October 2004.

6. NEXT STEPS

- 6.1 Following the General Purposes Committee meeting and subject to any comments made by Members, officers will complete their visits to the areas identified in order to assess the options available and the Returning Officer will then publish his proposals for consultation.
- 6.2 The statutory steps for the review as outlined above will be followed and any

- representations considered prior to finalisation of the recommendations by the end of January 2015 as required by law, with a view to implementation in time for the UK Parliamentary election to be held on 7 May 2015.
- 6.3 The General Purposes Committee is asked to consider the process which it wishes to put in place to sign off the final outcome of the review. This could either be a delegation to the Electoral Registration Officer/Returning Officer to agree the final recommendations following consultation with the Chair of the Committee, or an extraordinary meeting of the Committee to be held towards the end of January 2015.

7. CONCURRENT REPORT OF THE CHIEF LEGAL OFFICER

- 7.1 In carrying out a review of polling places, the Electoral Administration Act 2006 (as amended) requires that each polling district must have sufficient and suitable designated polling places that provide 'such reasonable facilities for voting that are practicable in the circumstances' including accessibility for electors with disabilities. The Council is under a duty to promote equality for those with a disability and the recommendations of the review will be drafted with this duty in mind.
- 7.2 Other legal comments are incorporated into the body of this report.

8. COMMENTS OF THE CHIEF FINANCIAL OFFICER

- 8.1 The report describes a review of polling districts and polling places in Tower Hamlets ahead of the 2014 elections. Any financial implications arising from changes to the polling districts or polling places are expected to be fully contained within existing budgets.
- 8.2 The forthcoming scheduled parliamentary elections in May 2015 are funded by the Government and there are no immediate financial implications for the Council.

9. IMPLICATIONS FOR ONE TOWER HAMLETS

- 9.1 The aim of the electoral review is to secure appropriate and as far as possible equal representation for electors across all wards of the borough.
- 9.2 Disability issues have been taken fully into account in election matters particularly in the polling station review. All recommended polling places are as far as practicable located centrally within the polling district and are accessible for people with disabilities.

10. SUSTAINABLE ACTION FOR A GREENER ENVIRONMENT

10.1 Within the constraints of the suitability and availability of the accommodation,

polling places are located so as to minimise the distance electors need to travel to cast their vote.

11. ANTI POVERTY IMPLICATIONS

11.1 There are no anti-poverty implications arising directly from this report.

12. RISK MANAGEMENT IMPLICATIONS

12.1 The polling place review exercise is concerned with managing risk at all premises used as polling places

13. IMPLICATIONS FOR CRIME AND DISORDER REDUCTION

13.1 There are no crime and disorder reduction implications arising directly from this report.
