Re: Application for Temporary Event Notice for Towpath by Canal Gate

Victoria Park for the 6th and 7th June 12:00 to 23:00 both days

I write with reference to the above application which was received by Tower Hamlets Police Licensing

Please accept this letter as notification that the police as a responsible authority wish to object to this application on the following licensing objective

The prevention of crime and disorder, and public nuisance

This application is for a floating licensed premises during one of the busiest weekends in Tower Hamlets, that is Field Day weekend. At this event there will be up to 30,000 people, many of whom will be looking to consume or "Load up" on alcohol prior to attending the event. Having a licensed premises selling alcohol so close to the event will run the risk of allowing people to engage in binge drinking. This will lead to alcohol related crime and disorder as people become intoxicated.

The Towpath itself can get incredible busy during the weekend and is very narrow, there is a real risk of people falling in the water or being injured as they try to either get past the

queue for the boat, or trying to queue to get served. Having regulated entertainment at this boat will only exacerbate the risk.

Tower hamlets Police therefore ask for this application to be rejected.
