Mayor's Report to Council 20/1/2016

Report of John Biggs, Mayor of Tower Hamlets, to Council

This is my fourth written report to Council. This has again been a busy period, with meetings and activities concerning all areas of the Council's work, but this time with a particular focus on the budget.

I have now attended the O&S committee four times, and they keep inviting me. I am holding my first 'Mayor's Assembly' in the community, at Whitechapel, on 21st January. I have, of course, attended many meetings in the community already, to listen and be accountable, but a Mayor's Assembly is the first attempt to do this in a more organised open access format. The meeting is an innovation and I will review how it works. I want also to offer members the opportunity of Ward based meetings, chaired by themselves, where I can meet their constituents.

Key Events

Budget The Council is about to consider my first budget and will properly debate it under the processes set out in statute. I will only raise at this point that the budget-making has highlighted a failure of strategic planning under the previous regime, where too often savings were made without thinking about the future shape of the authority. This is necessary. After the budget is agreed, in whatever form, a further and continuing programme of work will be needed throughout 2016. This will require a detailed look at the structure and organisation of the Council, in order to ensure that several years of 'salami-slicing' are examined and the structure is fit for purpose. Rebuilding a solid budget foundation, with clear priorities and possibly some tough decisions is a part of moving on from past controversy and lack of focus.

Chief Executive, and further appointments Will Tuckley has been in post for about three months. I am pleased we are tackling major issues facing the Council and, while always impatient, I am looking forward to more detailed proposals to take us beyond the 'Best Value' regime agreed with our Commissioners and towards a more corporate and focused authority. I am sure that with this we can better meet local needs, and respond to budget pressures. We are currently recruiting Directors of Adults and Childrens Services, together with a number of Service Heads. Prolonged acting appointments are not wise, and so this will be another necessary step forwards.

Commissioners Progress is being made with our Directions. I recently agreed the final dates for East End Life. The initial Communications Review is complete but we now need to build the alternative communications strategy, which will happen in the next few months. Suggestions that the closure of East End Life will 'save' £1.5million are wide of the mark. This doesn't reflect

the net cost to the Council of producing East End Life and, as we move forward, the Council will still need to communicate and advertise, as it always has, albeit through new channels. It would be good to see a saving in the budget but it is too early to say if this will happen.

On the other remaining directions, Procurement and Asset Management are on course. The latter will require among other things a more systematic approach to community buildings, which have historically been rented under apparently ad hoc, inconsistent and poorly justified decisions. Thus, identical organisations providing community value in similar buildings might enjoy widely different rent and security of tenure.

The two more complex remaining Directions are Grants and Organisational Culture. I can report steady progress with these, and the publication of a draft Voluntary and Community Sector strategy is welcome and is part of the Grants process.

Street Cleansing and Waste There has been a reduction in complaints about the waste contracts and cleansing. I think this is in part due to the increased management focus on this matter. Additionally, some new money has been invested in the street cleansing service and more is proposed.

Meanwhile, we are beginning to consider the re-provision of the cleansing service, with the current contracts ending in 2019. Getting this right, while managing costs and improving outcomes, will be a challenge and will be brought forward for scrutiny and examination soon.

Youth Service: New interim management has been recruited for the Youth Service, with a parallel exercise to review and as necessary redesign the service. This will be reported and open to scrutiny in the coming months. As a part of this change, the Youth Service will soon be transferred (back) to Childrens Services, from where it was transferred to the CLC Directorate, together with a transfer 'in-house' of most provision, a few years ago. In my view this was not a change that succeeded.

Development Issues The pressure for development, including high density and high rise schemes continues. There are five matters I can report:

- i. Our Borough Our Plan: consultation has now started on a new Local Plan. At this stage the consultation is on the scope of questions we want to examine. A far longer consultation will happen when a draft plan is published, hopefully later in 2016. This is a very important piece of work and I want our community to have the opportunity for detailed consideration of and contribution to the proposals.
- ii. The application 'called in' by the Mayor of London at Blossom Street/Norton Folgate was determined by the Mayor the other day, with permission given, contrary to the views of many local residents.
- iii. Bishopsgate Goods Yard: The Mayor of London called this scheme in and is proposing to consider it in March. I remain very opposed to the proposed development and we are talking with Hackney about how best to make our case against it.

- iv. The Whitechapel Masterplan is proceeding but is being quickly reviewed, to see how comfortable we are with the overall proposals including densities and heights of buildings. We remain committed to the Masterplan and regeneration of the area but local interests must be protected.
- v. Isle of Dogs 'OAPF': A briefing was given to members about this 'opportunity area framework' proposed by City Hall. While there is potential for development at the Northern end of the Island, I remain anxious that the London Mayor is getting carried away with himself in proposing unsustainable development, including the possible regeneration of the Poplar High Street area. Any such proposal needs to be considered sensitively, slowly and with local people.
- vi. Community Planning Forums: At Cabinet I recently agreed the new local planning forum for Limehouse. Other proposals for the Isle of Dogs and for Spitalfields have been delayed while I consider a number of objections and concerns, and questions about their boundaries and status (the inclusion of business interests in the forum in particular). However, I remain committed to the proposals in principle.

Planning Contributions Transparency: As an important part of my transparency agenda I agreed that 'Section 106' and 'Community Infrastructure Levy' spending proposals will be considered openly and therefore will be subject to scrutiny. This will be through, effectively, a sub-committee of the Cabinet. This is a contrast to the past where such decisions were made, without serious opportunity for challenge, by a secretive Officers Panel and then 'rubber stamped'. The level of such contributions, together with the urgent need for infrastructure investment to run alongside our scale of development, means that openness is a long overdue development.

Housing There are a number of developments.

- i. The Affordability Commission: my commission has now met twice. It faces some challenging decisions but will, I hope, improve our ability to both meet local needs and campaign effectively for unmet needs, as unaffordability and lack of supply continues to hammer us and many local people.
- ii. One Housing Group. There have been a number of meetings with One Housing Group, myself, cabinet members, local Councillors and residents since my election. I have made it clear that the approach of OHG to date has not been acceptable and that residents must be consulted in a thoughtful and open manner about any development proposals. A 'residents' friend' is to be appointed. The Council, during this period, passed a resolution and I report below on outcomes.
- iii. Circle Group: I remain concerned about the performance of Circle. While their repairs service has markedly improved, their impending merger with Affinity Sutton is, I and others think, a further departure from the local accountability and responsiveness residents expected on both the HAT exit and stock transfer. A motion was passed by Council some months ago and an update is reported below

Report Back on Council Motions Below are responses on progress following two recent motions passed by the Council with recommendations to the Executive. Both concern Housing Association Matters:

Circle Old Ford

In January 2015 Full Council passed a motion regarding concerns relating to the alleged poor management and performance residents of Circle Old Ford were receiving.

A number of high level meetings have been held with Circle to try and resolve these issues. A public meeting was held where Circle's Chief Executive and other senior staff recognised that there had been serious problems with the quality of services residents had received and apologised to residents. It was also explained that a new repairs and maintenance contractor was now in place and performance should improve.

The motion also called on the Council to explore options for legal proceedings for breach of promises contained in the transfer agreement. The Council has not received any evidence or details of which promises were allegedly breached and as such cannot address this with Circle in the absence of this.

One Housing Group

Another Motion was received by Full Council in July 2015 regarding a number of issues relating to One Housing.

I wrote to One Housing's Chief Executive outlining the Council's concerns relating to allegations of serious detriment residents had experienced as a result of the failings of their repairs and maintenance service. Added to this residents perceive that One Housing Group has been dishonest with them over its plans to redevelop the Island Estates.

Following meetings with officers from OHG and the Chair of their Board I instructed Officers to suspend One Housing as a preferred partner for 6 months.

The Council's legal team are looking at the transfer agreement to determine whether One Housing Group would be breaching any conditions particularly relating to redevelopment of the estate.
