Background

Page 2

- Rising demand for services and reducing funding for Councils under 'austerity'
- LBTH currently charges for residential / nursing care and care provided in extra care housing
- 2016/17 Budget – Agreed to introduce charging for community care services
- LBTH one of only 2 Councils who do not charge for these services
- Mixed views in budget consultation

Scope

- 2,700 clients currently receiving community care services
- Around half this number are estimated as needing to pay a charge
- Estimated saving £1.080m pa
- Estimated saving 16/17 £270k

- Cabinet commitment to consult on the policy
- Specific consideration of providing greater protection for those on lower incomes
- 20/6/16 – 19/8/16
- Letter and leaflet to all affected service users
- Website and social media
- Targeted meetings with a wide range of groups and Stakeholders
- Overview & Scrutiny

Policy

- Care Act guidance provides some rules
- Individual financial assessments
- Some incomes and capital sources are excluded
- Minimum Income Guarantee (MIG)
- Some services cannot be charged for eg Reablement, equipment
- We provide welfare benefit advice to maximise take-up of benefits as part of the process

Common Fears & Misunderstandings

Page 6

- That everyone will be charged – many people will be assessed as zero charge especially those on low incomes
- That an individual / family home is at risk – the value of someone's home is not taken into account in assessment charges for community services

- The overall balance between needing to raise income for a sustainable adult social care service and the aim to protect people on lower income.
