By way of introduction I act on behalf of Chao Zhang and I am emailing further to your recent representation to his application for a premises licence at the Site.

By way of clarification, the location of the Site in the Cumulative Impact Zone of Brick Lane does not mean that a new licence will not be granted unless a 'need' is demonstrated but instead that the applicant needs to demonstrate that cumulative impact will not be added to. My client believes that he has already done this with the conditions proffered in the Operating Schedule but is prepared to take the further step of having the following additional condition placed on any licence granted:

'The supply of alcohol at the premises shall only be to a person for consumption by such a person as ancillary to their meal.'

Furthermore, the terminal hours applied for in respect of the on sale of alcohol and being open to the public is well before the hours you cite being 11 p.m. throughout the week and my client is prepared to reduce the hours sought for off-sales to 10 p.m.
