1 The restaurant only uses background music so that there is no need for the regulate entertainment sought

2 To address the issue of cumulative impact we propose to limit the licence on 118 Brick Lane to 0000 and to substitute the extension on 120-122 to 0200. This gives up 88 places in return for an additional 72

3 We propose that all employees shall sign the restaurant's customer service policy , which we will send separately, to deal with other matters of concern
