Mayor's Report to Council

Key Events/Announcements

Budget: our proposals have now been formally proposed by Cabinet and were examined by the Scrutiny Committee last week. The Cabinet will consider the comments of O&S on the 30th of January, and proposals will be taken to the budget council meeting on 20th February. We need to be realistic about the challenge we face. In Tower Hamlets the council's core funding is set to be £148m less this year compared with 2010 – equivalent to a 64% cut – and the council expects to have to save a further £44m over the coming three years.

Despite this, we have a positive set of budget proposals with significant investment in what residents have told us are their top priorities: housing, education, young people, waste collection and tackling ASB.

Ofsted: findings from the latest Ofsted monitoring visit have now been published and the headline finding is that 'effective action taken by leaders and managers following the August monitoring visit has led to considerable improvements in the quality of social work practice for children in care.' This is very encouraging and testament to the work and dedication of our staff, but there is a great deal more to do. There will be a further monitoring visit in March, followed by a full re-inspection.

By-elections: as members will be well aware, we are now only a few weeks away from by-elections in Lansbury and Shadwell wards following the resignation of two councillors there.

Brexit: We are of course also anticipating Brexit and are one of the very few local authorities to have gathered public evidence and studied its possible impact.

Like everyone else we are still in the dark about what will happen, but our Brexit Commission report will be launched next month, led by Cllr Amina Ali.

As the political wrangling continues in Westminster we are looking at the practical steps we can take, and to offer reassurance to the 41,000 EU citizens who live here. We value their contribution and this is their home too.

I continue by the way to believe a second referendum is now needed to break the deadlock. Indeed now more vitally than ever. A narrow referendum result, either way, is not a mandate for the reckless pursuit of narrow interests.

Council Tax Reduction Scheme (CTRS): this is on the agenda for discussion this evening. At a recent cabinet meeting we decided not to proceed with the recommendation to use the same child allowances in the Local Council Tax Reduction scheme assessments as those used for Universal Credit, I am in particular referring to the 'two-child limit'.

In 2013 the Government made significant cuts to the Council Tax Reduction Scheme and localised its implementation. Since then the slow introduction of

Universal Credit has meant that much of the information which councils rely upon to administer CTRS is no longer available. That has made supporting our lowest income residents much harder and sits behind many of the changes we have had to make to the CTRS in recent years.

To further complicate matters, the Government introduced a limit of two children on benefit calculations. This means if a family has more than two children the Government will continue to assume they only have two when calculating their entitlements. The Government's systems make any deviation from their assessment criteria very difficult to implement as they no longer provide councils with the data we need.

The Government has recently partially backtracked on the two-child limit and agreed that it would not apply to those who had children before the system was introduced. I have called for the limit to be scrapped entirely.

We still operate one of the most generous schemes in the country and unlike many councils we offer 100% discount meaning our poorest residents don't have to pay. In total we expect to spend £25m on our Council Tax Reduction Scheme and in total over 27,000 families receive some form of discount as a result of the CTRS. Over 19,000 families received a 100% reduction over the last year and haven't had to pay a single penny of council tax.

Operation Continuum: we recently marked the first anniversary of Operation Continuum. As of December, Operation Continuum has resulted in 100 warrants executed/properties raided, 191 total arrests for drug offences and drug supply, 88 people charges, 31 men sentenced to a combined total of more than 100 years' imprisonment, large quantities of Class A drugs seized, £167k in cash seized under the Proceeds of Crime Act, 164 drugs stop and searches conducted, 399 ASB warnings issued, 25 weapons sweeps conducted, 33 weapons recovered from weapon sweeps and 93 people arrested, assessed and referred for drug treatment.

School funding: new analysis from the National Education Union (NEU), which has compared the Schools Block funding allocations for 2017/18 with 2018/19, has revealed that the Government has broken its promise that there would be "a cash increase for every school in every region" – with 31 schools in Tower Hamlets alone having seen their funding cut in 2018/19. This is deeply worrying, particularly as the National Funding Formula starts to bite.

Early Years Summit: we held a summit at the end of November to hear from parents, partners and professionals about our Early Years services and how we can make them even better. This was a positive event and feedback will be used to develop a new early years strategy and provide the support parents and families need.

New Homes Bonus (NHB): the Government has recently announced that Tower Hamlets has been provisionally allocated £19.2m NHB, the highest allocation in the country, as part of the New Homes Bonus allocations – the grant paid by central government to local councils to reflect housing growth and fund infrastructure.

Nearly £300,000 of this figure has been allocated as a result of the number of affordable homes built in Tower Hamlets, which was the second highest local authority area in terms of the number of affordable homes added, with 850 new homes.

I am also very grateful for the hard work of council staff which meant that no homeless families were accommodated in B&Bs over the Christmas period, who were instead placed in self-contained homes. Under the previous mayor many families were left in B&B accommodation for longer than the legal limit of six weeks.

Creative Enterprise Zone: I was very pleased to learn that our joint bid with Hackney Council has been successful, and the Mayor of London has named Hackney Wick and Fish Island as a Creative Enterprise Zone. This will help protect this outstanding creative quarter by ensuring that planning powers help develop a pipeline of affordable workspace in the area. Creative communities have brought a new lease of life to former industrial areas, but too often they end up being victims of their own success and are priced out of workspace and accommodation when developers move in.
