Mayor's Report to Council

20th March 2019

John Biggs, Mayor of Tower Hamlets

Key Events/Announcements

Christchurch: There are no words that can properly describe the horror of the terror attack in New Zealand. I send, as we all do, our deepest sympathies to those who have lost loved ones, and we stand in solidarity with the people of New Zealand, and with Muslims around the world. A number of vigils have taken place across the borough to show solidarity and we are in touch with mosque leaders to discuss what practical steps we can take as a council going forward. A statement of our solidarity will, I hope, be unanimously agreed by Council this evening and I believe reflects exchanges across the chamber.

I have also welcomed the announcement from the Home Office that the Places of Worship Protective Security Fund will receive additional funding to help protect places of worship. Last year, the council supported local faith groups to bid for funding from the scheme, which led to two mosques in the borough being awarded funding for enhanced security measures. As a council we will support places of worship to bid for funding following the announcement from the Home Office.

Brexit: The Prime Minister has, with less than two weeks until March 29th, conceded that the country is in crisis. Clearly we are keeping a very close eye on what happens, but this presents an enormous challenge particularly when it's clear that not even the Government knows what will happen.

The Brexit Commission, led by Cllr Amina Ali, recently published its final report and recommendations. This was an important piece of work and has shaped our approach. Belatedly the DHCLG has been convening meetings with local government to discuss the many areas where we might need to prepare for different outcomes, and we have been involved in those meetings.

Support for EU citizens: our campaign to provide reassurance for EU citizens living in Tower Hamlets, and council staff members, received some media coverage. I make no apology for standing up for those who call our borough home and who are worried about what the impact of Brexit will be on them. We have provided comprehensive advice and guidance on what steps people need to take to secure their right to continue living and working here after Brexit. We are also offering to support residents with their applications for settled or pre-settled status.

EU citizens contribute so much to our borough, and this is their home too.

LGC awards: Tower Hamlets Council was shortlisted for a number of these awards, and we are very proud that our Violence Against Women and Girls, Domestic Abuse and Hate Crime team won the 'team of the year' award. The council was also highly commended in the 'business transformation' category, for the hostels reconfiguration. Congratulations and thank you to the officers

involved. And by the way, we won Team of the Year last year too. These awards are tributes to our steady progress in the past few years following past controversies.

Serious Case Reviews: We do however need always to learn, and to improve. Two Serious Case Reviews (SCRs) were published last month by the Local Safeguarding Children Board (LSCB) and all members will have received a briefing on this.

Both of the SCRs have provided a set of recommendations for the LSCB, Tower Hamlets Council, the CCG and a number of other health trusts/groups. Many of the recommendations for the council have already been actioned over the last two years through the council's social care improvement work, but there is no complacency about the further work we need to do. OFSTED inspectors have indeed been coincidentally in the Town Hall for the past two days, as we continue our improvement journey. I am positive about the future, but never complacent.

£3.3m boost for Bow: a £3.3m boost for Bow, including the town centre on Roman Road, has been announced, after our successful bid for funding from the Mayor of London and Transport for London (TfL), under their Liveable Neighbourhoods programme. This will help us make further and deeper progress with our local, and ambitious, Liveable Streets programme, which will cover Bow, and in phases many other parts of the borough in the coming years. We have an ambitious programme to improve the street scene, to bring calmer traffic behaviour, provide a better environment for pedestrians and other vulnerable road users, to neighbourhoods across the borough. Bow is one of our earlier projects, and we are delighted TfL have recognised our commitment. There will be detailed consultation, and I want the community to be involved in the design where we can.

Cladding: I attended a meeting recently with residents of New Providence Wharf, a development in Blackwall and Cubitt Town Ward. I met subsequently with Ballymore Homes, the freeholders. We remain watchful of the problems of blocks in the borough with cladding systems that need replacement. Aside from the urgency, and reassurance, needed, there remains a very real problem of who will pay, particularly where leaseholders, management companies, and freeholders are involved. This remains a political issue on which Government is not acting decisively particularly as they have, understandably post-Grenfell, required removal but have left others to argue over the bills. We must assume that everybody acted diligently and in line with the law when the blocks were built. This issue will continue to be an anxiety for residents affected.

HMICFRS Inspection: Her Majesty's Inspectorate of Constabulary and Fire & Rescue Services (HMICFRS) has published a report following its inspection of the Metropolitan Police Service's review and reassessment of alleged criminal offences arising from the 2014 mayoral election in Tower Hamlets. I have copied my response below for information:

"This report makes clear that a lack of serious attention under the previous Mayor, Boris Johnson, in 2014 meant the police investigation into electoral fraud in Tower Hamlets was under-resourced and uncoordinated. As a result it potentially missed lines of enquiry and had to be reinvestigated years later.

“I’m pleased this review took place so lessons can be learnt for the future but sadly we may now never know what evidence was missed at the time which could have been crucial in prosecuting those responsible.

“Local people were rightly appalled at how Lutfur Rahman and his cronies stole an election. No stone should have been left unturned by the police in investigating how democracy was subverted. Sadly this was far from the case.

“As a borough we have moved on from this sorry moment in our history but as the report makes clear these failings have I fear let people off the hook.”

International Women’s Day: I was very pleased to celebrate International Women’s Day on the 8th, with the theme ‘Balance for Better’ – a number of videos were recorded to mark the day featuring cabinet members Cllr Asma Begum, Cllr Rachel Blake, Cllr Amina Ali and Cllr Denise Jones as well as senior officers. The council also has a range of events to mark Women’s History Month. Our borough has a rich history of inspirational woman from the suffragettes to the many women that I have the privilege of working with today in the Cabinet and Labour Group. On the day I awarded certificates to women who had completed construction training courses. I add that I did this because both my female Deputy Mayors were busy elsewhere!

Fair Funding Review: we have responded to the Government’s so-called Fair Funding Review which seeks to change the way local councils are funded. Recent analysis from the Local Government Chronicle has found that more than half a billion pounds is likely to be diverted from London boroughs, mainly to shire areas, as a result of the Government’s proposals. We will continue to press the case that we deserve truly fair funding and that this cannot be achieved by further cutting areas like Tower Hamlets.

Spitalfields Community Governance Review: a second public consultation is currently underway and will conclude in May. A number of roadshows have also been arranged as part of the consultation, and the Council will make its final decision in July.

Operation Continuum: we continue our clampdown on drug related crime in the borough. The police have carried out further dawn raids in connection with drug crimes, and the council are carrying out enforcement patrols and working with social landlords to seek the repossession of homes where raids find evidence of drug related crime. Operation Continuum, has taken 190 drug dealers off our streets in the last 12 months

Graffiti and Street Art Policy: the Cabinet has agreed a new Graffiti and Street Art Policy. There will be an increased focus on removing illegal or offensive graffiti while leaving street art in place. Our recent budget includes £450k investment in new teams to tackle graffiti in the borough, one of our manifesto commitments.

School Streets: 50 primary schools across Tower Hamlets will benefit from School Streets, an initiative to close roads to traffic or restrict the volume of cars passing by schools. £200k has been allocated for works to start on fifteen schools this year and next year. This is part of our ongoing efforts to help improve air quality around schools.

Licensing Scheme: We are extending our licensing scheme to further protect tenants and drive up standards in the private rented sector. The scheme,

effective from 1st April, builds on the scheme already in place, and will extend it to houses in multiple occupation. This will ensure properties are managed properly and offer a safe home for tenants.

‘Start-Up Ready’ programme: Since October 2016 we’ve invested over £650k in support for entrepreneurs to get start-ups running. More than 150 new businesses are up and running in the borough thanks to the programme.

Boishakhi Mela: The 2019 Boishakhi Mela has been confirmed for Sunday 30th June 2019, Weavers Fields.
