## Mayor's Report to Council

18<sup>th</sup> September 2019

John Biggs, Mayor of Tower Hamlets

### Key Events/Announcements

#### **Ofsted**

The Ofsted report has been published in the period since our last council meeting and while the result is widely known, this gives me another opportunity to congratulate and thank our excellent staff and partners who have worked so hard for the fantastic result.

Ofsted has rated our Children's Services department as 'good' just two years after it was given an 'inadequate' rating, something that Ofsted itself described as 'remarkable progress'.

When I was first elected we inherited major problems which required a great deal of time and investment to fix. This has been a major focus of ours over the last few years and the result is testament to the outstanding efforts of our staff and partners, including schools, NHS services, the police, voluntary sector organisations and many committed people across our community. Thanks to you all.

#### **Budget**

Whilst the current Chancellor may believe that 'austerity is over' – the reality is very different. The Chancellor's recent 'giveaway' did nothing to provide certainty for local authorities and with rapidly growing demands and pressures, budgets for local councils across the country are looking precarious.

As an administration we are well into preparations for the upcoming budget round, and as ever the next few years will require very careful management and some tough decisions.

#### **Brexit**

It is worth noting that we as a local authority continue to meet to discuss issues, but that our national parliament has shamefully been shut down during the height of a national crisis.

While this is a hugely uncertain time for all of us, we must not forget the uncertainty facing the 41,000 non-UK EU citizens living in Tower Hamlets. This is their home too.

I am lobbying the government to fully respect the rights of these citizens and I'm calling for their rights – including voting rights – to be enshrined in UK law. I hope all colleagues will echo these calls.

### **Local Community Fund**

The Local Community Fund (LCF) decision process – including a scrutiny call-in – has now concluded. This decision means £2.7 million annually for three and a half years to over 50 community groups. This is a major investment in many fantastic groups to deliver change and benefit the lives of many residents.

We have also committed to help organisations that made high quality albeit unsuccessful bids find alternative sources of funding. This includes setting up a 'funders forum' where community groups and potential funders can network and share ideas. We have also committed to an additional annual £180,000 funding pot for the next two years and agreed to look at what additional support can be given to our Somalian communities, as well as local groups that provide play, sports and recreational activities for older people, and ensuring advice services of quality are available across the borough. We are also planning to extend funding for the current lunch club programmes and community language projects for six months to allow for reviews of these areas to be completed.

### **Transport Strategy**

The council's consultation on its draft transport strategy has recently closed. The strategy aims to support residents and visitors use more sustainable methods of transport and we will be looking at feedback very closely.

### **Tower Hamlets Homes**

We have agreed to extend THH's contract by 4 years, with the option of extending it by a further 4 years beyond that. This decision follows a comprehensive review, resident engagement, an independent report and a scrutiny call-in. THH has made significant progress over recent years (including winning Landlord of the Year at the UK Housing Awards).

We do however recognise that THH still has areas to improve on and they will be working very hard to deliver this. Clearly a lengthy re-organisation process would have taken focus away from the areas where we need to see improvement.

### **Special Educational Needs and Disabilities**

We cannot understate the importance of this issue. We have been campaigning about funding for Special Educational Needs and Disabilities (SEND) services – and indeed warning about how these services are now at a 'tipping point'. Put simply, the government funding for these services has failed for a number of years now to keep up with rapidly increasing demand leading to very serious budget gaps.

The recent announcement from the government of £700m for pupils with SEND is of course welcome, but we have yet to receive concrete details about their plans. We remain concerned that the extra cash doesn't close the gap on high needs spending from last year, let alone what the gap is anticipated to be next year. The LGA estimates the gap to stand at £1.6bn by 2021.

Our administration motion is on this topic and I look forward to raising these issues in more depth. The implications of the funding gaps are potentially very serious for some of the most vulnerable children and young people in our borough.

### **City of London Police investigation**

The Police have informed us that their investigation into misconduct in public office related to the former Mayor has concluded. This followed on from Operation Lynemouth.

They have advised us that after consultation with the Crown Prosecution Service, they have decided that there is insufficient evidence to support criminal proceedings against any individual.

We should be clear that this is not a statement of innocence as the former Mayor has already been found guilty of serious election offences and was thrown out of office because of them. As the new Mayor I and my team have made a massive effort recovering the borough from the terrible mess he left behind. We have moved a long way forward since then and we must never go back.

### **London City Airport expansion consultation**

As a council we have responded to the more technical 'Our Skies' consultation. I am pleased that consultation period for the broader 'London City Airport Master Plan 2020-2035' has been extended until 18<sup>th</sup> October so resident views can be more fully considered.

### **New council homes**

As part of our work to meet our manifesto commitment to deliver 2,000 new council homes, the council has launched its new 'Build Here' tool, an online tool to enable residents to nominate sites where they think we could build new council homes:

### **Progress against climate commitments**

We have made solid progress towards becoming carbon neutral by 2025 and achieved an 18% reduction in the council's greenhouse gas emissions compared to last year and later this week we will join millions of others across the world calling for governments to take decisive action to tackle our Climate Emergency.

### **Exam results**

We saw some excellent exam results across the summer. Nearly three quarters of students gained A\*-C grade in their A levels and 98.9% of students entered for A Levels achieved at least 1 A\*-E grade. Similarly there were great GCSE results, where 85% of Tower Hamlets students achieved grades 9-4 in English, equivalent to the old A to C grades, (an improvement of

3% on 2018), while in maths 74% of students achieved grades 9-4, up four per cent on the comparable figure last year.

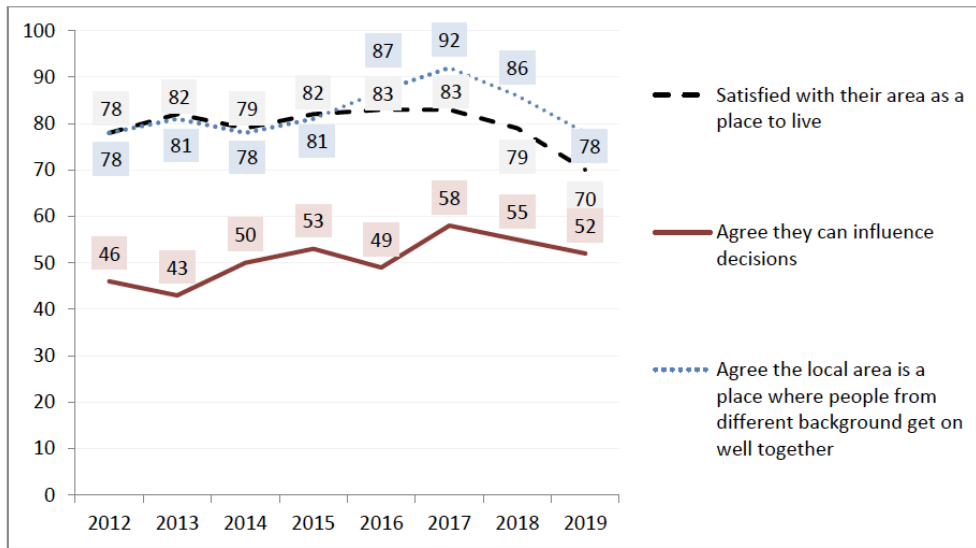

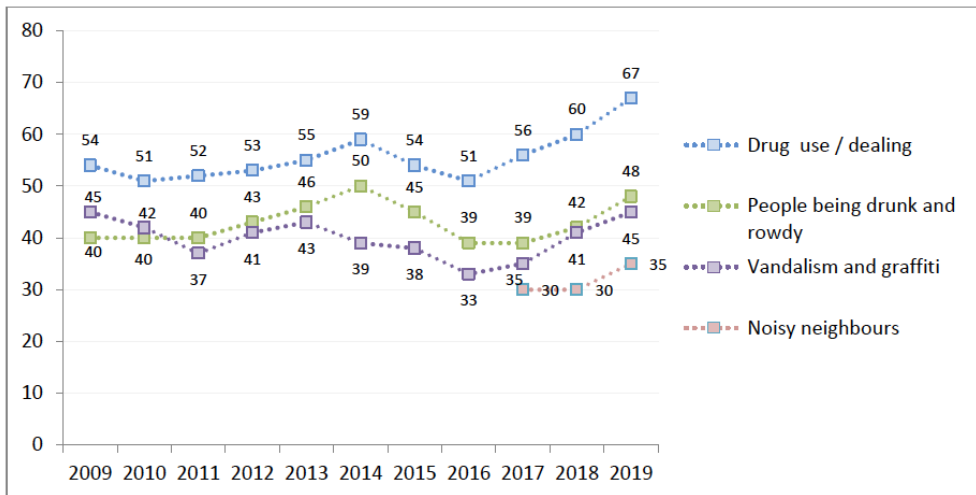

**This Council notes that Crime and ASB are major concerns for residents. Many elements of this are for other agencies and partners to address and it would be foolhardy for the Council to accept ownership of matters beyond our powers or control but we note the ongoing work by the Council and partners to address issues of community safety, including but not limited to:**

- £3 million investment of council funding for extra police officers to work on key crime and ASB hotspots;
- A Neighbourhood Management Pilot in the north east of the borough to bring extra focus and dedicated resource to four wards in the borough with high concentrations of ASB;
- Ongoing targeted activity with the police to tackle the drugs trade through 'Operation Continuum' which has seen 312 arrests for drug offences, 129 people charged with drug supply and £564k cash seized under proceeds of crime;

- A review of the Council's CCTV infrastructure as a prelude to major investment in the network;
- Refreshing the Substance Misuse Strategy to ensure it reflects the current/emerging challenges and sustaining £8 million investment on substance misuse support.

**The Council is concerned:**

~~About the year on year~~ That while some areas have seen an improvement in resident perceptions (for example in parks and road/pavement repairs), there has been a decline in resident's perception about a range of other issues and concerns (for example refuse collection but also other areas not a responsibility of the council including policing).

**The Council further notes:**

That the news release dated 3<sup>rd</sup> September 2019 titled "Residents survey results revealed" ~~does not mention any of the issues raised above and is not an accurate summary of the survey results~~ highlighted a number of key issues and provided a link to the survey report in full.

That the council is working towards meeting the commitments & promises made at full Council on the 19<sup>th</sup> September 2018 ~~as regards ASB have not been fully answered~~ including for example a new CCTV approach for the borough, completing a review of the online ASB reporting portal, 6,000 lamp columns have been upgraded to LED lanterns, among other measures.

**The Council resolves:**

To ~~reverse the year on year declines~~ address the concerns and build on improvements to address in the issues raised in the Annual Residents Survey, and to strive to deliver ~~rebuild trust in our ability to deliver~~ continuing improvements for our residents.

To continue to ensure that press releases accurately ~~summarise Councils documents and are not a Pravda like distortion of the truth~~ reflect the work of the council and inform the media and residents.

To ask the Cabinet Member for Community Safety to ~~respond urgently to all of the issues raised and commitments made 364 days ago.~~ provide a written update on ongoing actions following the agreement of the full council motion in September 2018.
