Overview and Update on progress and performance: October 2019- September 2020

ALE Performance in the context of the London RAA's up until Sept 2020



- Performance information has been collated from ASGLB which provides a service baseline and measure long term trends across London.
- Across London all RAA's have had a decreased in the numbers of children subject to an adoption plan except for ALE where adoption plan decision have increased year on year. ALE has the highest rate per 10,000 in London at 1.76. However this remain lower than the England average of 3.12.
- All London RAA's have seen significant decrease in placement order and placements except for ALE where placement numbers have remained stable and a small increase in placement orders.



Tower Hamlets' Child Performance



- A1 timeliness is currently 438 days between coming into care and being placed with an adoptive family. The England average is 449 days.
- The above is a decrease in performance from the previous two years. The main reason is due to the increased complexity in the cases, court delays and Covid.
- A2 timeliness is currently 138 days from placement order to match. The England average is 182 days.
- The above is a significant improvement in the previous two years. The main reason for this improvement has been the focus on early family finding activity prior to placement order being granted.

- The number of adopter approval declined in 2019/20 and this is largely due to the transition phase of setting up ALE.
- To date ALE have approved 15 new adoptive families.
