**Summary:**

An hour and half of footage has been reviewed from 23:00 on 18<sup>th</sup> August 2022 until 00:30 the following morning of 19<sup>th</sup> August 2022 over 4 different cameras.

Camera 1 shows two private dance areas where one performance took place after midnight with one performer and one customer.

Camera 2 shows a private dance area consisting of a corner booth, two performances took place in this area over the time period.

Camera 3 and 4 show three private dance booths. Camera 3 shows two of the booths and camera 4 shows all three. Both of the camera angles combine show a clear visual of the performances in that area of the premises. This is the main area where customers have a private dance and over the course of the time period 22 dances took place.

A total of 25 dances were performed by 8 different performers, all of these dances were found to be compliant.
