# Spitalfields & Banglatown masterplan SPD

Summary of Decision	Cabinet will be asked to approve the Spitalfields & Banglatown masterplan SPD. The masterplan SPD seeks to provide principles and guidance on the implementation of policies in the Tower Hamlets Local Plan 2031, and the emerging new Local Plan.
	Once adopted, the document will have weight as a material planning consideration, setting out the Council's expectations for planning applications.
	The Spitalfields & Banglatown masterplan SPD has been through an extensive preparation process. This includes a baseline analysis such as mapping, site analysis, and a thorough summary of the early engagement carried out in May and June 2023. This comprised an in-person town-hall event, on-site pop-up stall, webinar, and online survey (with over 550 responses); further informal engagement in November 2023 which consisted of two in- person workshops and a webinar.
	Preparation of a draft document was carried out over December 2023 and January 2024. Formal public consultation took place from early-May to mid-June 2024. A wide range of community groups, residents, landowners, and other stakeholders have so far engaged with and will continue to be consulted on the SPD.
	Adopting the Spitalfields & Banglatown masterplan SPD will enable clear and robust guidance to inform and be implemented in development proposals. The SPD will allow the delivery of a shared vision, ensuring new developments are consistent with the council's Strategic Plan, Local Plan, and other relevant policy

documents.
