Summary of Decision	The paper requires decision on the key reconfiguration proposals for the hostel sector during 2016 - 2019, which will shape the re-tendering of hostels during 2016/2017, when the current hostel contracts come to an end. These contracts begin to expire from the winter 2016, so this decision is needed.
