Under the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 – notice is hereby given of the intention to make a Key Decision where it is impractical to provide 28 clear days' notice in advance of the decision being taken.

This notification will be published at least 5 clear days before the decision is taken.

NATURE OF DECISION/RECOMMENDATION REQUIRED:

The Mayor to be recommended to:

- Confirm acceptance of the variations to the Development Agreement to allow the project to reach financial close.
- Confirm his preference with regard to the indemnity requirements now required by the Developers Funders in order for the deal to be finalised. These options are set out in Section 2 of the report.

Reason why it is impractical to provide 28 clear days' notice of the decision:

The Poplar Baths and Dame Colet scheme has been significantly delayed due to negotiations resulting in these variations. This has been driven as noted by the need to make the project bankable. Over this time the cost of financing the scheme has risen and whilst within the current cabinet approval further cost increases may make the scheme unaffordable to the council. The current and recent trend in interest rate swap hedging indicates a continued cost increase to the project for any delay. Failure to enter into the contracts because of this delay given that the bank and developer are ready and waiting to sign could give rise to claims from either the developer or bank who may seek to recover losses. Even were these claims to fail fighting them would cost the Council irrecoverable costs.

Further delays will inevitably also lead to cost pressures within the contract which could lead to downstream cost pressures on the scheme as a whole and therefore risk insolvency of the SPV.

The current bank credit approval is also time limited and whilst currently extended for the current delay a significant delay will require the bank to revisit credit committee which will also put the project at risk of failure or cost increase.

The bank, developer and the Council continue to be exposed to ongoing costs which also require resolution to avoid further cost increases. A decision either for or against the proposals contained in this report will crystallise costs rather than allowing them to continue to escalate.

Because of the risks and issues identified above further delay may prejudice the Council's commercial interests as outlined and in this respect the notice and call-in periods are considered significant.

- 2. Information which is likely to reveal the identity of an individual
- 3. Information relating to the financial or business affairs of any particular person (including the authority handling the information)
- 4. Information relating to any consultations or negotiations, or contemplated consultations or negotiations, in connection with any labour relations matters arising between the authority or a Minister of the Crown and employees of, or office holders under, the authority.
- 5. Information in respect of which a claim to legal professional privilege could be maintained in legal proceedings.
- 6. Information which reveals that the authority proposes:
 - a) to give under any enactment a notice under or by virtue of which requirements are imposed on a person; or
 - b) to make an order or direction under any enactment.
- 7. Information relating to any action taken or to be taken in connection with the prevention, investigation or prosecution of crime.
