The public are welcome to attend meetings of the Committee. However seating is limited and offered on a first come first served basis.

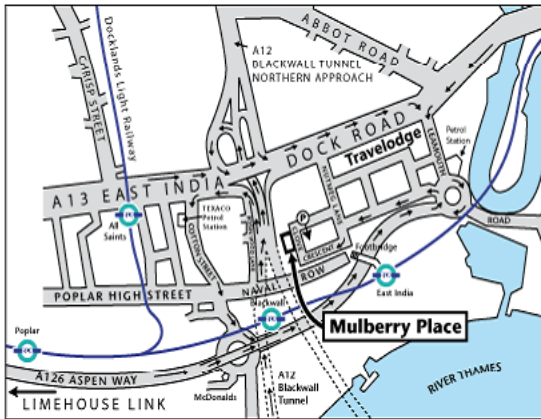

Blackwall station: Across the bus station then turn right to the back of the Town Hall complex, through the gates and archway to the Town Hall.
