<u>DECLARATIONS OF INTERESTS - NOTE FROM THE CHIEF EXECUTIVE</u>

This note is guidance only. Members should consult the Council's Code of Conduct for further details. Note: Only Members can decide if they have an interest therefore they must make their own decision. If in doubt as to the nature of an interest it is advisable to seek advice prior to attending at a meeting.

Declaration of interests for Members

Where Members have a personal interest in any business of the authority as described in paragraph 4 of the Council's Code of Conduct (contained in part 5 of the Council's Constitution) then s/he must disclose this personal interest as in accordance with paragraph 5 of the Code. Members must disclose the existence and nature of the interest at the start of the meeting and certainly no later than the commencement of the item or where the interest becomes apparent.

You have a **personal interest** in any business of your authority where it relates to or is likely to affect:

- (a) An interest that you must register
- (b) An interest that is not on the register, but where the well-being or financial position of you, members of your family, or people with whom you have a close association, is likely to be affected by the business of your authority more than it would affect the majority of inhabitants of the ward affected by the decision.

Where a personal interest is declared a Member may stay and take part in the debate and decision on that item.

What constitutes a prejudicial interest? - Please refer to paragraph 6 of the adopted Code of Conduct.

Your personal interest will also be a prejudicial interest in a matter if (a), (b) and either (c) or (d) below apply:-

- A member of the public, who knows the relevant facts, would reasonably think that your personal interests are so significant that it is likely to prejudice your judgment of the public interests; AND
- The matter does not fall within one of the exempt categories of decision listed in (b) paragraph 6.2 of the Code; AND EITHER
- The matter affects your financial position or the financial interest of a body with which (c) you are associated; or
- The matter relates to the determination of a licensing or regulatory application (d)

The key points to remember if you have a prejudicial interest in a matter being discussed at a meeting:-

- i. You must declare that you have a prejudicial interest, and the nature of that interest, as soon as that interest becomes apparent to you; and
- ii. You must leave the room for the duration of consideration and decision on the item and not seek to influence the debate or decision unless (iv) below applies; and

- iii. You must not seek to <u>improperly influence</u> a decision in which you have a prejudicial interest.
- iv. If Members of the public are allowed to speak or make representations at the meeting, give evidence or answer questions about the matter, by statutory right or otherwise (e.g. planning or licensing committees), you can declare your prejudicial interest but make representations. However, you must immediately leave the room once you have finished your representations and answered questions (if any). You cannot remain in the meeting or in the public gallery during the debate or decision on the matter.

1. Summary

1.1 This report sets out the results of a polling district and polling place review and makes proposals for the use of two additional polling places and suggests that there be an amendment in respect of the extent of one polling districts.

2. Recommendations

2.1 That the Committee considers the recommendations set out in paragraph 5 below and recommend that they be adopted by the Council for implementation in time for the local government election in May 2010.

3. Background

- 3.1 Over the past two years Electoral Services have conducted a number of polling place reviews. In 2008, all premises used as polling stations were visited with a particular emphasis on access and the requirements of the Disability Discrimination Act 1995 as amended on 1st October 2004.
- 3.2 In the report to the previous meeting held on 22 October 2008, the Committee were advised that the Boundary Commission had identified its priorities for 2009-2011 and the council's situation did not fulfil the criteria for a ward boundary review prior to the next full review due to take place in 2011 under legislation section 16 of the Electoral Administration Act 2006.
- 3.3 This report identifies the increase in electorate due to growth in the number of properties in the borough and proposes new polling districts and polling places as set out below.

4. Definitions

4.1 To ensure clarity in discussing issues arising from the review the following definitions are used:

polling district; a geographical sub-division of an electoral area ie a UK

parliamentary constituency, a European parliamentary electoral region, a ward or an electoral division.

polling place; a geographical area in which a polling station is located. however, as there is no legal definition of what a polling place is, the geographical area could be defined as tightly as a particular building or as widely as the entire polling district.

polling station; the actual area where the process of voting takes place, and must be located within the polling place designated for the particular polling district.

5. Process

- 5.1 Following publication of the revised Register of Electors 2010 and in preparation for the local election, Mayoral referendum and Parliamentary election in May 2010, the Electoral Services Manager and her deputy conducted a review of those wards where the electorate has risen significantly over the past year. A full breakdown of each ward by polling district, polling place and electorate is shown at Appendix A.
- 5.2 The proposals are as follows:

Bow East, BE2 – currently there are 2 polling stations at Eastside Youth Centre and due to the amount of electors attending the centre, we propose to create a new polling place, BE2A, at Wrights Community Centre, Wrights Road, E3 5LG to deal with the area south of Parnell Road and reduce 1 polling place at Eastside. See Appendix B.

Millwall; The current electorate for MI1 polling district is 5,702, which is too large for one polling place, with 3 polling stations at Seven Mills Primary School. We propose to create a new polling district MI4 with an additional polling place sited at River House Montessori School, 3 Millharbour, E14 9XP (former Council Housing Offices) to deal with the current and anticipated increase in the electorate. The electorate for MI1 would reduce to 3,357, with 2 polling stations at Seven Mills Primary School and the electorate for MI4 would equate to 2,345, with two polling stations at the new River House Montessori School. The revised polling district boundary and new polling place location is set out at Appendix C.

Mile End East; change Stebon Primary School to Burdett Neighbourhood Centre, off Woowood Street, Masjid Lane, E14 7BW (opposite school).

5.3 **Bow East**; BE1 - we were asked to look into the possibility of creating a new polling district in this area, to give an additional polling place for residents of Wick Lane, Cadogan Terrace, Whitepost Lane, Dace Road and part of Jodrell Road to ensure residents have a polling place within easy access to be able to cast their vote. As the total electorate affected is 348, at this time we cannot justify a new polling place under current regulations. However, as the electorate grows in this area, we will review the situation again.

Concurrent Report of the Assistant Chief Executive (Legal Services)

6. It was a legal requirement to carry out the review of polling places in 2007 and thereafter every four years in accordance with the requirements of the Electoral Administration Act 2006. Each polling district must have sufficient and suitable designated polling places that provide 'such reasonable facilities for voting that are practicable in the circumstances' including accessibility for electors with disabilities. The Council is under a duty to promote equality for those with a disability and the recommendations in this report are drafted with this duty in mind.

Comments of the Chief Financial Officer

7. This report describes a review of polling districts and polling places in Tower Hamlets and makes recommendations to create two additional polling places and amend one polling district due to increases in the electorate in recent years.

Any financial implications arising from these changes are expected to be fully contained within existing budgets.

One Tower Hamlets Considerations

8. It is essential that disabilities issues are taken into account particularly in relation to identifying new polling places.

Risk Management Implications

9. The entire polling place review exercise is concerned with managing risk at all premises used as polling places
