Mr Matthew Mannion, Committee Services Manager, presented the report which set out for noting the General Purposes Committee Terms of Reference, Quorum, Membership and dates of meetings as agreed by the Council Annual General Meeting held on 16 May 2012.

#### **5.5 LOCAL ELECTORAL REVIEW - UPDATE**

Mr John Williams, Service Head Democratic Services, introduced the report. He outlined the progress of the Boundary Commission's review to date and the next steps. He asked the Committee to note a number of points including:

- The Commission was proposing 45 Councillors for the Borough
- The Commission was now considering the development of the new Ward structure.

- The public consultation period would last until 28 August. Draft proposals were expected in November.
- Future population growth would be factored into the design of Wards. Early examples of population data prepared by the Commission were shown to Members for their information.
- The new Ward boundaries would be in place for the 2014 Local Elections.

The Committee discussed the report and noted particular issues including:

- Whether the population growth estimates were an underestimate, particularly in areas such as the Isle of Dogs.
- Population growth could well straddle existing polling district boundaries so care needed to be taken when compiling data.
- The naming of the Wards was an important consideration and was part of the current consultation.
- Meetings with the Commission for particular political groups were likely to be very useful.

Responding to questions, officers stated that:

- Officers would be available to offer support to party groups that wished to submit consultation responses.
- The Commission were keen to meet with interested groups and could be invited to an 'all Councillors' meeting or to individual group discussions.
- The Commission were very aware of the importance of community and historical links when designing and naming Wards.
- The officers' understanding was that the Ward design should ensure no more than a 10% variation in Ward population by 2018. More detail would be requested from the Commission, in particular regarding which month's projected figures in 2018 should be used.
- The Commission would also be asked to advise on the relationship (if any) between the current local review and the separate review of parliamentary constituency boundaries.

That the information in the report be noted.

### **5.6 APPOINTMENTS TO EXTERNAL BODIES - CONSTITUTIONAL MATTERS**

Ms Isabella Freeman, Assistant Chief Executive (Legal Services), introduced the report. She set out the history of the issues in the report and confirmed the legal view that it was the Mayor who held the power to make Executive appointments to outside bodies except in certain specific circumstances.

Following a request from Councillor Peter Golds, officers agreed to examine whether the original rules for appointing to outside bodies, as agreed by Members, had been properly determined, with particular reference to

decisions taken at the 3 March and 27 October 2010 Council meetings that reserved local choice functions to the Council.

During discussion Members raised a number of points relating to the nature of Executive appointments such as:

- Many bodies had wide ranging functions that did not fit Executive portfolios.
- Many bodies required Members of a local, ward representative nature, whilst for others, cross-party representation could be beneficial. This could potentially be at odds with the appointment of Executive members. Officers agreed to consider the issue of balancing the representative as against Executive nature of Member appointments.
- Being appointed to outside bodies was an important part of the function of being a Councillor and it was important that Members appointed to such bodies could devote adequate time to the role and commit to attending meetings etc.
- There was a need to resolve this issue as vacancies were now occurring.

Following the discussion officers confirmed that there was scope for examining whether some appointments related to Executive functions. However it was noted that the Local Government Act 2000 was explicit that most issues were Executive functions. However, in most cases the Mayor was free to appoint any Councillor, not just the members of the Executive, to outside bodies should he so wish.

Officers agreed to liaise with the Mayor and the party groups on this issue, following which the Assistant Chief Executive (Legal Services) would report back to the next meeting of the General Purposes Committee.

## **RESOLVED**

That a report be prepared for the next meeting of the General Purposes Committee providing an officer response to the following issues:

- Whether the Constitution had correctly taken account of Council resolutions on this matter, with particular reference to those from the 3 March and 27 October 2010 meetings.
- Which appointments to outside bodies were considered to be executive functions, and which were agreed by consent of the Mayor and group leaders to be made by the Council/General Purposes Committee.
- The extent to which issues such as the representative role of Councillors impacts on the consideration of appointments to outside bodies.
