<u>DECLARATIONS OF INTERESTS - NOTE FROM THE CHIEF EXECUTIVE</u>

This note is guidance only. Members should consult the Council's Code of Conduct for further details. Note: Only Members can decide if they have an interest therefore they must make their own decision. If in doubt as to the nature of an interest it is advisable to seek advice prior to attending at a meeting.

Declaration of interests for Members

Where Members have a personal interest in any business of the authority as described in paragraph 4 of the Council's Code of Conduct (contained in part 5 of the Council's Constitution) then s/he must disclose this personal interest as in accordance with paragraph 5 of the Code. Members must disclose the existence and nature of the interest at the start of the meeting and certainly no later than the commencement of the item or where the interest becomes apparent.

You have a **personal interest** in any business of your authority where it relates to or is likely to affect:

- (a) An interest that you must register
- (b) An interest that is not on the register, but where the well-being or financial position of you, members of your family, or people with whom you have a close association, is likely to be affected by the business of your authority more than it would affect the majority of inhabitants of the ward affected by the decision.

Where a personal interest is declared a Member may stay and take part in the debate and decision on that item.

What constitutes a prejudicial interest? - Please refer to paragraph 6 of the adopted Code of Conduct.

Your personal interest will also be a prejudicial interest in a matter if (a), (b) and either (c) or (d) below apply:-

- (a) A member of the public, who knows the relevant facts, would reasonably think that your personal interests are so significant that it is likely to prejudice your judgment of the public interests; AND
- The matter does not fall within one of the exempt categories of decision listed in (b) paragraph 6.2 of the Code; AND EITHER
- The matter affects your financial position or the financial interest of a body with which (c) you are associated; or
- The matter relates to the determination of a licensing or regulatory application (d)

The key points to remember if you have a prejudicial interest in a matter being discussed at a meeting:-

- i. You must declare that you have a prejudicial interest, and the nature of that interest, as soon as that interest becomes apparent to you; and
- You must leave the room for the duration of consideration and decision on the item and ii. not seek to influence the debate or decision unless (iv) below applies; and

- iii. You must not seek to <u>improperly influence</u> a decision in which you have a prejudicial interest.
- iv. If Members of the public are allowed to speak or make representations at the meeting, give evidence or answer questions about the matter, by statutory right or otherwise (e.g. planning or licensing committees), you can declare your prejudicial interest but make representations. However, you must immediately leave the room once you have finished your representations and answered questions (if any). You cannot remain in the meeting or in the public gallery during the debate or decision on the matter.

1. ELECTION OF CHAIR

The Service Head, Democratic Services advised members that this was the first meeting of the Committee in the new municipal year. As such it was necessary to elect a Chair. That person would normally hold that post for the remainder of the year, although in this case would only serve until 30th June 2012, when the Standards Committee would be abolished and the new standards regime would come into operation. Mr Williams invited nominations for an Independent Member to serve as Chair.

Ms Sue Rossiter MOVED and Mr Barry Lowe SECONDED that Mr Barry O'Connor be re-elected as Chair of the Standards Committee for 2012/13 or until the Committee was disbanded.

No further nominations were received and it was therefore

RESOLVED

That Mr Barry O'Connor be elected as Chair of the Standards Committee until 30th June 2012.

Chair for the meeting

In the absence of the Chair, Mr O'Connor, Ms Sue Rossiter MOVED that Mr Eric Pemberton be elected Chair for the meeting and this was SECONDED by Ms Councillor Zara Davis.

No further nominations were received and it was therefore

6. REPORTS FOR CONSIDERATION

6.1 Standards Committee - Membership, Terms of Reference and Programme of Meetings 2012/13

In response to a query about the makeup of the new Standards Advisory Committee, Mr John Williams, Service Head, Democratic Services explained that if Barry O'Connor were appointed the new *Independent Person*, this would prevent him from being a Member of the committee. He could however attend meetings as an observer.

Mr Williams also advised the Committee that paragraph 6 a) of the report contained a typing error. The co-opted members of the Standards Advisory Committee would in fact be voting members.

RESOLVED

That subject to the correction above, the report be noted.

6.2 Localism Act 2011 - The Amended Standards Regime

The Chair drew Members' attention to tabled copies of the following documents:

- Localism Act The Amended Standards Regime report of the Assistant Chief Executive (Legal Services);
- 2. Extraordinary Council Meeting:18th June 2012 Localism Act 2011 The Amended Standards Regime draft report;
- 3. Disclosable pecuniary interests schedule:
- 4. Conservative group comments;
- 5. Statutory Instrument 2012 No. 1463; and
- 6. Localism Act 2011 The Amended Standards Regime: Addendum report.

Ms Isabella Freeman, Assistant Chief Executive, Legal Services highlighted the key changes and commented as follows:

- Paragraph 1 recruitment for an Independent Person: it was agreed that some of the Members of the Standards Advisory Committee [SAC] will participate in the recruitment process
- Paragraph 2.3 as regards consideration of any requests for dispensations, officers proposed that a Dispensation Sub-Committee of the SAC be part of this process, with the option for such a committee to be convened at relatively short notice. In the case of urgent matters, it could be resolved by email and ratified at a later stage;
- Paragraph 3.5 this allowed for the possibility of the Independent Person being the current Chair of the Standards Committee from the 1st July when the new SAC comes into being;
- Paragraph 5.2 with regards to the oversight of all complaints including those not referred for investigation, officers recommended that the Monitoring Officer and Independent Person consult on the matter initially, and then report to an Investigation and Disciplinary Sub-Committee – there will be no recourse to the main committee. This was to ensure finality and avoid the matter becoming protracted:
- Paragraph 5.3 where there had been no breach of the code, it would be referred to the Investigation Sub-Committee and this would conclude the matter;
- Paragraph 5.9 the findings would be published in a local newspaper and on the Council's website. Ms Freeman assured Members that the decision would be published simply as a notice in the newspaper;
- Paragraph 5.11 with regards to the right of appeal, officers recommended a Hearings Sub-Committee and a separate Appeal Sub-Committee. It was for Members to decide if a two-tier system would still be adopted, whilst allowing for an appeal to be made to the first tier tribunal;
- Paragraph 5.13 dealt with the monitoring of report-back to the Advisory Committee as to whether a sanction had been complied with;
- Paragraph 5.14 dealt with situations where three consecutive meetings had been missed and bringing it to the attention of full Council.

Terms of Reference, Appendix 1

- Confidential matters: the proposal was for matters to remain confidential until a complaint was investigated and substantiated;
- Composition the SAC will be chaired by a co-opted member.

Role and function

- Where a complaint had been referred for investigation by the Monitoring Officer, and such a complaint was subject to an investigation, the SAC/Sub-Committee would recommend whether or not it should proceed to hearing.
- If the Monitoring Officer considered that a complaint should not be the subject of an investigation or should not proceed to a hearing, s/he shall convene an Investigation and Disciplinary Sub-Committee of the SAC and it shall be the final arbiter on the matter.

Appendix 2

- Complainants must provide their name and postal address when submitting a complaint;
- Where the Monitoring Officer considered that a complaint should not be subject to an investigation, an Investigating and Disciplinary Sub-Committee shall be convened and it shall make the final decision on the matter:
- Where a subject Member feels that a recommended sanction would cause him/her undue hardship or prevent him/her from undertaking ward duties, that Member may make representations to the Council meeting that will consider the recommendations of the Hearings Sub-Committee on the relevant complaint. Any such representations shall be notified to the Monitoring Officer within five working days of the Hearing Sub-Committee;
- The content of the notice of the recommendations of the Hearings Sub-Committee shall be agreed by the Chair of the Hearings Sub-Committee. Following publication, a link to the notice shall remain on the front page of the Council's website for one month, or such other position or period as the Hearings Sub-Committee saw fit. The Monitoring officer shall draft further guidance on the detailed procedures for publication of decisions as necessary;
- A complainant who was dissatisfied with the outcome of his/her complaint may appeal against that outcome. Any appeal under this section shall be notified in writing to the Monitoring Officer within 15 working days of the Hearings Sub-Committee recommendation being notified to the member or complainant and the Monitoring Officer shall arrange for the appeal to be heard by a Hearings (Appeal) Sub-Committee of the SAC within 15 working days of receipt of the appeal. The decision of the Hearings Sub-Committee shall not be published, nor any sanctions applied, until the period allowed for an appeal had expired;
- A member who was the subject of a complaint shall be informed of, and shall have the right to attend and/or be represented at, the hearing

of the Standards Advisory Committee or any of its sub-committees that considers any matter relating to that complaint following investigation.

Members highlighted a number of issues and concerns as follows:

- One Member queried how the Council's Respect Councillors were selected for the sub committees in the past to decide on matters involving complaints against the Council's Independent Councillors as they always voted together. The Monitoring Officer pointed out that the decisions of the Assessment Sub-Committee in the past had always been unanimous and they had two co-opted Members (non councillors) on them. A co-opted member confirmed that each Member had the opportunity to explain their opinion with reasons to the others and they came to a unanimous decision. This was left open to resolve when the SAC was operational;
- Some Members were also concerned about the subject member's right of appeal, fearing that the process could drag on with no finality;
- One Member felt that for the sake of clarity, the publishing rules ought to be quite prescriptive;
- Another Member believed that there was some confusion over the use of the word 'confidential' and requested a clear definition for Members.

In response, Ms Freeman made the following points:

- With regards to an appeals process, Ms Freeman suggested a time period of 21 calendar days [15 working days];
- With reference to sanctions, those drafting the legislation were very definitively of the view that the only sanction should be that there should be a withdrawal of resources so that that Member was unable to use meeting rooms, or the Council's facilities for their business;
- With regards to confidential information, Ms Freeman advised that it was not possible to have a singular definition of what constituted 'confidential' material. Members were advised to seek guidance from the Monitoring Officer. Ms Freeman offered to compile a briefing document of 'confidential' information based on the Constitution and the law. A co-opted member confirmed that there was a need for stricter guidance on what they ought to be taking into account before they can disclose information, to ensure that information was not disclosed in a misleading manner or in a way that was deemed improper.

RESOLVED

1. That the Standards Committee note the changes set out in the report of the Assistant Chief Executive (Legal Services) and agree the submission of the revised report to full council for adoption.

- 2. That the Committee note the information in the addendum report and that the proposed new Standards arrangements to be submitted to the Council for adoption will be amended to comply with the provisions of the Localism Act 2011 (Commencement No.6 and Transitional, Savings and Transitory Provisions) Order 2012 and the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012.
- 3. That the Council be recommended to appoint the existing Independent Chair of the Standards Committee as the 'Independent Person' under the new arrangements, to serve until the completion of the recruitment process to that position.
- 4. Consequent on point 3 above, that the Council be recommended to not appoint the existing Chair of the Standards Committee at this stage as a co-opted member of the new Standards Advisory Committee, but that he be invited to attend meetings of that advisory committee as an observer.

7. ANY OTHER BUSINESS WHICH THE CHAIR CONSIDERS URGENT

In response to a query by the Chair about the composition of the new Standards Advisory Committee, Mr Williams explained that it will comprise seven Councillors and seven co-opted Members. He also confirmed that the Chair of SAC will be a co-opted member.

The meeting ended at 8.45 pm.

1. **SUMMARY**

 - Investigation and Disciplinary Sub-Committee
 - Hearing Sub-Committee
 - Dispensations Sub-Committee

3. BACKGROUND

3.1 Following changes to the Standards regime in the Localism Act 2011, a new Standards Advisory Committee will come into existence from 1st July 2012. This report details the membership and terms of reference of the Committee and its programme of meetings for the forthcoming municipal year.

4 <u>COMPOSITION (STANDARDS ADVISORY COMMITTEE)</u>

a) Membership:

The Council has agreed that the Standards Advisory Committee will be composed of:

- Councillors (who may not include the Mayor or more than one other Cabinet Member), appointed in accordance with proportionality rules; and
- up to seven co-opted Members (non-voting).
- b) Six of the seven previous Standards Committee Independent Members were reappointed as Co-optees to the Standards Advisory Committee by the Council for a four year term of office subject to confirmation at the Annual Council meeting. Co-opted Members may serve as many terms of appointment as the Council considers appropriate. A person may not be appointed as a Co-opted Member of the Standards Advisory Committee or one of its sub-committees unless the appointment is approved by Full Council.

The seventh Independent Member (and Chair) of the former Standards Committee, Mr. Barry O'Connor, was appointed as the interim 'Independent Person' under the new Standards arrangements agreed by the Council and has therefore not been appointed as a co-opted member of the Standards Advisory Committee. Mr. O'Connor will however be invited to attend the Committee's meetings as an observer.

c) Chairing the Committee

The Council has agreed that the Chair and the Vice Chair of the Committee will be Co-opted Members.

5. CURRENT MEMBERSHIP (STANDARDS ADVISORY COMMITTEE)

5.1 The Annual Meeting of the Council held on 16th May 2012 appointed the following Councillors to membership of the Committee:

The Chair and Vice-Chair will be appointed from the above Co-opted Members of the Committee.

5.3 The quorum for meetings of the Standards Advisory Committee and for each of its sub-committees is three of the total membership and this must include at least one councillor and one Co-opted Member. A co-opted member shall Chair the meeting.

6. TERMS OF REFERENCE

The Council using the powers under section 102(4) of the Local Government Act 1972 have established a Standards Advisory Committee.

The Standards Advisory Committee shall have the power to create Sub-Committees in order to discharge its advisory role.

Composition

The Standards Advisory Committee shall be comprised of Members of the Council (not including the Mayor or more than one Cabinet Member), appointed by the Council in accordance with the requirements of political proportionality; and up to seven persons who are not Members or officers of the Council or any other relevant authority (i.e. Co-opted members.)

The Co-opted member(s) will be entitled to vote at meetings under the provisions of S13 (4) (e) of the Local Government and Housing Act 1989.

The Committee shall establish Hearings and other Sub-Committees in accordance with these terms of reference.

Appointment of Co-Opted Members

A person may not be appointed as a Co-opted member of the Standards Advisory Committee or one of its sub-committees unless the appointment is approved by Full Council. The term of appointment shall be for four years unless otherwise determined by Full Council or the Co-optee does not continue to fulfil any required conditions as may be determined by the Authority from time to time. Co-opted

members may serve as many terms of appointment as the Council considers appropriate.

Role and Function

The Standards Advisory Committee has the following roles:

- a. To recommend to the Monitoring Officer whether or not any complaint of a breach by the Mayor, a Councillor or a co-opted member of the Members Code of Conduct should be referred for investigation by the Monitoring Officer or an investigator appointed by the Monitoring Officer; and where a complaint has been subject to such investigation, to recommended whether or not the complaint should proceed to hearing. Where the Monitoring Officer considers that a complaint should not be subject to investigation or should not proceed to hearing, s/he shall convene an Investigation and Disciplinary Sub-Committee of the Standards Advisory Committee which shall make the final decision on the matter:
- b. To receive regular quarterly reports from the Monitoring Officer on the numbers of complaints of the Code received, the decisions taken by the Monitoring Officer (in consultation with the Independent Person) on such complaints and investigation outcomes where the investigation determines there was no evidence of a failure to comply with the code or where the investigation outcome recommends a local resolution;
- c. To convene a Hearings Sub-Committee of three Members of the Standards Advisory Committee comprising two of the co-opted members and one Councillor to consider any matter where the investigation finds evidence of a failure to comply with the Code and a local resolution is not possible or appropriate;
- d. To make such recommendations to Council in respect of the matter as the Hearings Sub-Committee considers appropriate as a result of any matter referred including;
 - Reporting its findings to Council for information;
 - Recommending to the member's Group Leader (or in the case of ungrouped members, recommend to Council or to Committees) removal from any or all Committees or Sub-Committees of the Council;
 - Recommending to the Mayor removal from the Executive, or from particular Portfolio responsibilities;
 - Recommending the Monitoring Officer arrange training for the member;
 - Recommending removal from outside appointments to which he/she has been appointed or nominated;
 - Recommending withdrawing facilities provided to the member by the Council, such as a computer, website and/or email and Internet access;
 - Recommending excluding the member from the Council's offices or other premises, with the exception of meeting rooms as necessary for attending Council, Executive Committee and Sub-Committee meetings;
 - Recommending the Member to contact the Council via specified point(s) of contact;

- e. To convene a Hearings (Appeal) Sub-Committee of at least three different Members of the Standards Advisory Committee (comprising two of the co-opted members and one Councillor) to consider any appeal against a finding of, or sanction recommended by, the Hearings Sub-Committee;
- f. To receive reports on compliance with any recommendation(s) made for sanctions to be applied in respect of any member.
- g. Promoting and maintaining high standards of conduct by the Mayor, Members of the Council, co-opted members including church and other faiths and parent governor representatives and where the Committee considers that there may be issues of concern recommending that the Monitoring Officer considers and reports on the issues raised.
- h. Assisting the Mayor, Members of the Council, co-opted members including church and other faiths and parent governor representatives to observe the Council's Code of Conduct for Members;
- i. Advising the Council on the adoption or revision of the Code of Conduct for Members;
- j. Monitoring the operation of the Code of Conduct for Members;
- k. Advising, training or arranging to train the Mayor, for Members of the Council, co-opted members including church and other faiths and parent governor representatives on matters relating to the Code of Conduct for Members:
- I. To act as an advisory body in respect of any matters referred to the Standards Committee by the Local Strategic Partnership (LSP) or Community Forums in respect of probity issues arising out of the codes and protocols applicable to relevant members of the LSP and Community Forums as set out in the Community Forum handbook and as may be amended from time to time.
- m. To advise on allegations of Member breaches of the Protocols set out in the constitution as may be referred to the Committee by the Monitoring Officer and to make recommendations with regard to such allegations as may be so referred.
- n. Advising on local protocols for both Officer and Member governance.
- o. To monitor and review Member and Officer Procedures for registering interests and declaring gifts and hospitality.
- p. To receive periodic reports on the Council's Ethical Governance arrangements, on whistle blowing arrangements and complaints; and
- q. As requested by the Monitoring Officer, to establish a Dispensations Sub-Committee to advise on any applications for dispensations in relation to participation at a meeting by a member with a Disclosable Pecuniary Interest.

Validity of proceedings

A meeting of the Standards Advisory Committee or one of its sub-committees shall only be quorate where at least three members of the Committee or sub-committee are present for its duration and such quorum must include at least one councillor and at least one co-opted member.

Part VA of the Local Government Act 1972 applies in relation to meetings of the Standards Advisory Committee or its sub-committees as it applies to meetings of the Council.

Hearings Sub-Committee and Hearings (Appeal) Sub-Committee

Any Hearings Sub-Committee or Hearings (Appeal) Sub-Committee shall comprise a minimum of three Members of the Standards Advisory Committee at least two of whom shall be co-opted members.

The Hearings Sub-Committee shall consider complaints referred to it that the Mayor, an elected or co-opted Member of the Council may have failed to comply with the Council's Code of Conduct for Members or local protocol where the complaint has been subject to an investigation arranged by the Monitoring Officer and shall make recommendations accordingly. The Hearings Sub Committee shall decide at the outset of the meeting whether it is in the public interest that the Hearing is held in a public or private session in accordance with relevant statutory guidance as advised by the Monitoring Officer.

The membership of the Hearings (Appeal) Sub-Committee shall not include any member who served on the Hearings Sub-Committee that considered the same complaint.

The Independent Person, or if that person is unable to act a reserve Independent Person, shall have the right to attend all meetings of the Hearings Sub-Committee or Hearings (Appeal) Sub-Committee as an observer but may not vote or participate in the decision making.

Attendance Requirements

In the event that any Member of the Committee does not attend three or more consecutive meetings of the Committee, the Committee may draw the attention of the Council to such non-attendance and may recommend that the member concerned be replaced on the Committee.

The Committee shall not do so without first giving the absent Member an opportunity to make representations (which may be made in writing) as to their non-attendance and any matters they wish the Committee to take into account.

Procedures

The Committee shall agree a set of procedures to enable it to discharge the arrangements under these Terms of Reference.

Confidentiality

The Committee and any of its Sub-Committees may meet in private in accordance with the relevant legislation as advised by the Monitoring Officer. Any meeting or part of a meeting that considers whether or not a complaint should be referred for investigation or, following an investigation should proceed to hearing, shall be held in private and all papers relating to that consideration shall remain confidential.

 - Tuesday 15th January 2013 at 7.30 p.m. Tuesday 16th April 2013 at 7.30 p.m.

1. **SUMMARY**

- 1.1 The Localism Act 2011 introduced a number of changes to the regime governing standards of conduct by members and co-opted members of local authorities. The Council on 18th June 2012 adopted new arrangements to apply in Tower Hamlets in accordance with the Act from 1st July 2012. These arrangements include:-
 - the adoption of a new Code of Conduct (attached at Appendix 'A');
 - the establishment of a Standards Advisory Committee, with terms of reference as attached at Appendix 'B';
 - arrangements for dealing with any complaint of a breach of the new Code (Appendix 'C'); and
 - the recruitment of a statutory 'Independent Person' to advise on any such complaints in accordance with the requirements of the Localism Act.
- 1.2 The arrangements agreed by the Council were subject to consultation with all councillors, the Mayor and the Independent Members of the former Standards Committee prior to an initial discussion at the Standards Committee on 10 May 2012. Following that meeting there was a further period of consultation including a Members' Seminar on 30 May and a further meeting of the Standards Committee on 12th June prior to adoption of the new arrangements by the Council.
- 1.3 There was a consensus amongst members, the Standards Committee and in the responses to the consultation that the Council should continue with a robust Standards regime with independent Members, and that the Member Code of Conduct should continue to cover a broad spectrum of matters to demonstrate the highest ethical standards within the new Act.

2. **RECOMMENDATION**

2.1 The Standards Advisory Committee is requested to note the decisions of the Council on 18th June 2012 as at section 7 overleaf; and the attached appendices 'A' – 'C' setting out the new Standards arrangements effective in Tower Hamlets Council from 1st July 2012.

3. BACKGROUND

- 3.1 The Localism Act 2011 makes fundamental changes to the system of regulation of standards of conduct for elected and co-opted members. The Council is required to adopt a new Code of Conduct. No specific Code of Conduct is prescribed, although the Local Government Minister and the Local Government Association have each published suggested template codes. However, the Council agreed that these omit a number of important matters and has adopted a code more similar to the previous model code. It should be noted that the Council can amend its new Code of Conduct subsequently if it wishes in the light of experience of its operation and of developing law in this area.
- 3.2 The Council remains under a statutory duty to promote and maintain high standards of conduct for its elected and co-opted members. As far as possible the new framework remains close to the previous one that was well established and understood by members.
- 3.3 The Localism Act repeals Section 55 of the Local Government Act 2000, which provided for the previous statutory Standards Committee. So, there is now no requirement for a Standards Committee. However, there is still a need to deal with standards issues and case work. Tower Hamlets had a Standards Committee before the previous regime was introduced in the 2000 Act and the new arrangements are similar in many respects to those that applied then. A Standards Advisory Committee has been established as a committee of Council under S101/102 of the Local Government Act of 1972. This does not incorporate the unique features or statutory powers which were conferred on statutory Standards Committees. Its composition will be subject to proportionality. It is possible to co-opt non elected members onto a Committee of the Council however such co-optees cannot vote unless the committee is advisory.
- 3.4 The Act establishes a new category of 'Independent Person' (see below) who must be consulted at various stages. Independent Persons may be invited to attend meetings of the Standards Committee, but are unlikely to be co-opted onto the Committee. Instead their role is one of consultation in respect of any investigation of an alleged breach of the Code before the Council takes a decision in relation to the allegation. As permitted by the Localism Act 2011 (Commencement No.6 and Transitional, Savings and Transitory Provisions) Order 2012, the Council has agreed to appoint Mr Barry O'Connor, former Independent Chair of the Standards Committee, as interim 'Independent Person' pending recruitment to that position.
- The provisions of the Code of Conduct, procedures for dealing with any complaint of a breach and the other elements of the arrangements in this report apply to the Elected Mayor, all councillors and co-opted members of any council committee or sub-committee when acting in that capacity.

4. CODE OF CONDUCT

4.1 The former ten General Principles and Model Code of Conduct have been repealed. However, the Council is required to adopt a new Code of Conduct governing elected and co-opted members' conduct when acting in that capacity. The Council's new

Code of Conduct must, when viewed as a whole, be consistent with the following seven principles; Selflessness; Integrity; Objectivity; Accountability; Openness; Honesty and Leadership

- 4.2 The Council has discretion as to what it includes within its new Code of Conduct, provided that it is consistent with the seven principles; and includes provisions which deal with the following matters:-
 - General conduct rules, to give effect to the seven principles. This corresponds broadly with paragraphs 3 to 7 of the former Code of Conduct, applies to conduct of an elected or co-opted member of the Council or any of its committees or sub committees.
 - A requirement for registration and disclosure of pecuniary and non-pecuniary interests but only requiring withdrawal as specified by the Act in relation to 'Disclosable Pecuniary Interests' to be defined in regulations.
 - Arrangements for dealing with an alleged breach of the Code.
- 4.3 The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 came into force on 1st July 2012. A Member with a Disclosable Pecuniary Interest (DPI) must register and disclose it, and his/her involvement in any business of the authority connected with those interests is limited. Failure to comply with the arrangements on DPIs without reasonable excuse is a criminal offence, with a penalty of a fine of up to £5,000 and disqualification from office for up to five years. In summary, the new regulations specify DPIs as pecuniary interests covering:-
 - A Member's employment, office, trade, profession or vocation;
 - Any sponsorship of the Member, including contributions towards their election expenses;
 - Any contracts between the Member and the authority;
 - Any land the Member has an interest in which lies within the area of the authority;
 - Any licences the Member holds to occupy land in the area;
 - Any corporate tenancies; and
 - Certain securities the Member may hold.
- 4.4 The new Code of Conduct, adopted by the Council with effect from 1st July 2012, is attached at Appendix 'A'.

5. ARRANGEMENTS FOR DEALING WITH MISCONDUCT COMPLAINTS

- 5.1 The Act requires that the Council adopt "arrangements" for investigating and deciding upon complaints of breach of Code of Conduct. The Council has established a Standards Advisory Committee which will operate in much the same way as it did before the 2000 Act came into effect. The committee will be an advisory committee (thus enabling co-optees to be fully participating members). Its powers (which are very much reduced under the new legislation) are advisory.
- 5.2 The Council agreed with the proposal by the Standards Advisory Committee that the Committee should retain oversight of all complaints including those not pursued.

The Council therefore agreed that where the Monitoring Officer is of the view that a complaint should not be referred for investigation, this decision should be subject to the Committee's endorsement. In order to enable a final resolution to be reached without delay, this function would be delegated to an Investigation and Disciplinary Sub-Committee of three members.

The terms of reference of the Standards Advisory Committee and related provisions are set out Appendix 'B' to this report and the arrangements agreed by the Council for dealing with any complaint of a breach of the new Code of Conduct are at Appendix 'C'.

6. **DISPENSATIONS**

- 6.1 Statute allows for a Member to be granted, in certain circumstances, a dispensation to participate in decision-making on a matter, notwithstanding that s/he has a Disclosable Pecuniary Interest in that matter. The provisions on dispensations are significantly changed by the Localism Act 2011. Previously, a member who had a prejudicial interest could apply to the Standards Committee for a dispensation. In future, a dispensation will be able to be granted in the following circumstances.
 - That so many members of the decision-making body have DPIs in a matter that it
 would "impede the transaction of the business". In practice this means that the
 decision-making body would be inquorate as a result;
 - That, without the dispensation, the representation of different political groups on the body transacting the business would be so upset as to alter the outcome of any vote on the matter. This assumes that members are predetermined to vote on party lines on the matter, in which case, it could be inappropriate to grant a dispensation to enable them to participate.
 - That the authority considers that the dispensation is in the interests of persons living in the authority's area;
 - That without a dispensation, the Mayor (or where the Cabinet is discharging executive functions on behalf of the Mayor, sufficient members of the Cabinet) would be unable to participate on this matter. It will be necessary to make provision in the scheme of delegations from the Mayor to cover this, admittedly unlikely, eventuality); or
 - That the authority considers that it is otherwise appropriate to grant a dispensation.
- 6.2 Any grant of a dispensation must specify how long it lasts for, up to a maximum of 4 years.
- 6.3 The Local Government Act 2000 required that dispensations be granted by Standards Committee. The Localism Act gives discretion for this power to be delegated. The Council agreed that dispensation requests should be subject to Member oversight. However, such requests require a swift resolution and there is a need for consistency in their consideration.
- 6.4 The Council therefore agreed that a Dispensations Sub-Committee comprising three members of the Standards Advisory Committee should be established to be

convened urgently as required to consider any dispensation request(s) by the Mayor, any Councillor or co-opted member.

7. DECISIONS OF THE COUNCIL, 18TH JUNE 2012

- 7.1 The Council Meeting on 18th June 2012 adopted the following documents with effect from 1st July 2012:-
 - The new Code of Conduct for Members (attached at Appendix 'A');
 - The terms of reference of the new Standards Advisory Committee (Appendix 'B'); and
 - The arrangements for dealing with complaints of a breach of the new Code of Conduct (Appendix 'C')

7.2 In addition the Council agreed:-

- That the Monitoring Officer be authorised to make arrangements to advertise for, and together with an Appointments Panel drawn from the Standards Advisory Committee in accordance with proportionality to take the necessary action to appoint, an Independent Person and a reserve Independent Person, whose appointments shall be confirmed by the Council.
- That the existing Independent Chair of the Standards Committee, Mr Barry
 O'Connor, be appointed as the 'Independent Person' under the new arrangements,
 to serve until the completion of the recruitment process to that position;
- That the current Independent Members of the Standards Committee, with the exception of the Independent Chair, be appointed as co-optees to the new Standards Advisory Committee (total six members);
- That consequent on his appointment as the interim Independent Person, Barry O'Connor be not appointed at this stage as a co-opted member of the new Standards Advisory Committee but that he be invited to attend meetings of that Advisory Committee as an observer; and
- That the Monitoring Officer have authority to convene a Dispensations Sub-Committee of the Standards Advisory Committee, to consider and advise on applications from the Mayor, any Member or co-opted member for dispensations from the restrictions on participation in any matter in which there is a Disclosable Pecuniary Interest.

1. INTRODUCTION

1.1 Tower Hamlets Council has adopted this Code of Conduct for Members in accordance with the Localism Act 2011. The Code will assist the authority in providing excellent local government for the people of the borough. This Code of Conduct applies to the Mayor and all Members and Co-opted Members of the authority or any of its committees or sub-committees and it is your responsibility to comply with the provisions of this Code.

1.2 Tower Hamlets' Code of Conduct

(a) Any alleged breach of the provisions of the Code of Conduct by a Member or co-opted Member of the authority shall be dealt with in accordance with the arrangements set out in Appendix A to this Code.

1.3 Additional Codes and Protocols

- (a) The Council has approved the following additional Codes and Protocols:
 - Planning Code of Conduct
 - Licensing Code of Conduct
 - Member/Officer Protocol
 - Employees' Code of Conduct

This Code should be read in conjunction with these Codes and Protocols that have been adopted by the Council as supplementary guidance for Members and officers. These Codes and Protocols do not form part of the Code of Conduct but Members and officers are required to comply with their provisions.

- (b) Any failure by the Mayor, a Member or co-opted member to comply with these additional Codes and Protocols may be investigated in accordance with the arrangements set out at Appendix A to this Code
- (c) Any failure by an officer to comply with these additional Codes and Protocols will be referred to the relevant Corporate Director and where appropriate disciplinary action may be taken.

1.4 General Principles of Conduct

You should read this Code together with the general principles prescribed by the Localism Act 2011. These principles are listed below and they should guide all aspects of your conduct as a member of the authority:-

- (a) selflessness;
- (b) integrity;
- (c) objectivity;
- (d) accountability;
- (e) openness
- (f) honesty; and
- (g) leadership.

1.5 Further Guidance

If you require further guidance on the application or interpretation of the provisions of this Code of Conduct or any of the additional Codes and Protocols approved by the Council you should contact the Monitoring Officer.

2. SCOPE AND INTERPRETATION

- **2.1** In this Code 'meeting' means any meeting of:
 - (a) the authority;
 - (b) the executive of the authority (currently known as the cabinet);
 - (c) any of the authority's or its cabinet's committees, sub-committees, joint committees, joint sub-committees, panels, or area committees
- **2.2** In this Code 'Member' includes the Mayor, a co-opted Member and an appointed Member.
- **2.3** Subject to paragraph 2.4, you must comply with this Code whenever you:
 - (a) conduct the business of the authority (which, in this Code, includes the business of the office to which you are elected or appointed); or

(b) act, claim to act or give the impression you are acting as a representative of the authority;

and references to your official capacity are construed accordingly.

- **2.4** Where you act as a representative of the authority:
 - (a) on another relevant authority (as defined by section 49(6) of the Local Government Act 2000), you must, when acting for that other authority, comply with any code of conduct adopted by that other authority;
 - (b) on any other body, you must, when acting for that other body, comply with this Code of Conduct, except and insofar as it conflicts with any other lawful obligations to which that other body may be subject.

3. GENERAL OBLIGATIONS

3.1 You must treat others with respect.

3.2 You must not:

- (a) do anything which may cause the authority to breach the Equality Act 2010 or any other equality enactment;
- (b) bully any person;
- (c) intimidate or attempt to intimidate any person, including anyone who is or is likely to be:
 - (i) a complainant,
 - (ii) a witness, or
 - (iii) involved in the administration of any investigation or proceedings,

in relation to an allegation that a Member (including yourself) has failed to comply with his or her authority's code of conduct;

- (d) act in a threatening manner towards any person;
- (e) do anything which compromises or is likely to compromise the impartiality of those who work for, or on behalf of, the authority.

3.3. You must not:

- (a) prevent another person from gaining access to information to which that person is entitled by law.
- (b) disclose information given to you in confidence by anyone, or information acquired by you which you believe, or ought reasonably to be aware, is of a confidential nature, including information that is exempt from publication in

accordance with Part 1 of Schedule 12A of the Local Government Act 1972 ('Part 2' agenda items), **except** where:

- (i) you have the consent of a person authorised to give it; or
- (ii) you are required by law to do so; or
- (iii) the disclosure is made to a third party for the purpose of obtaining professional advice provided that the third party agrees not to disclose the information to any other person; or
- (iv) the disclosure is reasonable **and** in the public interest **and** made in good faith **and** in compliance with the reasonable requirements of the authority.
- 3.4 You must not conduct yourself in a manner which could reasonably be regarded as bringing your office or the authority into disrepute.
- **3.5** You:
 - (a) must not use or attempt to use your position as a Member improperly to confer on or secure for yourself or any other person, an advantage or disadvantage;
 - (b) must, when using or authorising the use by others of the resources of the authority:
 - (i) act in accordance with the authority's reasonable requirements;
 - (ii) ensure that such resources are not used improperly for political purposes (including party political purposes);
 - (c) must have regard to any applicable Local Authority Code of Publicity made under the Local Government Act 1986.
 - 3.6 When reaching decisions on any matter you must have regard to any relevant advice provided to you by:
 - (a) the authority's Chief Finance Officer; and/or
 - (b) the authority's Monitoring Officer,

where they are acting pursuant to their statutory duties.

3.7 You must give reasons for all decisions in accordance with any statutory requirements and any reasonable additional requirements imposed by the authority.

4. INTERESTS

- **4.1** You have an interest in any business of the authority where either:
 - (a) it relates to or is likely to affect:
 - (i) any body of which you are a member or in a position of general control or management and to which you are appointed or nominated by the authority;

- (ii) any body
 - (aa) exercising functions of a public nature;
 - (bb) directed to charitable purposes; or
 - (cc) one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union),

of which you are a member or in a position of general control or management;

- (iii) any employment or business carried on by you;
- (iv) any person or body who employs or has appointed you;
- (v) any person or body, other than a relevant authority, who has made a payment to you in respect of your election or any expenses incurred by you in carrying out your duties;
- (vi) any person or body who has a place of business or land in the authority's area, and in whom you have a beneficial interest in a class of securities of that person or body that exceeds the nominal value of £25,000 or one hundredth of the total issued share capital (whichever is the lower);
- (vii) any contract for goods, services or works made between the authority and you or a firm in which you are a partner, a company of which you are a remunerated director, or a person or body of the description specified in paragraph (vi);
- (viii) the interests of any person from whom you have received a gift or hospitality with an estimated value of at least £25;
- (ix) any land in the authority's area in which you have a beneficial interest;
- (x) any land where the landlord is the authority and you are, or a firm in which you are a partner, a company of which you are a remunerated director, or a person or body of the description specified in paragraph (vi) is, the tenant;
- (xi) any land in the authority's area for which you have a licence (alone or jointly with others) to occupy for 28 days or longer; or
- (b) a decision in relation to that business might reasonably be regarded as affecting your well-being or financial position or the well-being or financial position of a relevant person to a greater extent than the majority of other council tax payers, ratepayers or inhabitants of the electoral division or ward, as the case may be, affected by the decision.

- **4.2** In paragraph 4.1(b), a relevant person is:
 - (a) a member of your family or any person with whom you have a close association; or
 - (b) any person or body who employs or has appointed such persons, any firm in which they are a partner, or any company of which they are directors;
 - (c) any person or body in whom such persons have a beneficial interest in a class of securities exceeding the nominal value of £25,000; or
 - (d) any body of a type described in paragraph 4.1 (a) (i) or (ii).

5. DISCLOSABLE PECUNIARY INTERESTS

5.1 A Disclosable Pecuniary Interest (DPI) is defined in law as a pecuniary interest of any of the following descriptions:-

Subject	Prescribed description
Employment, office, trade, profession or vacation	Any employment, office, trade, profession or vocation carried on for profit or gain.
Sponsorship	Any payment or provision of any other financial benefit (other than from the relevant authority) made or provided within the relevant period in respect of any expenses incurred by M in carrying out duties as a member, or towards the election expenses of M. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
Contracts	Any contract which is made between the relevant person (or a body in which the relevant person has a beneficial interest) and the relevant authority— (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.
Land	Any beneficial interest in land which is within the area of the relevant authority.

Licences

Any licence (alone or jointly with others) to occupy land in the area of the relevant authority for a month or longer.

Corporate tenancies

Any tenancy where (to M's knowledge)—

- (a) the landlord is the relevant authority; and
- (b) the tenant is a body in which the relevant person has a beneficial interest.

Securities

Any beneficial interest in securities of a body where—

- (a) that body (to M's knowledge) has a place of business or land in the area of the relevant authority; and
- (b) either—
- (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
- (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

NB: A Member's DPIs include his/her own relevant interests and also those of his/her spouse or civil partner; or a person with whom the Member is living as husband and wife; or a person with whom the Member is living as if they were civil partners; if the Member is aware that that other person has the interest.

- 5.2 Subject to paragraphs 5.3 to 5.6, where you have a Disclosable Pecuniary Interest in any business of the authority which is not included in the Member's register of interests and you attend, in any capacity, a meeting of the authority at which the business is considered, you must disclose to that meeting the existence and nature of that interest at the commencement of that consideration, or when the interest becomes apparent; and must within 28 days notify the Monitoring Officer of the interest for inclusion in the register.
- **5.3** Paragraph 5.2 only applies where you are aware or ought reasonably to be aware of the existence of the interest.

- Where you have an interest but, by virtue of section 9, sensitive information relating to it is not registered in the authority's register of members' interests, you must indicate to the meeting that you have a personal interest, but need not disclose the sensitive information to the meeting.
- 5.5 Subject to paragraph 7.1 (b), where you have an interest in any business of the authority and you have made an executive decision in relation to that business, you must ensure that any written statement of that decision records the existence and nature of that interest.
- 5.6 In this Code 'executive decision' is to be construed in accordance with any regulations made by the Secretary of State under section 22 of the Local Government Act 2000.

6. INTERESTS ARISING IN RELATION TO OVERVIEW AND SCRUTINY COMMITTEES

- You have an interest in any business before an overview and scrutiny committee of the authority (or of a sub-committee of such a committee) where:
 - (a) that business relates to a decision made (whether implemented or not) or action taken by the Mayor or the authority's cabinet or another of the authority's committees, sub-committees, joint committees or joint sub-committees: and
 - (b) at the time the decision was made or action was taken, you were the Mayor or a member of the cabinet, committee, sub-committee, joint committee or joint sub-committee mentioned in paragraph (a) and you were present when that decision was made or action was taken.

7. EFFECT OF DISCLOSABLE PECUNIARY INTERESTS ON PARTICIPATION AT MEETINGS

- **7.1** Subject to paragraph 7.2 where you have a DPI in any business of the authority:
 - (a) you must withdraw from the room or chamber where a meeting considering the business is being held, including from any public viewing area:
 - (i) in a case where paragraph 7.2 applies, immediately after making representations, answering questions or giving evidence;
 - (ii) in any other case, whenever it becomes apparent that the business is being considered at that meeting;
 - unless you have obtained a dispensation from the authority's Monitoring Officer following consideration by the Dispensations Sub-Committee of the Standards Advisory Committee;
 - (b) you must not exercise executive functions in relation to that business; and

- (c) you must not seek improperly to influence a decision about that business.
- 7.2 Where you have a Disclosable Pecuniary Interest in any business of the authority, or in relation to business before an Overview and Scrutiny Committee of the kind described at section 6 above, you may attend a meeting (including a meeting of the Overview and Scrutiny Committee or of a sub-committee of such a committee) but only for the purpose of making representations, answering questions or giving evidence relating to the business, provided that the public are also allowed to attend the meeting for the same purpose, whether under a statutory right or otherwise.

8. THE REGISTER OF MEMBERS' INTERESTS

- **8.1** Subject to paragraph 9, you must, within 28 days of:
 - (a) this Code being adopted by the authority; or
 - (b) your election or appointment to office (where that is later); or
 - (c) Disclosing a DPI at a meeting of the authority, its executive or any committee or sub-committee;

Notify the Monitoring Officer in writing, for inclusion in the authority's Register of Members' Interests, of details of your Disclosable Pecuniary Interests and other interests that fall within any of the categories mentioned in paragraph 4.1 (a).

8.2 Subject to paragraph 9, you must, within 28 days of becoming aware of any new DPI or change to any interest registered under paragraph 8.1, register details of that new interest or change by providing written notification to the authority's Monitoring Officer.

9. SENSITIVE INFORMATION

- 9.1 Where you consider that the information relating to any of your interests is sensitive information, and the authority's Monitoring Officer agrees, you need not include that information when registering that interest, or, as the case may be, a change to that interest under paragraph 8.
- 9.2 You must, within 28 days of becoming aware of any change of circumstances which means that information excluded under paragraph 9.1 is no longer sensitive information, notify the authority's Monitoring Officer asking that the information be included in the authority's Register of Members' Interests.
- **9.3** In this Code, 'sensitive information' means information whose availability for inspection by the public creates, or is likely to create, a serious risk that you or a person who lives with you may be subjected to violence or intimidation.

STANDARDS ADVISORY COMMITTEE - TERMS OF REFERENCE

- Agreed by the Council on 18th June 2012
- Standards Advisory Committee established with effect from 1st July 2012

1. Standards Advisory Committee

The Council using the powers under section 102(4) of the Local Government Act 1972 have established a Standards Advisory Committee.

The Standards Advisory Committee shall have the power to create Sub-Committees in order to discharge its advisory role.

2. Composition

The Standards Advisory Committee shall be comprised of Members of the Council (not including the Mayor or more than one Cabinet Member), appointed by the Council in accordance with the requirements of political proportionality; and up to seven persons who are not Members or officers of the Council or any other relevant authority (i.e. Co-opted members.)

The Co-opted member(s) will be entitled to vote at meetings under the provisions of S13 (4) (e) of the Local Government and Housing Act 1989. The Standards Advisory Committee shall be chaired by a co-opted member.

The Committee shall establish Hearings and other Sub-Committees in accordance with these terms of reference.

3. Appointment of Co-Opted Members

A person may not be appointed as a Co-opted member of the Standards Advisory Committee or one of its sub-committees unless the appointment is approved by Full Council. The term of appointment shall be for four years unless otherwise determined by Full Council or the Co-optee does not continue to fulfil any required conditions as may be determined by the Authority from time to time. Co-opted members may serve as many terms of appointment as the Council considers appropriate.

4. Role and Function

The Standards Advisory Committee has the following roles:

4.1 To recommend to the Monitoring Officer whether or not any complaint of a breach by the Mayor, a Councillor or a co-opted member of the Members Code of Conduct should be referred for investigation by the Monitoring Officer or an investigator appointed by the Monitoring Officer; and where a complaint has been subject to such investigation, to recommended whether or not the complaint should proceed to hearing. Where the Monitoring Officer considers that a complaint should not be subject to investigation or should not proceed to hearing, s/he shall

- convene an Investigation and Disciplinary Sub-Committee of the Standards Advisory Committee which shall make the final decision on the matter;
- 4.2 To receive regular quarterly reports from the Monitoring Officer on the numbers of complaints of the Code received, the decisions taken by the Monitoring Officer (in consultation with the Independent Person) on such complaints and investigation outcomes where the investigation determines there was no evidence of a failure to comply with the code or where the investigation outcome recommends a local resolution;
- 4.3 To convene a Hearings Sub-Committee of three Members of the Standards Advisory Committee comprising two of the co-opted members and one Councillor to consider any matter where the investigation finds evidence of a failure to comply with the Code and a local resolution is not possible or appropriate;
- 4.4 To make such recommendations to Council in respect of the matter as the Hearings Sub-Committee considers appropriate as a result of any matter referred including;
 - Reporting its findings to Council for information;
 - Recommending to the member's Group Leader (or in the case of ungrouped members, recommend to Council or to Committees) removal from any or all Committees or Sub-Committees of the Council:
 - Recommending to the Mayor removal from the Executive, or from particular Portfolio responsibilities;
 - Recommending the Monitoring Officer arrange training for the member;
 - Recommending removal from outside appointments to which he/she has been appointed or nominated;
 - Recommending withdrawing facilities provided to the member by the Council, such as a computer, website and/or email and Internet access;
 - Recommending excluding the member from the Council's offices or other premises, with the exception of meeting rooms as necessary for attending Council, Executive Committee and Sub-Committee meetings;
 - Recommending the Member to contact the Council via specified point(s) of contact;
- 4.5 To convene a Hearings (Appeal) Sub-Committee of at least three different Members of the Standards Advisory Committee (comprising two of the co-opted members and one Councillor) to consider any appeal against a finding of, or sanction recommended by, the Hearings Sub-Committee;
- 4.6 To receive reports on compliance with any recommendation(s) made for sanctions to be applied in respect of any member;
- 4.7 Promoting and maintaining high standards of conduct by the Mayor, Members of the Council, co-opted members including church and parent governor representatives and where the Committee considers that there may be issues of concern recommending that the Monitoring Officer considers and reports on the issues raised;

- 4.8 Assisting the Mayor, Members of the Council, co-opted members including church and other faiths and parent governor representatives to observe the Council's Code of Conduct for Members;
- 4.9 Advising the Council on the adoption or revision of the Code of Conduct for Members:
- 4.10 Monitoring the operation of the Code of Conduct for Members;
- 4.11 Advising, training or arranging to train the Mayor, Members of the Council and coopted members including church and other faiths and parent governor representatives on matters relating to the Code of Conduct for Members;
- 4.12 To act as an advisory body in respect of any matters referred to the Standards Committee by the Local Strategic Partnership (LSP) or Community Forums in respect of probity issues arising out of the codes and protocols applicable to relevant members of the LSP and Community Forums as set out in the Community Forum handbook and as may be amended from time to time;
- 4.13 To advise on allegations of Member breaches of the Protocols set out in the constitution as may be referred to the Committee by the Monitoring Officer and to make recommendations with regard to such allegations as maybe so referred;
- 4.14 Advising on local protocols for both Officer and Member governance;
- 4.15 To monitor and review Member and Officer Procedures for registering interests and declaring gifts and hospitality;
- 4.16 To receive periodic reports on the Council's Ethical Governance arrangements, on whistle blowing arrangements and complaints; and
- 4.17 As requested by the Monitoring Officer, to establish a Dispensations Sub-Committee to advise on any applications for dispensations in relation to participation at a meeting by a member with a Disclosable Pecuniary Interest.

5. Validity of proceedings

A meeting of the Standards Advisory Committee or one of its sub-committees shall only be quorate where at least three members of the Committee or sub-committee are present for its duration and such quorum must include at least one councillor and at least one co-opted member.

Part VA of the Local Government Act 1972 applies in relation to meetings of the Standards Advisory Committee or its sub-committees as it applies to meetings of the Council.

6. Hearings Sub-Committee and Hearings (Appeal) Sub-Committee

Any Hearings Sub-Committee or Hearings (Appeal) Sub-Committee shall comprise a minimum of three Members of the Standards Advisory Committee at least two of whom shall be co-opted members.

The Hearings Sub-Committee shall consider complaints referred to it that the Mayor, an elected or co-opted Member of the Council may have failed to comply with the Council's Code of Conduct for Members or local protocol where the complaint has been subject to an investigation arranged by the Monitoring Officer and shall make recommendations accordingly. The Hearings Sub Committee shall decide at the outset of the meeting whether it is in the public interest that the Hearing is held in a public or private session in accordance with relevant statutory guidance as advised by the Monitoring Officer.

The membership of the Hearings (Appeal) Sub-Committee shall not include any member who served on the Hearings Sub-Committee that considered the same complaint.

The Independent Person, or if that person is unable to act a reserve Independent Person, shall have the right to attend all meetings of the Hearings Sub-Committee or Hearings (Appeal) Sub-Committee as an observer but may not vote or participate in the decision making.

7. Attendance Requirements

In the event that any Member of the Committee does not attend three or more consecutive meetings of the Committee, the Committee may draw the attention of the Council to such non-attendance and may recommend that the member concerned be replaced on the Committee.

The Committee shall not do so without first giving the absent Member an opportunity to make representations (which may be made in writing) as to their non-attendance and any matters they wish the Committee to take into account.

8. Procedures

The Committee shall agree a set of procedures to enable it to discharge the arrangements under these Terms of Reference.

9. Confidentiality

The Committee and any of its Sub-Committees may meet in private in accordance with the relevant legislation as advised by the Monitoring Officer. Any meeting or part of a meeting that considers whether or not a complaint should be referred for investigation or, following an investigation should proceed to hearing, shall be held in private and all papers relating to that consideration shall remain confidential.

LONDON BOROUGH OF TOWER HAMLETS

ARRANGEMENTS FOR DEALING WITH COMPLAINTS OF BREACH OF THE CODE OF CONDUCT FOR MEMBERS

Effective 1st July 2012. Arrangements agreed by the Council on 18th June 2012.

- The Monitoring Officer shall be the Proper Officer to receive complaints of any failure by the Mayor, a Councillor or a co-opted member to comply with the Code of Conduct for Members. On receipt of a complaint the Monitoring Officer shall within three working days inform the subject member of the substance of the complaint on a confidential basis.
- 2. The Monitoring Officer shall ensure that the Council appoints at least one Independent Person and at least one reserve Independent Person.
- 3. Complainants must provide their name and postal address when submitting a complaint. Anonymous complaints will not be considered unless in exceptional circumstances where the Monitoring Officer decides (after consultation with the Independent Person) that the complaint raises a serious issue affecting the public interest which is capable of investigation without the need to ascertain the complainant's identity.
- 4. The Monitoring Officer shall, after consultation with the Independent Person and within ten working days of receiving the complaint (so far as practicable), determine whether a complaint merits formal investigation and arrange for such investigation. In making this determination the Monitoring Officer may at his/her discretion also consult other persons including Counsel.
- 5. In determining whether to refer a complaint for investigation, the Monitoring Officer may take into account how long has elapsed since the event(s) complained about took place and if this is more than one year, then a complaint will be rejected as out of time unless the complainant demonstrates that there are good reasons for the delay such as fresh evidence not available at the earlier date or only recently discovered.
- 6. The Monitoring Officer may refer a complaint of failure to comply with the Code to the Standards Advisory Committee or its sub-committee to recommend whether or not the complaint requires investigation where s/he feel that it is inappropriate for him/her to take the decision without seeking their advice. Where the Monitoring Officer considers that a complaint should not be subject to investigation, s/he shall convene an Investigation and Disciplinary Sub-Committee of the Standards Advisory Committee which shall make the final decision on the matter.
- 7. The Monitoring Officer will report quarterly (or less frequently if there are no complaints to report) to the Standards Advisory Committee on the number and nature of complaints received and action taken as a result. This will include details of complaints that did not require investigation so that the Committee can exercise its oversight role.

- 8. If a complaint of failure to comply with the Code is referred for investigation the Monitoring Officer shall appoint an investigator or complete the investigation him/herself. Such investigation should be completed within one month of the decision to refer the matter for investigation. The Monitoring Officer may, having consulted the Standards Advisory Committee or its sub-committee, extended this period by up to a further month where s/he feels it is necessary to ensure an adequate investigation.
- 9. The Monitoring Officer may, during the course of the investigation, seek local resolution of the matter to the satisfaction of the complainant before the investigation is concluded.
- 10. Where any investigation into a complaint of breach of the Code finds no evidence of failure to comply with the Code of Conduct, the Monitoring Officer shall within ten working days of receipt of the investigation report, consult with the Independent Person and the Standards Advisory Committee Investigations and Disciplinary Sub-Committee to confirm their agreement that the matter shall be closed without further hearing. If the Sub-Committee agree then the matter is closed. The Monitoring Officer shall provide a copy of the report and findings of the investigation which shall be kept confidential to the complainant and to the member concerned and shall report the matter as part of the quarterly report to the Standards Advisory Committee for information.
- 11. Where the investigation finds evidence of a failure to comply with the Code of conduct, the Monitoring Officer in consultation with the Independent Person, may seek local resolution to the satisfaction of the complainant in appropriate cases, with a summary report for information to Standards Advisory Committee in due course. Where such local resolution is not appropriate or not possible the Monitoring Officer shall report the investigation findings to a Hearings Sub-Committee of the Standards Advisory Committee for local hearing and recommendations. The Hearings Sub-Committee will be convened within one month of the Monitoring Officer receiving the investigation report. The Hearings Sub-Committee may sit in private after advice from the Monitoring Officer.
- 12. The Hearings Sub-Committee will advise the Monitoring Officer whether or not they consider there has been a breach of the Code and if they consider sanction is appropriate having heard the matter shall request that the Monitoring Officer prepare a report to Full Council setting out the details of the investigation, hearing and proposed sanction which may include any of the following:-
 - Recommend to the member's Group Leader (or in the case of ungrouped members, recommend to Council or to Committees) that he/she be removed from any or all Committees or Sub-Committees of the Council;
 - Recommend to the Mayor that the member be removed from the Executive, or removed from particular Portfolio responsibilities;
 - Recommend the Monitoring Officer to arrange training for the member (subject to the Members agreement);
 - Recommend remove as from all outside appointments to which the Member has been appointed or nominated;

- Recommend withdrawing facilities provided to the member by the Council, such as a computer, website and/or email and Internet access; or
- Recommend excluding the member from the Council's offices or other premises, with the exception of meeting rooms as necessary for attending Council, Executive Committee and Sub-Committee meetings (as appropriate);
- Recommend the member to contact the Council via specified point(s) of contact:
- Write to the member with their advice on the Members conduct.
- 13. In determining any recommended sanction the Sub-Committee may take into account any previous breach by the member concerned and/or their compliance with any previous sanction applied.
- 14. Where a subject member feels that a recommended sanction would cause him/her undue hardship or prevent him/her from undertaking ward duties, that Member may make representations to the Council meeting that will consider the recommendations of the Hearings Sub-Committee on the relevant complaint. Any such representations shall be notified to the Monitoring Officer within five working days of the Hearing Sub-Committee meeting.
 - 15. The recommendations of the Hearings Sub-Committee shall be published in a local newspaper in the Public Notices Section and on the Council's website as well as in the minutes of the meeting. The content of any notice to be published shall be subject to agreement by the Chair of the Hearings Sub-Committee. Following publication, a link to the notice shall remain on the front page of the Council's website for a period of one month or such other position and/or period as the Hearings Sub-Committee may recommend. The Monitoring Officer shall draft further guidance on the detailed procedures for publication of decisions as necessary.
- 16. A member who is the subject of a finding by the Standards Advisory Committee that he/she has breached the code may appeal against that finding and/or against any sanction applied. A complainant who is dissatisfied with the outcome of his/her complaint may appeal against that outcome. Any appeal under this section shall be notified in writing to the Monitoring Officer within 15 working days of the Hearings Sub-Committee recommendation being notified to the member or complainant and the Monitoring Officer shall arrange for the appeal to be heard by a Hearings (Appeal) Sub-Committee of the Standards Advisory Committee within 15 working days of receipt of the appeal. The decision of the Hearings Sub-Committee shall not be published, nor any sanctions applied, until the period allowed for an appeal has expired.
- 17. An appeal under 15 above may be made on grounds of either fact or defective procedure. The appellant must state the grounds on which the appeal is made and must provide specific reasons and any further information to support his/her appeal.
- 18. The Sub-Committee to hear any appeal under 15 above shall not include any member of the Hearings Sub-Committee that considered the investigation of the matter in question.

- 19. A member who is the subject of a complaint shall be informed of, and shall have the right to attend and/or be represented at, the hearing of the Standards Advisory Committee or any of its sub-committees that considers any matter relating to that complaint following investigation.
- 20. The timelines set out in this procedure are for guidance only and shall be observed where practicable but may be extended by the Monitoring Officer as necessary if they cannot be complied with by any relevant party due to sickness, holidays or other reasonable cause.

1. SUMMARY

1.1 This report updates the Committee on a range of matters related to Councillors' attendance at formal meetings and training events, completion of timesheets and the register of interests. Some amendments to the format and content of the report have been made and additional information included, as requested by the former Standards Committee.

2. RECOMMENDATIONS

- 2.1 That the Standards Advisory Committee:
 - (i) Note the information set out in Appendices 1, 2 and 3 in relation to Councillors' submission of timesheets, attendance at formal meetings and training events, and completion of the register of interests during the previous and current municipal years;
 - (ii) Consider whether there is a need to ask the Chair to write to any Councillor(s) in connection with any of the monitoring information; and
 - (iii) Agree to receive further monitoring reports at six monthly intervals.

3. BACKGROUND

- 3.1 Since April 2004 the former Standards Committee received regular monitoring reports on the completion of Members' timesheets and attendance by Members at Council and other formal meetings.
- 3.2 At recent meetings the Committee has discussed how to build on this good practice by incorporating additional information in the reports and presenting the information in the most suitable way to enhance transparency and accountability. In April 2009 the Committee agreed a number of proposed changes to the monitoring regime and these are incorporated in this report.

4. MEMBERS' TIMESHEETS

- 4.1 Tower Hamlets Councillors have, since April 2002, completed monthly timesheets detailing the time spent on council duties, split into categories such as surgeries, casework, attendance at meetings/external bodies etc.
- 4.2 Members' timesheets are posted on the 'Meet your Councillor' pages of the Council's website which also contain information on the ward represented, committee/external appointments, surgery arrangements, contact and other details. Councillors are personally responsible for the accuracy and timely submission of their timesheets.
- 4.3 Completion of timesheets is not a statutory requirement and does not affect the Basic and Special Responsibility Allowances paid to Members. However, the London Councils Independent Panel on the Remuneration of Councillors have emphasised the need for an accountable and transparent allowances scheme. In their 2001 report, the Independent Panel identified the tasks and responsibilities which they believed were the essential remit of a Councillor. In proposing a Basic Allowance to apply to all Councillors, they assumed a "contribution" of 40 hours per month on top of a "voluntary commitment" of 20 hours for each Member. Tower Hamlets has voluntarily developed the timesheet system to enhance transparency.
- 4.4 The Standards Committee has placed great importance on the timely and accurate completion of timesheets and the monitoring arrangements have placed Tower Hamlets at the forefront of best practice in this area as very few other local authorities have any such formal monitoring system in place. In accordance with the Committee's previous request, the table at Appendix 1 now includes, in addition to a snapshot of timesheets completed as at the date of the Standards Committee meeting, information on when each timesheet was submitted and a figure at the bottom of each column showing the average number of total hours recorded on each of the timesheets submitted in respect of that month.

The current position – completion of timesheets

- 4.5 In relation to the submission of timesheets the current position, as at 4 July 2012 and set out in Appendix 1 attached, is that 18 Members (35.3% of the total) have completed their timesheets up to and including May 2012. 21 Councillors (41.2%) are more than three months in arrears. An updated schedule will be tabled at the meeting, if necessary.
- 4.6 The Committee may wish to follow previous practice and ask the Chair to write to those Members who are significantly in arrears, drawing his/her attention to the need to maintain an up to date record.

5. MEMBERS' ATTENDANCE AT MEETINGS

- 5.1 As with timesheets, attendance at committee/panel meetings is not a statutory requirement the law simply says that if a Councillor fails to attend any Council or other qualifying meeting for a period of six months, he/she shall cease to be a Member of the local authority and it is accepted that many important Council duties take place outside formal meetings. Nevertheless, attendance at meetings to which he/she has been appointed does represent a key part of a Councillor's work and the combination of attendance and timesheet monitoring information in this report provides a useful picture of a Councillor's activity for the purpose of accountability.
- 5.2 In April 2009 the Committee asked that where a Councillor has failed to attend a formal meeting but has submitted apologies in advance, this should be noted in the report. The attached schedule has been amended to incorporate these changes.

The current position - attendance at meetings

5.3 The charts at Appendix 2 show the record of attendance by Councillors at formal constitutional meetings during the last and current municipal years (i.e. from 18th May 2011 to 15th May 2012 and 16th May to 30th June 2012).

6. MEMBERS' DECLARATION OF INTERESTS AND ATTENDANCE AT MANDATORY TRAINING EVENTS

- 6.1 The Committee has previously requested that information be included in the report on two matters that are key to Councillor accountability and ethical governance (i) Members' completion of the register of personal interests, and (ii) attendance at mandatory training events including seminars on the Code of Conduct and further specific training for Councillors appointed to the quasi-judicial committees. This information is summarised in Appendix 3 attached and further explanatory information is below:-
- 6.2 Updates to the register of Members' interests: Members are required to complete a register of their interests within 28 days of becoming a Councillor and subsequently they must notify any change to this within 28 days of becoming aware of the change. Members receive six-monthly reminders to update the register with any changes. All Councillors were advised of the requirements immediately following their election on 6 May 2010 and the attached schedule lists the date of each Councillor's latest update to their register entry.

6.3 As a matter of good practice and for the purpose of clarity, Members are asked to provide a nil return if there are no changes to register at the six-monthly reminder. However it is important to note that failure to do so would not represent a breach of the Code of Conduct.

Gifts and hospitality register

- 6.4 The Committee has previously requested information on the recording of gifts and hospitality received by Members.
- 6.5 The Code of Conduct provides that a Councillor shall have a personal interest in any business of the authority that relates to the interests of any person from whom he/she has received a gift or hospitality with an estimated value of at least £25. Any such gifts or hospitality must be registered and, if they were received during the previous three years, must be declared at any relevant meeting. Gifts and hospitality are now recorded as part of the main register of Members' interests form.
- 6.6 Attendance at training events: The Committee has also sought assurance regarding Councillors' attendance at relevant mandatory training events such as those on the Code of Conduct and the specific sessions arranged for members of the Development, Licensing and Appeals Committees and the Appointments Sub-Committee. This information is now incorporated into the schedule at Appendix 3, together with the total number of attendances at other (non-mandatory) in-house Member seminars during the year.
