This year's fund is intended to support projects which bring together residents from different backgrounds to tackle the tricky issues which can undermine the quality of day-to-day life for people in the borough.

1. Executive Summary

- 1.1 The council has once again made available the One Tower Hamlets Fund. This fund is available to local resident led organisations and resident groups to help us realise our One Tower Hamlets aspiration.
- 1.2 This year's fund is intended to support projects which bring together residents from different backgrounds to tackle the tricky issues which can undermine the quality of day-to-day life for people in the borough.
- 1.3 Successful groups or organisations will be able to demonstrate that their project:
- brings residents from different backgrounds together with service providers to tackle quality of life issues in their area
 - builds leadership within the community they are working in
- Full details of the criteria are in Appendix 2 to this report.

From the 2013 application process of the One Tower Hamlet Fund, 16 Applications have been received.

- 1.4 Details of applications received for which awards are proposed are summarised below in **Appendix 1**. Decisions on these applications are now required in order that the Council is able to meet its commitment to making grants available to successful organisations, to enable all applicants to be notified of the outcome of their applications, to enable the processing of Grant Agreements and for initial stage payments to be processed for successful applicants. No review process was provided for in the advertised scheme, given the low value of the awards.

2. Recommendations:

The Mayor is recommended to:

- 2.1 Agree the proposed awards for One Tower Hamlets Fund totalling £53,819 as set out in Appendix 1.
- 2.2 Authorise officers to issue Grant Agreements for the One Tower Hamlets Fund in line with established procedures to and implement the agreed payment and monitoring arrangements.

3. REASONS FOR THE DECISIONS

- 3.1 The decisions on proposed grant allocations are required in order that the Council is able to meet its commitment to make available to local community organisations small grants of up to £7,000 through the One Tower Hamlets Fund.
- 3.2 Once the decisions have been made, organisations that have applied can be notified of the outcome of their applications and that payments can be initiated for applications that have been recommended for funding awards.

4. ALTERNATIVE OPTIONS

- 4.1 An alternative option would be to decide not to fund any of the organisations who have applied for grants and to use the funds for other purposes, for example the larger types of project typically associated with Main Stream Grants.
- 4.2 However, because opportunities to apply for the One Tower Hamlets Fund have been widely advertised, expectations have been raised and to cancel these programmes after a number of organisations have submitted applications in good faith would lead to wide disappointment.

5. DETAILS OF REPORT

- 5.1 Now in its fourth year the One Tower Hamlets Fund is designed to strengthen cohesion and community leadership at a grassroots level. In previous years the programme has supported projects in a range of areas, including: the role of schools in promoting cohesion, strengthening relationships between different communities and the development to neighbourhood agreements.
- 5.2 In 2012-13 in final evaluation of the projects concluded that:
- Projects brought real benefits for cohesion at a local level. Nearly all the projects were able to show improvement against the Council's cohesion criteria, and strong cohesion emphasis can lead to real improvements in building community relationships and breaking down barriers.
 - Community organisations welcomed the support they received to focus on cohesion concerns such as interaction across different communities and this gave them confidence to take more leadership in facilitating and managing difficult conversations.
 - The most successful projects used innovative strategies to break down barriers and came up with innovative and effective solutions to long standing problems gently challenge others' preconceptions, leading to increased understanding and improved relations between different groups, and across ethnic and age differences in particular.

Officers have assessed 16 applications for the One Tower Hamlets Fund. 8 applications have been considered as successful. These have gone through the agreed eligibility and assessment process and awards with a total value of £46,820 proposed against a total budget of £55,500.

- 5.3 A briefing on the applications was provided to the Mayor who supported the proposed grant awards. In addition he considered the DeafPlus project and concluded that the Deaf Plus project does meet three of the 'Getting Along Together' criteria:
- Tackling myths and rumours that harm cohesion
 - Engaging with hard to reach communities and
 - Encouraging participants for onward progression,
- With support for the project to meet the general criteria of the fund. He concluded that this project should therefore be funded.
- 5.4 Therefore the proposed grant allocation will value at £53,819 against the total of £55,500.
- 5.5 Were the proposed awards to be approved, an available budget of £1,181 would remain available in this fund.
- 5.6 Application details including the organisation name, amount requested, an outline description of the event/activities for which grant is requested, the proposed award and the related rationale are set out in Appendix 1.

6. COMMENTS OF THE CHIEF FINANCE OFFICER

- 6.1 Financial implications of the recommendations under 2.1 and 2.2 above are detailed in 5.2 and 5.3 above. The allocation of £55,500 for the One Tower Hamlets Fund is provided for within the 2013/14 General Fund budgets.

7. LEGAL COMMENTS

- 7.1 The Council has various statutory powers, which enable it to provide grant funding to organisations to undertake a variety of activities including Section 1 of the Localism Act 2011 which gives the Council a general power of competence to anything that individuals generally may do unless specifically prohibited by law. This power may be used to support the giving of grants to community groups.
- 7.2 The current report deals with the award of new grant funding and the grant agreements will detail the agreed service levels. The Council will ensure it is complying with its duty under Section 3 of the Local Government Act 1999 by monitoring these agreed service levels. The duty requires best value authorities, including the Council, to "make arrangements to secure continuous improvement in the way in which its functions are exercised, having regard to a combination of economy, efficiency and effectiveness"..

- 7.3 In exercising this power, the Council should have regard to its strategy set out in its Community Plan and to the need to eliminate unlawful conduct under the Equality Act 2010, the need to advance equality of opportunity and the need to foster good relations between persons who share a protected characteristic and those who don't. Information is provided in the report which is relevant to these considerations.

8. ONE TOWER HAMLETS CONSIDERATIONS

- 8.1 The contribution of Third Sector organisations to delivering One Tower Hamlets is explicitly recognised in the Council's Third Sector Strategy. Organisations play a key role in delivering services that address inequality, improve cohesion and increase community leadership: the deliveries of these services are real examples of 'One Tower Hamlets' in practice.
- 8.2 The opportunities offered through the One Tower Hamlets Fund play a key role in strengthening community cohesion at a local level and therefore delivering the aims of One Tower Hamlets.

9. SUSTAINABLE ACTION FOR A GREENER ENVIRONMENT

- 9.1 Aspects of the recommended projects for funding support the spirit of SAGE. The Council as a funder of third sector proposals that meet these priorities assists in the implementation of the strategic aims of SAGE along with its community and voluntary sector partners.

10. RISK MANAGEMENT IMPLICATIONS

- 10.1 A number of different risks arise from any funding of external organisations.
- 10.2 The key risks are:
- The funding may not be fully utilised i.e. allocations remain unspent or outcomes are not maximised;
 - The funding may be used for purposes that have not been agreed e.g. in the case of fraud;
 - The organisations may not be able to secure additional funding necessary to deliver the agreed activities;
 - The organisation may not have the capacity to achieve the outputs and outcomes required.

11. CRIME AND DISORDER REDUCTION IMPLICATIONS

11.1 The services that will be provided through these funding streams cover a broad spectrum of activities, some of which are key drivers in contributing to the reduction in crime and disorder, in particular, improving community cohesion.

12. EFFICIENCY STATEMENT

12.1 The proposed funding priorities which are clearly linked to delivering outcomes as set out in the Strategic Plan and Community Plan will deliver better outcomes for local people within existing resources, through for example:

- Giving priority to organisations and schemes, that promote social inclusion by reducing social exclusion
- Supporting service providers who deliver cost effective services that benefit the local community and meet the needs of the area.

<u>4.</u>	Funding should be used to bring people together to develop a neighbourhood project; the core costs of an organisation or the cost of delivering services fall outside the scope of this fund.
<u>5.</u>	Organisation has a Management Committee or Board which has Tower Hamlets local representation.
<u>6.</u>	Organisation has an Equality and Diversity policy which sets out how the organisation and services will be provided and how the organisation will abide by anti-discriminatory legislation.
<u>7.</u>	Successful applicants are expected to get involved with the evaluation of the programme which will run in parallel with projects being developed.

- 6.1 Financial implications of the recommendations under 2.1 and 2.2 above are detailed in 5.2 and 5.3 above. The allocation of £55,500 for the One Tower Hamlets Fund is provided for within the 2013/14 General Fund budgets.

7. LEGAL COMMENTS

- 7.1 The Council has various statutory powers, which enable it to provide grant funding to organisations to undertake a variety of activities including Section 1 of the Localism Act 2011 which gives the Council a general power of competence to anything that individuals generally may do unless specifically prohibited by law. This power may be used to support the giving of grants to community groups.
- 7.2 The current report deals with the award of new grant funding and the grant agreements will detail the agreed service levels. The Council will ensure it is complying with its duty under Section 3 of the Local Government Act 1999 by monitoring these agreed service levels. The duty requires best value authorities, including the Council, to "make arrangements to secure continuous improvement in the way in which its functions are exercised, having regard to a combination of economy, efficiency and effectiveness" ..

- 7.3 In exercising this power, the Council should have regard to its strategy set out in its Community Plan and to the need to eliminate unlawful conduct under the Equality Act 2010, the need to advance equality of opportunity and the need to foster good relations between persons who share a protected characteristic and those who don't. Information is provided in the report which is relevant to these considerations.

8. ONE TOWER HAMLETS CONSIDERATIONS

- 8.1 The contribution of Third Sector organisations to delivering One Tower Hamlets is explicitly recognised in the Council's Third Sector Strategy. Organisations play a key role in delivering services that address inequality, improve cohesion and increase community leadership: the deliveries of these services are real examples of 'One Tower Hamlets' in practice.
- 8.2 The opportunities offered through the One Tower Hamlets Fund play a key role in strengthening community cohesion at a local level and therefore delivering the aims of One Tower Hamlets.

9. SUSTAINABLE ACTION FOR A GREENER ENVIRONMENT

- 9.1 Aspects of the recommended projects for funding support the spirit of SAGE. The Council as a funder of third sector proposals that meet these priorities assists in the implementation of the strategic aims of SAGE along with its community and voluntary sector partners.

10. RISK MANAGEMENT IMPLICATIONS

- 10.1 A number of different risks arise from any funding of external organisations.
- 10.2 The key risks are:
- The funding may not be fully utilised i.e. allocations remain unspent or outcomes are not maximised;
 - The funding may be used for purposes that have not been agreed e.g. in the case of fraud;
 - The organisations may not be able to secure additional funding necessary to deliver the agreed activities;
 - The organisation may not have the capacity to achieve the outputs and outcomes required.

11. CRIME AND DISORDER REDUCTION IMPLICATIONS

11.1 The services that will be provided through these funding streams cover a broad spectrum of activities, some of which are key drivers in contributing to the reduction in crime and disorder, in particular, improving community cohesion.

12. EFFICIENCY STATEMENT

12.1 The proposed funding priorities which are clearly linked to delivering outcomes as set out in the Strategic Plan and Community Plan will deliver better outcomes for local people within existing resources, through for example:

- Giving priority to organisations and schemes, that promote social inclusion by reducing social exclusion
- Supporting service providers who deliver cost effective services that benefit the local community and meet the needs of the area.

<u>3.</u>	Applicant organisation must have a bank or building society account which has at least 2 signatories from the Management Committee or Board of trustees. <i>(Resident groups without a bank or building society account are asked to partner with a local organisation which does have a bank account and are willing to be accountable for the project).</i>

<u>4.</u>	Funding should be used to bring people together to develop a neighbourhood project; the core costs of an organisation or the cost of delivering services fall outside the scope of this fund.
<u>5.</u>	Organisation has a Management Committee or Board which has Tower Hamlets local representation.
<u>6.</u>	Organisation has an Equality and Diversity policy which sets out how the organisation and services will be provided and how the organisation will abide by anti-discriminatory legislation.
<u>7.</u>	Successful applicants are expected to get involved with the evaluation of the programme which will run in parallel with projects being developed.
