#### **EXECUTIVE SUMMARY**

This report seeks a decision with regards to the consideration of grants to Voluntary and Community Organisations in relation to the Council's Emergency Funding Scheme.

One application was received in this period (Phase 9, July 2017) requesting total funding of £14,150. The application has been assessed on its individual merit against the agreed emergency funding criteria, approved at the Commissioners Decision Making Meeting on 27 September 2016. Recommendations have been made accordingly.

The report was considered at the Grants Determination Sub Committee Pre Agenda Meeting which was held on 18<sup>th</sup> August 2017. Due to the urgency of the decision, at the Mayor's request, it was agreed that this should progress as an Individual Mayoral Decision. This decision was made mindful of the fact that the Shuffle Festival was due to be held on 26<sup>th</sup> and 27<sup>th</sup> August 2017 and consequently the outcome of the application for Emergency Funding is urgent.

#### 1. **EXECUTIVE SUMMARY**

- 1.1 This report seeks a decision with regards to the consideration of grants to Voluntary and Community Organisations in relation to the Council's Emergency Funding Scheme.
- 1.2 One application was received in this period (Phase 9, July 2017) requesting total funding of £14,150. The application has been assessed on its individual merit against the agreed emergency funding criteria, approved at the Commissioners Decision Making Meeting on 27<sup>th</sup> September 2016. Recommendations have been made accordingly.

#### 2. RECOMMENDATIONS

- 2.1 The mayor is recommended to:
  - i. Approve the officer recommendation not to award emergency funding based on the analysis set out in paragraph 5.3 of this report.

#### 3. REASONS FOR THE DECISIONS

3.1 The decision is required in order to enable officers to advise the organisation making the application and where appropriate, to prepare Grant Offer Letters and enter into contractual arrangements with the organisation.

#### 5. DETAILS OF REPORT

- 5.1 Historically, the Council had emergency funding arrangements in place enabling local voluntary and community organisations to apply for what was often referred to as life-and-limb support. The current Emergency Funding Scheme was approved by the previous Executive Mayor following publication of his decision on 23 October 2014. This followed a detailed report on the need to re-introduce a scheme which was presented to the Corporate Grants Programmes Board in September 2014. The Scheme was established with a one-off budget allocation of £250,000. The maximum available grant is £20,000 (within a rolling 12-month period). The criteria and process for the Emergency Funding however was revised by Commissioners at their meeting on the 27<sup>th</sup> September 2016.
- 5.2 To date 19 awards have been made over 8 phases totalling £167,606. Two organisations who were awarded a loan were either no longer eligible for funding or declined the offer, these are also detailed below. The available budget remaining is £82,394. The table below summarises the current financial position of the Emergency Fund.

- 5.4 The application was assessed to establish the extent to which it meets the agreed Emergency Funding criterion. The application together with the completed eligibility checklist is attached in Appendix A.
- 5.5 Although the organisation doesn't receive funding from the Council, the Council has been keen to support the Festival where possible and this is reflected in its in-kind support for the delivery of the Festival which amounts to at least £20,100, a breakdown of this is included below:

5.6 In addition to the above the Council has also written to the Shuffle Festival to offer further support, including exploring other alternative funding sources. Through the Council's Business Rates database we have also identified over 330 businesses in the E3 area which could be contacted for sponsorship, the Council has notified the organisation that it is happy to share this information with them.

#### 6. <u>COMMENTS OF THE CHIEF FINANCE OFFICER</u>

6.1 There are no direct financial implications arising from this report.

#### 7. **LEGAL COMMENTS**

- 7.1 The Council has a duty under the Local Government Act 1999 to make arrangements to secure continuous improvement in the way in which its functions are exercised, having regard to a combination of economy, efficiency and effectiveness. This is referred to as the Council's best value duty. Best Value considerations have also been addressed in section 9 of the report.
- 7.2 Applying this duty to grants, the Council must operate a fair and open application procedure to process a request to obtain funding. Requests for grant funding should ordinarily be measured against a predetermined set of criteria and the criteria themselves must be fair and transparent. The grant agreement should include a clear monitoring process against defined parameters in order for the Council to demonstrate either: that delivery is in line with the application and, therefore, the grant achieved its purpose; or provide clear delineation where outcomes were not achieved and the reasons for such failure are apparent. Monitoring should therefore include measuring performance against the expected outcomes.
  - 7.3 This report advises the mayor of one (1) application for grants from Voluntary and Community Organisations for the Council's Emergency Funding. These grants are discretionary and the applications have been assessed on their individual merit against the agreed emergency funding criteria, approved at the Commissioners Decision Making Meeting on 27<sup>th</sup> September 2016. In this case, the recommendation is to refuse the application for the reasons as set out in the table at paragraph 5.3 of the report.

#### 8. ONE TOWER HAMLETS CONSIDERATIONS

8.1 The Council's support of the voluntary and community sector through grants contributes to the delivery of One Tower Hamlets priorities and objectives.

Please explain why your organisation has a financial emergency (*This textbox can be expanded to provide as much information as required*)

Shuffle is a not-for-profit community arts and regeneration organisation that has been running in LBTH since 2013. Shuffle's main event is Shuffle Festival, held annually in and around Tower Hamlets Cemetery Park, bringing unique and cutting edge arts, film and performance to Tower Hamlets. The Festival's events are either free or highly subsidised for local people and 50% of the audience is from the immediate locality of E3, E2 and E1 postcodes. As an organisation Shuffle's aim is to promote unused or underused public space and to make cultural activities inclusive and accessible to all. Shuffle has worked specifically with communities in Mile End since its inception in 2013.

Shuffle is run by a small team of committed young professionals and a wider group of volunteers. Shuffle exists on a very small budget, made up mostly of 'in kind' donations of equipment from local businesses. The feast for 500 local residents is funded by Canary Wharf Group, Artists Fees and commissions by The Arts Council and our cinemas screens set-up by Mubi. Shuffle receives no funding from Tower Hamlets Council. As well as improving access to the arts in Tower Hamlets, we have also done a considerable amount of work towards improving generational, religious and socio-economic relationships in the area through our engagement with local individuals and groups as well as a yearly theme that is socially and political relevant e.g. Movement Migration and Place (2015), Gods, Idols, Light (2016) and Public/Private (2017)

In spite of our hard work, which we feel is necessary in a climate of reduced public funds to the arts, as well as a project that we feel is in-line with the council's own 'Community Plan', we have been burdened with specific barriers and costs to our organisation which, unless covered by this fund, will make it impossible to continue our activities this year. We are therefore applying for assistance through the Emergency Fund in order to cover costs lost due to the 3-month period of venue suspension, lost projects and reduced operations, as well as the increased costs incurred to meet the council's event management conditions by employing external consultants.

#### The following issues have resulted in a financial emergency for our organisation:

#### 1. Financial Loss from Council Action

In November 2016 a number of miscommunications and misunderstanding between Shuffle and LBTH resulted in applications to use space in Tower Hamlets to be rejected and a letter being sent from the Arts, Parks and Events department which explained that Shuffle were no longer able to use public land for the foreseeable future. It was eventually agreed by senior elected officials including Mayor John Biggs and Deputy Mayor, Rachel Saunders, that this letter was not to be legally binding, and the decision was overturned. The termination of our ability to use public space in Tower Hamlets resulted in a 3-month pause in our work, which in turn led us to cancel various projects, including a collaborative 10-day event with Queen Mary University based on the history of Tower Hamlets Cemetery Park, leading to loss of pubic engagement and income, as well as damage to our reputation and staff morale as staff were unable to be paid for work completed.

#### 2. Health and Safety Improvements

This year we have been asked by LBTH to employ external event managers to improve event health and safety. We have employed a company to do this to meet this condition, however we do not have the funds to pay their already reduced rate. This work includes writing documentation including in Event Management Plan, and employing a freelance site manager.

Without this support Shuffle Festival cannot happen in 2017 and Tower Hamlets will lose an important and unique community activity that will not be able to be replaced.

Please provide details of what action you have taken to date in an effort to mitigate the emergency

- 1. We have rescheduled the cancelled projects to take place within this years Shuffle Festival. This means we can continue our collaboration with Queen Mary, but the timescale and therefore public engagement and income is highly reduced.
- 2. We have employed an external event management company that has given us a discount on the requirements simulated by the borough and who have worked on other community events.

How you will ensure the organisation will be financially sustainable once emergency funding has been utilised?

The Emergency funds will make up the deficit experienced due to loss of projects and due to the employment of Event Management consultants. Prior to this we have always been financially stable. We are applying for this additional emergency funding to make sure the festival goes ahead and meets some of the limitations set by the council for the first time this year.

As a community organisation, Shuffle's own aims are strongly aligned with the council's Community Strategy and Strategic plan. We believe that Shuffle hits all of the criteria of the council's Community Strategy and Strategic plan. Though temporary in nature, the festival aims to create lasting impacts such as affordable cultural experiences, work experience for young people, an artistic platform for local groups, and an incubator for local entrepreneurs, community cohesion and a strong sense of place. The long-term strategy is to work with Tower Hamlets Council to redevelop The Lodge, Tower Hamlets Cemetery Park into an exciting new community space to ensure that our work can reach the local community all year round.

Each year Shuffle invests in an offering to the local community which includes:

#### A great place to live (Community Plan, 2015)

- FREE feast for 500 local residents
- FREE entry to site and food, drink and craft market.
- FREE tickets for under 16s
- FREE, un-ticketed events throughout the park including: music performances, artist installations, local stalls, sport and workshops
- Unlimited subsidised tickets for E3 residents, students and those on low-income benefits
- An event championed by Director and local resident Danny Boyle.
- A programme that includes appearances from world-famous film directors, actors and artists.
- High-quality cultural experience within our neighbourhood, with a cinema set-up provided in-kind by QED productions and Panalux.

#### A prosperous community (Community Plan, 2015)

- Work Experience opportunities to local school children on work-experience placement.
- Employment of local young people.
- Schools' science programme and prize in collaboration with Greenpeace.
- Commissions and opportunities for local artists to display their work alongside worldrenowned artists. We operate a policy having a majority of hyper-local artists.
- Use of local food suppliers and shops.
- Educational events for all ages and support from educational institutions Queen Mary University and The Wellcome Trust.

#### A safe and cohesive community (Community Plan, 2015)

- Open and affordable events for all ages, backgrounds and abilities, creating a true feeling of trust.
- Close working relationship with Mile End police with reported reduced crime figures over the period which we run.
- No crime committed or noise complaints.

#### A healthy and supportive community (Community Plan, 2015)

- A programme that supports those with learning and physical disabilities and mental health issues – working with accessibility organisation, Attitude is Everything, the Friends of East End Loonies and Hearing Voices network.
- Partnership in 2017 with male suicide prevention charity Campaign Against Living Miserably (CALM).
- A programme strongly committed to education on health and social cohesion. This year our science programme includes issues surrounding Air Pollution, including schools programme for 9-12 year olds.
- Food and drink that is locally sourced and healthy, including free feast.
- Collaborations with local Public Health academics from Queen Mary University and UCL.

## Creating opportunity by supporting aspiration and tackling poverty (Strategic Plan 2016-19)

- Volunteering opportunities for people all ages and abilities
- Open call to local people for free stalls and workshops at the festival to help entrepreneurs launch their own businesses
- Short Film Prize with prizes including distribution on online film platform MUBI and lighting package from Panalux.
- Discounted entry to Short Film Prize for under 25s.

#### Creating and maintaining a vibrant, successful place (Strategic Plan 2016-19)

- A programme that engages with and promotes the work of the Friends of Tower Hamlets Cemetery Park (FoTHCP) e.g nature and history walks, moth collections, beekeeping and honey collection.
- Hosting other local community and nonprofit groups e.g. Eco-therapy, Tower Hamlets Cycling Club, Friends of Tower Hamlets Cemetery Park, Southern Grove Community Centre, Friends of the Earth Tower Hamlets, Providence Row, Mile End Community Project.

  - In turn, promoting Tower Hamlets as a borough that supports events of cultural excellence.

This emergency fundamentally changes our organisation as we have lost income due to a loss of projects and have had to pay a fee to an external organisation to do a service that we usually do in house. This means we do not have the budget as the fee is beyond our very limited funds.

If we do not receive the emergency funds we will not be able to deliver the annual community arts festival. If we don't run the festival this year, our overall sustainability as an organisation will be put in jeopardy. Along with this ours and the council's reputation + relationship with the Mile End community and local partners will be seriously harmed.

Shuffle has been identified as a key stakeholder by the council for the new Community Cohesion projects in Mile End. If Shuffle is no longer able to function the council will lose an organisation that helps to reach the new projects aims of:

- Residents and other people in the community have shared values and a sense of belonging in their community
- Stronger and more positive relationships are developed between different people and different parts of the community
- People from different backgrounds have similar opportunities, such as jobs, education, access to activities etc.

None. We have never received funding from Tower Hamlets Council. However our event takes place on an important park and nature reserve owned by the borough, which is a form of 'In Kind' sponsorship.

Please detail how the emergency will affect any project or initiative currently funded by the Council.

The emergency has been created by decisions out of our control + enforced without thought to small community organisations like ours. The emergency fund will allow Shuffle to continue the annual event that benefits the local community. Shuffle Festival greatly adds to the social cohesion, cultural capital, job opportunities for young people not in education, training or employment and enhances and encourages public use of underused council assets. If the council loses Shuffle, as a festival and an organisation involved in long-term community projects, the following will be lost from the borough:

- Annual investment in the area of over £120,000 (including 'In Kind' sponsorship from local companies and groups)
- Summer job opportunities for young people
- 5 years of direct engagement with hard to reach groups in the community, including opportunities within the festival for local organisations such as 'Para-carnival' (disability arts group) + 'Friends of East End Loonies' (mental health group formerly based in Mile End Mental Health ward. These groups receive funding and support based on their participation in Shuffle Festival to a value over £15,000 which will be lost to these people in need.
- Paid work days and platform for local artists to exhibit works which adds immeasurably to the cultural life of the borough and create engagement in the Tower Hamlets Cemetery Park
- Annual ticket sales donation to 'Friends Of Tower Hamlets Cemetery Park' the organisation which manages the park on behalf of the council.
- Our involvement long-term in fundraising and initiatives in the under-used park
- The crowd-funded scheme to deliver permanent community space in 'The Lodge' and the support of 350 local people who have given to this project. This would be a shame considering the council has just launched a crowd-funding initiative with Space-hive and this has been one of the most successful projects to date and has the goodwill of many people behind it.

- Students from local schools and colleges who work with us to gain experience in the creative industries and paid positions over the summer will no longer have jobs. This includes young people not in education, training or employment (NEED) and many from the local social housing estates.
- Local families will not be able to attend an event that has been running for 5 years, and will be hugely disappointed
- The local free village feast for 500 people will not go ahead
- <sup>75</sup> Local artists commissions will be cancelled
- 13 free children's workshops will be cancelled
- All our films with our wide ranging diversity of stories from different cultures (including Persian, Nigerian, Bengali, Arabic, French, Dutch and Turkish will be cancelled
- All the staff costs we have incurred to date will go to waste, including for the period in which our organisation was ceased by unauthorised actions from Arts, Parks and Events, and we will need to incur them back off the council.
- Queen Mary Exhibition 'Defending The Wild City' will not go ahead and the rest of this funding towards this project will be lost, and will need to be reimbursed.
