Statement

1. I am [REDACTED] and I am employed by The [REDACTED].
2. I was instructed by [REDACTED] to attend Health One, 66 Middlesex Street, London E1 7EZ, in order to conduct a test purchase task on behalf of the London Borough of Tower Hamlets.
3. At approximately 11:11 hrs on the 07/06/2017 I visited Health One, 66 Middlesex Street, London E1 7EZ.
4. Upon entering the premises I was greeted by two females who appeared to be Asian and were wearing skirts. I was asked if I would like a massage and told it would be £30 for a 30-minute massage or £50 for a 60-minute massage. I attempted to pay by card but the machine was not working.

I then exited the premises to use a cash machine and returned with £50 which I handed to a female in black shorts and a black top to pay for the 60-minute massage. She then led me to a room downstairs and asked if I had been there before, I confirmed that I had not.

The female then told me to take off my clothes and lie down and that she would be coming back. I asked if I should just take my top off and she replied "You can take off everything if you like." She then exited the room.

I undressed down to my underwear and then lay on the bed. Upon her return, the female asked why I had kept my underwear on and what kind of massage I would like. I asked what the options were and she stated "Thai, Chinese, Relaxation", I chose a Thai Massage.

During the massage the female spoke about sex and on one occasion stated "Someone who will throw me on the bed and whip me when I'm bad." Whilst massaging my legs she asked me "Are you thinking of me?"

Towards the end of the massage she turned off the lights and used a mobile phone to light the room. She then asked me if I had ever had a "sexy massage". I asked her what this was and she laughed, placed her hand over my genitals and repeated again "Sexy massage" and went on to state that it was an extra cost and cash only. I declined the offer.

At the end of the massage she told me to come back again and to bring more money with me. I then exited the premises at 12:28 hrs.

5. *During this visit I was offered, without any previous suggestion by myself, services of an apparent sexual nature.*
6. *I declined all offers of such services.*
7. *I believe the facts stated in this witness statement are true.*
