- 8. The female returned to the room, after which she then positioned an air conditioning unit to face me.
- 9. The female began to remove my underwear before then stopping and stating that I should remove my underwear. I politely declined to remove my underwear and the female then began the massage.
- 10. During the initial period of the massage I would describe the female as acting in a very friendly manner. We discussed the heatwave and she complimented my physique several times. I would describe the massage as thorough and delivered to a high standard.
- 11. Over 20 minutes into the massage the female instructed me to lie on my back, which I did. The female then proceeded to massage my upper thighs. At this point the female then asked me if I would like a "happy ending". I asked what the cost of this would be, to which she replied "£30". I politely declined the offer.
- 12. After I had declined the offer, I would describe the mood as having changed. I would describe the atmosphere as now being "frosty".
- 13. The massage continued for approximately another 60 seconds, after which she stated that she had finished and immediately left the room. I did not see this female again.
- 14. I replaced my clothing and returned back upstairs. I was thanked by a different female in the reception area as I departed the premises at approximately 15:10 hrs.
- 15. During this visit I was offered, without any previous suggestion by myself, services of an apparent sexual nature.
- 16. I declined all offers of such services.
- 17. Following my visit, I immediately returned to my vehicle and wrote notes on the details of the event within a document on my work-issued smart-phone on 26/07/2018. I exhibit these as KC.003.
- 18. I believe the facts stated in this witness statement are true.
