I provide my services as a Massage therapist in China Health Spa in 2016.

I want to confirm that the company does not follow a very professional procedure.

I was never asked for sexual services but I experienced some procedures into the company very unprofessional.

-They allow customers; to be naked in the room

Free choice to choose the therapist in a funny way.

-Therapist are not using professional uniforms, they wear short dress, low-cut blouses and heels.
(majority of them Asian women)

-Some of the therapist are not certified as a qualified massage therapist (they only are in the salon to do "extra service").

-The receptionist manage bookings for their regular male clients only "nice ladies" that are not qualified.

I experienced one time I had a client waiting for a massage and when and get into the room the customer was completely naked even covered with a towel, I left the room rejecting this client and the manager swop for another therapist instead of ask for this customer leave.

Also in other occasion I was performing a treatment and the customer was having an erection during the massage expecting an extra service, I just stop the massage and the receptionist did not care about this, this was a regular client.

Their regular clients always are get ready into the room completely naked and with the wallet ready on the table.

I would like to support my statement giving some details of some employees if that can help in the investigation. Probably might be changed as it was 2 years ago.
