We're getting in touch because the smell is close to unbearable now every day. The air is thick with the smell of fat and fried chicken. We can hear that the vent is on but it does not seem to be getting rid of any of the smell at all.

We also became disturbed by the smell of faeces too. And when we went to have a closer look we were horrified to see that there is a large collection of faeces on the roof of the Chicken shop kitchen/bathroom. This is right under our terrace. There's no imaginable way this amount of waste has been produced by neighbouring cats. It looks like it has been dumped there - there is soil and gravel mixed in with it.
