Further to my statement on the 30th September 2008, I wish to add this further statement in relation to Mr Pickwicks, 70 Leman St, E1 8EU .

I continue to be a police licensing officer for Tower Hamlets. BOCU and it is in this capacity that I have met Ms Simone Pizzie the current Premises Licence Holder ( PLH )

On the 1st October 2008 I applied for an expedited review, in relation to a homophobic assault that took place in the pub on Saturday 27th September at about 3am. This took precedence over the initial Premises Review which I submitted on the 22nd of September 2008

As a result, a licensing sub committee was held on the 2nd of October at 3.30pm . The Metropolitan Police’s legal counsel, Mr Baumber, asked the committee to consider a suspension of the licence until a full review could be heard . The PLH and the DPS , Mr Mark Fraher , had been convicted of supplying Class A drugs and that Ms Pizzie had been convicted of permitting the use of her premises for the supply of cocaine.

Also , there was no DPS for the pub.

The decision of the committee was not to revoke the licence but to add a number of conditions to the licence. Mr Fraher , the DPS to be removed with immediate effect. Mr Fraher at that time was serving a prison sentence for the drug offences. All licensable activities to be **end at 1am** , Wednesday to Saturday, with the exception of live music. SIA door supervisors to be on duty from 2100 , Wednesday to Saturday. No windows to be open except for access/egress.

On the 29th October 2008 , the licensing committee met to discuss the full review of Mr Pickwicks. On this occasion the committee decided to revoke the licence. The pub has remained open until the appeal at Thames Magistrates Court.

On the 10th April 2009 at about 0459 ( CAD 1900/10 refers ) a man telephones the police to say he had been assaulted in the pub by the landlord or his staff and was knocked to the floor. The victim was disabled and had a walking stick. On speaking to a police officer, he did not wish to make any allegations but would contact the brewery to make a complaint.

On the 1st of May at about 0414 ( CAD 1097/01 refers ) , a fight occurred inside the bar. On police arrival , there was a dispute over a mobile telephone found by a drunk female. No one wished to make any allegations and the phone was returned to its owner.

I later asked Ms Pizzie why there were people in her pub at such late hours. She replied that they weren’t drinking but she often found it hard to get people to leave the bar.

On Friday 21st August 2009 , some time between 10.30pm and 2am , a victim had their I phone stolen whilst they were in

the pub. The victim states they were at a “regular karaoke function that goes on through to the early hours of the following day” CRIS 4216337/09 refers.

On the 2nd of September 2009 at about 11am I attended Mr Pickwicks with Mr Ian Wareing of LBTH Noise Team, who was investigating a noise nuisance the previous weekend. Whilst there I asked Ms Pizzie if I could conduct a drug testing procedure in her toilets, for which she agreed. I used a cocaine swab made by Crackdown Drug Testing Ltd. This swab is not evidential but will highlight the fact that cocaine is being used on the premise and for the pub owners to introduce any measures to combat the use of drugs. Removing the swap from its pouch , swipe over a surface and if cocaine is traced, the swab will immediately turn blue. I entered the male toilets with Ms Pizzie. I wiped the round metal toilet holder in the male cubicle. It immediately turned blue indicating cocaine. Ms Pizzie was shocked and said she did everything possible to stop drugs in her pub. There was no trace in the female toilet.

On the 19th September at about 2240 I again attended the pub. I again tested the toilet holder in the presence of Ms Pizzie and found a small trace of cocaine. The toilet holder has since been removed.

On the 5th of November 2009 at about 2130 I once again attended the pub and tested the male toilets. In the presence of an employee Mr Spencer Goodman, I tested the male cubicle. This time a small trace of cocaine was found on the back of the toilet seat.

In relation to the DPS , Mr Robert Madigan, I have never met him at the pub and the only contact I have had with him was when he attended Bethnal Green Police Station with Ms Pizzie to state he was going to be the new DPS.

In conclusion I believe that the revocation was the correct decision and the pub needs to be under new management with stronger enforcement of the licensing objectives.

## STATEMENT OF

Simmons Pizzie

I am Simmons Pizzie and I am the Premises Licence holder in respect of Mr Pickwicks, Leman Street, London, E1. I have been at the premises since May 2006. The Tower Hamlets determined to revoke my Premises Licence at a Hearing on the 29<sup>th</sup> October 2008. I produce the relevant documents served upon me. I produce also my Proof of Evidence before the Licensing Sub-Committee. There were letters of support also before the Committee that I would wish Tower Hamlets to produce to the Court. I also say the following: -

1. I was sentenced by Southwark Crown Court on 13<sup>th</sup> October 2008 for being concerned as supplier of Cocaine and permitting the use for the supply of Cocaine at the premises. I received a suspended sentence and 240 hours community punishment for these offences. I have subsequently carried out the community punishment and completed my sentence in that regard. I am still subject to the suspended sentence in respect of the conviction.
2. When the hearing was before the Licensing Committee, Superintendent Bending of the Police told the Committee that he feared that more incidents would occur at the Public House and that therefore there should be an immediate revocation of the premises licence. The Committee did not uphold this appeal by Police and in fact as at the date of the hearing, namely 15<sup>th</sup> December 2009, we have proved that Superintendent Bending's fears were totally misplaced.

I have tried my hardest to keep the premises run on a proper basis. I know the pub has a bad reputation but I am turning this pub around and making it a respectable establishment.

3. I can say there have been no incidents that would require the Police to criticize me for the way I have run the premises since the last hearing before the Committee in October 2008. I report any adverse occurrence to Police.

4. ~~Were I to lose my licence I would lose my livelihood and so would my employees.~~  
There were a number of letters of support before the Committee and I wish the Court to take these into account also. I have complied with the conditions imposed at the original Summary Review Hearing in that windows and doors are closed at midnight to reduce noise level; I have SIA registered door staff to work the premises from 21:00 hours until close to prevent Crime and Disorder and I have fully complied with all the objectives of the Licensing Act in respect of all matters. There is CCTV on the Premises that I have always kept in case it is required by Police.
5. Since the Hearing before the Licensing Committee at Tower Hamlets I have had no trouble that has caused the Police or the Local Authority to take action against me. I urge the Court to have regard to this when deciding on my appeal.
6. My previous manager, John Tolan, brought some persons to the pub that were a problem. I barred them. This upset John and his attitude towards me changed. John Tolan left on 14<sup>th</sup> August 2009. He had been violent towards me and smashed the CCTV. I reported this to P.C Nolan the officer who originally arrested me. He advised me that he would place this report on file in case there were further issues arising. I have a statement in support written by John Tolan which he would have given in evidence before the Court had the first Hearing have taken place. He now refuses to give evidence.
7. On 15<sup>th</sup> August 2009 I opened on a Saturday. Tower Hamlets visited through the Environmental Health Officer So far as the EHO are concerned, I allowed them to look around the premises and they wanted me to get an Acoustics report. I did arrange for an acoustics test to be carried out. I have obtained the report and given a copy to Tower Hamlets.
6. On Wednesday 19<sup>th</sup> August 2009, Tower Hamlets Officers again came down and inspected the Premises. No adverse matters were brought to my attention.

7. On 25<sup>th</sup> August 2009 Mr Waring from the Local Authority came down and visited the Premises along with PC Cruickshank. There were no untoward matters to report upon. PC Cruickshank told me that my licence was to be revoked.
8. In September P.C Cruickshank arrived, he mentioned Noise. He gave advice and I dealt with it. I have never been served with a Noise Abatement Notice from the Local Authority. PC Cruickshank also mentioned security on Monday to Friday. I have a SIA Doorman on Mondays and Tuesday as these are the less busier days and others on Wednesday to Friday. My Head doorman is Gary and he will give evidence to the Court about his observations of the premises. He has been at the Premises for 8 months.
9. P.C. Cruickshank came on 12<sup>th</sup> September 2009 at around 09:30 am and spoke to my new manager Spencer Goodman. He said to him whilst I was upstairs "is she drunk?" Mr Goodman said no. P.C. Cruickshank had with him Jane Burke, also police. They found a minute substance in the Male toilets which may have been drugs. The Female toilets were clear. We carry our regular inspections. Police asked me to remove toilet roll holders. I did this. The Police accepted that this was a minute amount. No action was taken in respect of this and it was accepted that this may have been left by someone visiting the toilets who was a customer.
10. Various visits were made by the EHO and the Police and on 12<sup>th</sup> September 2009 Tower Hamlets Officers arrived regarding a noise. Advice was given I am still dealing with the acoustics; I have a report that costs £1200.00 . My income from the premises is limited.
11. On 03<sup>rd</sup> November 2009, a strange person was in the pub. We looked out for him; he asked for the loo, we wrote this in the incident book because we found it odd. He was dressed very smartly. I suspect that this may have been an attempt to cause problems for me at the premises. I can produce the incident book.
10. On 05<sup>th</sup> November 2009, I went out. Ricardo an employee sent a text and said he called police because some guys were causing problems and had threatened Ricardo regarding the Karaoke. Police were present when I arrived. I knew these guys and if

I had been there it would have been sorted out. No action was taken against me or these people.

---

11. Also in November 2009, P.C Cruickshank and Jane Burke arrived. I believe Jane Burke is a Police Officer. Jane Burke commented that I was trying to deal with the problems and not ignoring it.
12. At all times I have tried vigorously to ensure that the premises are run properly and I believe that I have achieved this. I have worked hard to achieve the Licensing objectives under the Act.
13. I believe I have established over the past twelve months plus that I can run the Premises without any problems and I have proved to the Police and the Local Authority that I can behave responsibly and run the Premises within the Licensing Act.
14. I would strongly urge the Court to allow my appeal and to allow me to continue trading.
15. As at 17.00 Hours today, 14<sup>th</sup> December, I was told by my solicitor that the Respondent Local Authority had faxed to them an unsigned statement from PC Cruickshank. I would wish time to consider the contents of this statement and respond.

### Acoustic Report – Scope of work and fee proposal

Simone

Further to our recent discussions we are pleased to provide you with a fee proposal for an acoustic report in support of the recent investigation undertaken by Tower Hamlets Council into noise emission from the Pickwicks premises.

## Scope of work

We propose the following scope of works.

- We will measure the noise emissions to the surrounding area as a result of typical operation of Pickwicks; this will involve a noise survey just prior to closing time when a typical music event is in operation. Manual noise measurements will be taken at street level close to the nearest residential property.
- We will then repeat these measurements just after closing time when the premises has ceased operation. Once again, manual noise measurements will be taken at street level close to the nearest residential property.
- Assessment will be made of the relevant noise emissions at the nearest noise sensitive property with comparison made to the local authority's recommendations.
- Where appropriate, we will propose outline mitigation methods required to meet the local authority's recommendations; these may include changes to building fabric, ventilation systems and management strategies. Please note that this will be limited to only cursory advice and will not contain construction detail.
- We will forward a technical letter of our findings and recommendations to you upon completion.

## Fee

Our total fee for these works inclusive of equipment and travel expenses would be £685 + VAT.

This fee is valid for 30 days from the date of this letter.

Please note that any work outside of the described scope, including abortive work, would be subject to additional fee. This would be charged for on a time and expenses basis at our currently average hourly rate of £80. In the event of extra work we will try to inform you of this prior to commencement of such work.

Abortive work is charged at £100 per hour.
