To whom it may concern,

I would like to submit a positive representation on behalf of E1's licensing application for their new Site 5 project.

To begin with I would like to state that I have worked with Yuval, Oren and their team over many years as a promoter in many of their venues but my opinion should not be considered as bias, moreover I have witnessed first hand the hard work, dedication, and above all the diligence in the upholding the licensing objectives which has helped them grow their business from a tiny venue in shoreditch to one of London's leading clubbing institutions.

From the correspondence I have reviewed it appears there are issues of contention locally about apparent antisocial behaviour by patrons leaving the site. Whilst I empathise with those stakeholders affected I believe the calls to reject the license application outright are extreme by any measure, especially in the current climate. One could reasonably argue that all these concerns are easily mitigated by conditions on the license which provision for prevention of this kind of behaviour.

Our industry is on a knife edge, with many institutions such as E1 that attract tens of thousands of customers a year at risk of being wiped off the face of London's nightlife scene. We should be doing absolutely everything we can to support them at this time of crisis thus I argue that E1 should be granted their outdoor license as a matter of cultural and social importance.

I know that as a licensing department you look at things through a different lens than I do, and that is both important and understandable. But we can certainly all see that once we lose these venues they will be gone forever, and London will be worse off for it.

As previously stated I have worked closely with the E1 team (as an external promoter) over many years and with any business I have conducted with them the upholding of the licensing objectives has been a priority that trumps all others.

I cannot see any reason as to why the granting of this premises license would adversely impact the licensing objectives, moreover the increased security and vigilance in the area from E1's operations would, I propose, actually aid in the prevention of crime and public disorder.

I find it worrying that other venues similar to E1 (I believe Village Underground being another I often go to) are at risk. Both of these venues have a great vibe and are places that I feel are welcoming and safe to myself and others.

I work in the Square Mile, so live part-time in London

Newcastle being the other residence just over half my time). As you can infer from this, the job opportunities and social life London offers are key driving factors that bring in diverse and talented individuals into the city. The social aspect of this equation is important because it brings balance to an otherwise stressful lifestyle many working Londoners experience. Before COVID, I often found many pubs overcrowded due to the lack of outdoor space many establishments have, so it is nice to see establishments looking to provide outdoor space to their clientele.

I find it concerning that in these times many clubs, theatres, restaurants and similar entertainment venues are closing or on the brink of closing. E1 as a venue is one of the few clubs I enjoy in the city-it is paramount to have venues like E1 that support a broad array of music genres. One of the reasons I much prefer London's nightlife over Newcastle's is simply down to the fact I don't want to be listening to cheesy pop/dance in overcrowded clubs/bars.

I fear that this pandemic will drive many people out of London as companies look to relocate elsewhere, and many workers will follow suit if they feel the city does not offer the entertainment facilities to live a balanced lifestyle. It will only get compounded by Brexit which already was driving skilled foreign labour back to their respective countries. I've witnessed this is already happening, particularly in the Polish community where many say they have better prospects back in their home country.

As the furlough comes to an end, it is essential to support businesses like E1 who can provide jobs/employment security to those who might find themselves unemployed.

Cities like London face a daunting task reinventing themselves in the post COVID world that confronts us.
