I am writing to express my concern for the issues facing the E1 / Site 5 licence application.

It is bewildering to think that during these times of unprecedented levels of unemployment and threats to peoples' livelihoods that an application for a venue that will bring 100+ jobs is being contested.

There is a huge demand in London for venues such as this, especially now, as many remain closed due to the pandemic. London's thriving pub life is a contribution to the city's rich culture, but it is unfortunately often wrongly dismissed as a nuisance to residential areas or unsafe to the public. We need to move away from this narrative and encourage people to give back to their communities by enjoying social time in a COVID secure environment that can be managed as advised by the government, while contributing economically to the area. It is when we shun this that real issues arise and unsafe activities and gatherings occur.

I therefore believe it is the responsibility of the licencing authority to approve this application, to give people their jobs back, boost the local economy and keep us safe while socialising.

I am writing to you today to show support for the recently launched Site 5 outdoor space, located on Pennington Street, Wapping. I would like to express my belief that the venue's licence application should indeed be supported, so that local residents and those based further out can regularly enjoy a socially-distanced pub garden experience.

From what I have gathered through viewing their social media channels, I believe the pub garden setup provides local people and customers with a safe and secure drinking experience, one that enables people to enjoy themselves responsibly. I have also noticed that the site employs local food vendors to cater to customers, providing several grass-roots businesses with weekly trade. Examples of this include Story Deli, a pop-up artisan pizza company.

Should the permanent licence be granted, I believe this will have zero impact on bringing crime, disorder or public nuisance to the local area, nor do I believe it will impact public safety in a negative way. In fact, I actually feel quite the opposite, in that the venue will bring far more positive things to the wider community, including regular employment to those workers impacted by the COVID situation, as well as giving nearby residents a place to enjoy a socially-distanced pub garden experience, something that is hard to come by in the local area.

> I am emailing as a supporter of E1 London and to its community.

> These are challenging times for everyone at the moment, especially for many nightclub venues across the world; however, E1 London has remained shut during the pandemic lockdown. The safety of their clientele is paramount, yet they are left fighting for their survival until indoor venues can re-open once again at full capacity.

> As lockdown eased at the beginning of July, E1's team acquired a temporary outdoor space next to E1, intending to offer a socially distanced environment for those who were ready to interact with friends within the recommended government guidelines.

>

> A great deal of work went into turning a previously derelict space into Site 5, a COVID secure pub for outdoor drinking. Thus enabling to aid the cover costs for E1 throughout their extended period of closure. Everything possible has been altered to secure staff jobs during these times. The prospect of having Site 5 as a more permanent location over the coming months is vital. Not only to support E1's team employed on a full-time basis, (as furlough comes to an end) but also to help bring employment support to those who work on a freelance basis for E1 - their loyal bar staff, suppliers and beyond.

> Unfortunately, E1's licence application for Site 5 has been disputed by two people for motives unknown; therefore, everything at E1 London is at sheer risk. Which could mean no Site 5, no jobs for E1 staff and further down the line; no more E1 London, which would be devastating on a global standpoint.

> It means a significant amount to the E1 staff, the international DJ artists that play there, and the clubbers who find sanctuary in music, alongside many like-minded people who care deeply about the scene.

> Are you genuinely going to jeopardise over 100 employers over two people's remarks? Given the circumstances of what is going on in the world, I cannot comprehend how you can justify rejecting the application with two objections. We need to be helping each other, not making more people suffer during these tough times.
