Re: Tower Hamlets Pizza, 479 Cambridge Heath Road, London E2 9BU

Following my application for review for the above submitted on 5th July 2022 I would like to add further evidence in support of the review.

Since the review application has been made further evidence has come to light in regards to the premises and the lack of management in running the business.

Despite my review the premises continues to advertise until 04:30 hours and detail attached screenshots of the various platforms of which orders are being taken from the premises. See **Exhibit P**

I attach a Planning notice of which has been served on the premises for breaches of planning permission. See **Exhibit Q**

Complaints have continued and detail the following:

3/7/22	I just asked the people working at the pizza place about their closing time which they replied " we are open 11am to 8am".
21/9/22	They are operating illegally 7 days a week from 11am to 7 or 8am. They are 3 or 4 different businesses under one roof paying nothing in terms of tax, vat etc etc other than making our lives hell.

The Companies House information for Hamlet Pizza Ltd have altered over the period of time of which Mr. Khel is no longer in control, a Mr. Feradoon HAMIDI has taken over control. Mr. Faradoon Hamidi was sent a warning letter on 1st September 2022. We have had no response to the letter. See **Exhibit R**.

The current premises licence holder is Mr. Umid Hussain KHEL.

On 8th October 2022 and 02:15 Officers attended the premises to undertake a test purchase on site and were able to walk inside the premises and request an order, they were informed to order online and hence clearly operating beyond the timings of their licence. The premises had persons on site the smell of food being cooked and delivery riders outside indicates that they have continued to offer late night refreshment beyond their timings and ignore our warnings. See **Exhibit S** for details of the visit made.

We are undertaking a prosecution against the premise for unauthorised licensable activities of which Mr. Haroon Hamidi, Mr. Mohammed Mangal Jillani and Mr. Umid Khel have all failed to respond to any communications including invites to attend interview under PACE.

In light of all of the evidence before Members I ask for the licence to be revoked.
