- We support most people to live independently at home our residential admission numbers remain low
- We focus on the strengths of those who need our support an excellent learning and development offer supports our staff to practice with a "strengths based approach"
- Our new Tower Hamlets Connect service providing advice, information and signposting to help people stay independent and well is working well 69% of those contacting the service were helped in this way (above the target of 59%)
- A Healthy Advertising policy has been introduced to help tackle our health inequalities
- Health & Wellbeing Ambassadors had 3000 interactions with residents mostly those over 40 with existing long-term conditions or at risk of developing one
- 88% of people report that they have a positive experience of our home care services
- We supported 1150 people to quit smoking 460 people from Black, Asian & Multi Ethnic backgrounds
- We secured an additional £4.7m over 2 years to enhance substance misuse services and a new needs assessment was undertaken
