Executive Summary

This report proposes a calendar of Council, committee and other meetings for the forthcoming municipal year 2024/25.

The Calendar of Meetings was agreed at the Council meeting held on 20 March 2024. However, as is traditional, the report is also presented at the Annual Council.

The following changes should be noted from the version presented at Council in March:

- Cabinet 22 May 2024 to 16 May 2024 as previously agreed by the Mayor and Chief Executive.
- Health and Wellbeing Board 22 May to 10 June 2024; deletion of 9 July meeting to reduce overall number of meetings to normal 5 (from 6); changes to correct error and meeting clashes in earlier version; 25 to 27 Feb 2025
- Standards Advisory Committee 20 June 2024 to 26 June to avoid England Euro 2024 early evening kick-off.
- Development Committee 20 June 2024 to 12 June to avoid England Euro 2024 early evening kick-off.
- King George Fields Charity Board, various changes to correct errors and meeting clashes in earlier version: 5 June 2024 to 29 May 2024; 2nd October 2024 to 30 October 2024; 4 February 2025 to 12 February 2025; 3 April 2025 to 16 April 2025.
- Licensing Committee, first meeting moved from 6 to 13 June 2024 to align with member training.
- Licensing Sub Committee, proposed first 2024/25 meeting (23 May) removed as meeting has moved forward into 2023/24, to ensure new members can receive training prior to first hearing.
- Pensions Committee moved from 3 to 10 March 2025 and Pensions Board from 10 to 3 March 2025, to preserve the sequential order of quarterly pensions meetings.

The calendar of meetings is presented at Appendix 1 to this report

Recommendations:

The Council is recommended to:

- 1. Approve the proposed calendar of meetings for the municipal year 2024/25 as set out in Appendix 1.
- To delegate to the Monitoring Officer the authority to agree meeting dates for any new Committees or Panels that Members agree to set up subsequent to this report being presented to Council, subject to appropriate consultation with Members.

1. REASONS FOR THE DECISIONS

- 1.1 Approval of the annual calendar of meetings is a Council function. Therefore, each year Elected Members are asked to consider and approve a schedule of meetings that will enable them to deliver the business of the Council.
- 1.2 To enable the Council to be flexible and reactive to new situations and new demands, the Councils' procedure rules provide that the Monitoring Officer may call additional meetings or cancel scheduled meetings. The Monitoring Officer is also able to agree meeting dates for any new Committees or Panels that are set up subsequent to this report being presented to Council, subject to appropriate consultation with Members.

2. ALTERNATIVE OPTIONS

2.1 None are presented although it would be within the powers of Council to vary the proposed Committee meeting dates, times and frequencies as well as to change the overarching Committee structure.

3. <u>DETAILS OF THE REPORT</u>

- 3.1 The draft calendar is presented at Appendix 1 to the report. In general it follows the same pattern of meetings set in previous years in terms of frequency of meetings with the Annual Meeting in May 2024 and all meetings following on from that.
- 3.2 Cabinet and other Executive meetings will continue to take place on Wednesdays. The Overview and Scrutiny Committee (OSC) will normally meet on the Tuesday of the same week as Cabinet (see paragraph 3.7 also). This supports the role of OSC in providing Pre-Scrutiny of Executive decisions by giving OSC Members time to review the Cabinet papers before their own meeting takes place.
- 3.3 Mirroring the arrangements in recent years, an additional Cabinet meeting is scheduled for the beginning of January 2025 to consider the draft budget

- proposals before submission to the special budget OSC meeting later that month.
- 3.4 As in previous years, efforts have been made to avoid holding meetings during school holidays, with particular reference to August. However, it may be necessary for some meetings to be held especially in relation to regulatory matters. Wherever possible we have also sought to minimise the impact of meetings on Members where these clash with certain religious holidays and party conferences.
- 3.5 During Ramadan, officers will work with Committee Chair's to identify a suitable start time for the meeting taking into account the breaking of the fast. It may be necessary in some cases to organise adjournments during meetings to accommodate this. In particular for 2024/25, the Council meeting that would normally be scheduled in March 2025 has been moved to April.

Member Training Programme

3.6 The committee calendar has been developed in conjunction with the Member Training Programme to try and minimise any clashes between committee meetings and induction seminars.

Changes to OSC meeting schedule

3.7 As summarised in paragraph 3.2 and as previously reported to the 20 March Council meeting, at the request of the Chair of the Committee, Overview and Scrutiny Committee will meet on the Tuesday before Cabinet in 2024/25 (a day closer to the Cabinet meeting than in 2023/24).

4. EQUALITIES IMPLICATIONS

4.1 The calendar has taken into account religious observances and will consultant committees on earlier start times for meetings during Ramadan.

5. OTHER STATUTORY IMPLICATIONS
