

Register of Housing Landlords – self-funding paid for by an admin fee, to be made compulsory for all landlords wishing to receive Local Housing Allowance payments

Corporate Director's Comments (D&R)

Newham are currently trialling such a scheme and the advice is to 'wait and see' the results of that trial. It is not felt that such a scheme will deter the few 'problem' landlords (who are well known to the authority) and it would be better for the Council to remain focussed on dealing with those landlords using existing resources rather than introducing an administrative process which will largely impact on the majority of socially responsible landlords.

Without CLG/DWP clearance it would also not be possible to withhold payment of LHA payments for no registration.

Furthermore, the Housing Options Service is to pilot a Social Lettings Agency that sees the council acting as an intermediary service provider between private landlords and their tenants, thereby providing a tangible market alternative for prospective tenants and good landlords.

Ring-fence £1m of New Homes Bonus out of the £10million allocated to Decent Homes for insulation to reduce condensation, damp and fuel poverty

Corporate Director's Comments (D&R)

The total value the Council is already proposing to spend on insulation and energy efficiency works as part of the HRA capital programme is £30.1m, consisting of the following elements:-

Central Heating (includes radiators, boilers & communal heating)

Double Glazed windows

Front entrance doors and/or rear/balcony doors (double glazed)

£13.9m
£13.1m
£3.1m

These measures will help improve the energy efficiency of homes, which in turn should help reduce expenditure on heating. In addition, the need to replace or add roof insulation is sometimes identified whilst carrying out roofing works.

Works to carry out energy efficiency will also be carried out as part of CESP – the Community Energy Savings Programme. The CESP programme is being finalised but will total approximately £6- £7 million, and will be carried out in conjunction with the Decent Homes programme of works. These works are primarily a programme of external wall insulation, which is not in Decent Homes budgets.

The backlog capital programme consists of works that must be undertaken in order to comply with the current definition of the Decent Homes standard; ring-fencing money for insulation would mean that other parts of the statutory Decent Homes backlog programme would have to be dropped.

Members would also wish to note that any pay increase, including an unconsolidated payment is likely to have a negative impact on a number of low paid, particularly part-time staff e.g. those people who are in receipt of benefits such as working tax credits. Clearly, individual personal circumstances vary considerably e.g. hours worked, actual earnings, savings, whether employees have children, child care costs etc, so it is not possible to provide 'catch-all' advice as to a specific group of employees who may be affected.


