EXECUTIVE SUMMARY

The GLA housing development fund known as Building the Pipeline Supply included provision for funding bids for an Extensions programme in 2013 alongside the additional affordable homes to be built. The Council has been informed that it was successful in its bid for funding to support a programme of Extensions.

The grant allocation is £30,000 per property and totals £1.020 million. To secure the funding the Council must provide at least 45 additional bedrooms from 34 homes, with works to be completed by March 2016.

On 5th February 2014 Cabinet adopted a capital estimate of £3.610 million in respect of the Extensions element of the GLA Pipeline scheme. The properties for inclusion in the programme need to be assessed in terms of their suitability under building regulations, planning policy and deliverability. Properties in the programme require building surveys, party wall surveys and planning assessments. The procurement of technical advisers, consultants and contractors also needs to be undertaken. The decisions requested in this report are necessary to put in place a detailed delivery plan and take this programme forward.
