- 7. If you wish people to be able to consume alcohol on the premises, please tick 'on the premises'. If you wish people to be able to purchase alcohol to consume away from the premises, please tick 'off the premises'. If you wish people to be able to do both, please tick 'both'.
- 8. Please give information about anything intended to occur at the premises or ancillary to the use of the premises which may give rise to concern in respect of children, regardless of whether you intend children to have access to the premises, for example (but not exclusively) nudity or semi-nudity, films for restricted age groups or the presence of gaming machines.
- 9. Please list here steps you will take to promote all four licensing objectives together.
- 10. The application form must be signed.
- 11. An applicant's agent (for example solicitor) may sign the form on their behalf provided that they have actual authority to do so.
- 12. Where there is more than one applicant, each of the applicant or their respective agent must sign the application form.
- 13. This is the address which we shall use to correspond with you about this application.








Section 182 Advice by the Home Office

Relevant, vexatious and frivolous representations

- 9.4 A representation is "relevant" if it relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives. For example, a representation from a local businessperson about the commercial damage caused by competition from new licensed premises would not be relevant. On the other hand, a representation by a businessperson that nuisance caused by new premises would deter customers from entering the local area, and the steps proposed by the applicant to prevent that nuisance were inadequate, would be relevant. In other words, representations should relate to the impact of licensable activities carried on from premises on the objectives. For representations in relation to variations to be relevant, they should be confined to the subject matter of the variation. There is no requirement for a responsible authority or other person to produce a recorded history of problems at premises to support their representations, and in fact this would not be possible for new premises.
- 9.5 It is for the licensing authority to determine whether a representation (other than a representation from responsible authority) is frivolous or vexatious on the basis of what might ordinarily be considered to be vexatious or frivolous. A representation may be considered to be vexatious if it appears to be intended to cause aggravation or annoyance, whether to a competitor or other person, without reasonable cause or justification. Vexatious circumstances may arise because of disputes between rival businesses and local knowledge will therefore be invaluable in considering such matters. Licensing authorities can consider the main effect of the representation, and whether any inconvenience or expense caused by it could reasonably be considered to be proportionate.
- 9.6 Frivolous representations would be essentially categorised by a lack of seriousness. Frivolous representations would concern issues which, at most, are minor and in relation to which no remedial steps would be warranted or proportionate.
- 9.7 Any person who is aggrieved by a rejection of their representations on either of these grounds may lodge a complaint through the local authority's corporate complaints procedure. A person may also challenge the authority's decision by way of judicial review.
- 9.8 Licensing authorities should not take decisions about whether representations are frivolous, vexatious or relevant to the licensing objectives on the basis of any political judgement. This may be difficult for councillors who receive complaints from residents within their own wards. If consideration is not to be delegated, contrary to the recommendation in this Guidance, an assessment should be prepared by officials for consideration by the sub- committee before any decision is taken that necessitates a hearing. Any councillor who considers

that their own interests are such that they are unable to consider the matter independently should disqualify themselves.

- 9.9 It is recommended that, in borderline cases, the benefit of the doubt about any aspect of a representation should be given to the person making that representation. The subsequent hearing would then provide an opportunity for the person or body making the representation to amplify and clarify it.
- 9.10 Licensing authorities should consider providing advice on their websites about how any person can make representations to them.

We are writing to formally object to the application submitted by East London Leisure LTD for the Horn of Plenty Pub to extend the current license for the provision of late night refreshments including alcohol sales and live and recorded music.

We believe that the extension applied for undermines licensing objectives, specifically public nuisance and the prevention of crime and disorder.

We strongly believe that late trading hours are disproportionate for this dense residential area and ask the committee to consider the impact on residents and reject the application. We ask that the committee consider more appropriate and reasonable hours and we suggest something similar to the "framework hours" (inclusive of the half hour allowed after last orders) described in the Tower Hamlets Licensing Policy:

- . Sunday 12 00 hrs to 22 30 hrs
- Monday to Thursday 12 00 hrs to 23 30 hrs

The application refers to a "small smoking area situated at the back of the premises"; we believe this to be the pavement on Alderney Road as there is no other patio or outside space connected to the pub as far as we know. The pavement outside the pub is narrow, only two people can walk side by side, and surrounded by housing including a residential care home directly opposite (Pat Shaw House).

Although the applicant describes the steps they will take to promote licensing objectives they do not say they will limit the number of customers allowed outside at any time nor do they suggest that they will bar customers from taking drinks outside.

We ask the committee to consider placing conditions on any license granted to limit the noise disruption from smokers and other customers outside of the pub because of the density of the residential housing on Alderney Road.

The previous pub landlords consistently breached the license conditions and the noise from the live and recorded music could be heard as far as the corner of Alderney and Argyle Road. Customers gathered on the pavement outside the pub entrance on Alderney, with drinks in hand, with complete disregard for residents. The noise form the pub was disruptive and anti-social behavior was very common. It was a regular occurrence for fighting to break out at closing hours, spilling down the road as far as Carlton Square.

There were also issues with noise disruption from emptying rubbish and recycling bins late at night. We ask the committee to consider placing conditions limiting the use of bins at night.

Local residents have been raising concerns about the increase in drug dealing outside of the pub in the last few months and we are concerned that late hours could make the situation worse.

We welcome a new business into the neighbourhood and want to see the ward thrive economically, especially with a pub that has the potential to be of community value.

But the provision of a late license and live and recorded music is not appropriate for such a residential location. We hope that the committee will consider our concerns and reject the application.

Re: Application to extend the licence at 36 Globe Road, E1 1DU, The Horn of Plenty

We are writing to object formally to the application submitted by East London Leisure Ltd to extend the terms of the licence for venue currently known as the Horn of Plenty pub.

Firstly, we would like to highlight how disappointed we were to find out about this application by a neighbour. There was no communication sent to us to our home address and the only public letter that highlights the requested changes has been put in the window of the pub at about two meters high so that it is almost impossible for most residents of average high to see it, read it and comment/object to it. Surely this is not how these applications should be dealt with.

In its previous incarnation, The Horn of Plenty opened on a Friday, Saturday and Sunday from 18.00. This application proposes a huge hike in business hours. Our objections to increasing licensing hours are:

- The opening hours applied for are not in keeping with the tone and requirements of this densely populated, family orientated residential area.
- A late night live/recorded music venue will cause particular disturbance and distress to residents, especially those close by to the Horn of Plenty, including the Pat Shaw Nursing Home opposite.
- Noise nuisance associated with live and recorded music will increase. From experience, we know this is something that will impact negatively on the sleep and wellbeing of the residents.
- There will be new noise nuisance (i.e. from people talking loudly, glass smashing and the doors being constantly opened allowing the music to escape) from the proposed outdoor smoking area.
- The amount of noise generated from drunk people leaving the pub late at night (i.e. after 1.30am) will cause distress and disturbance to local residents. A number of residents have a job that requires an early wake up call (i.e. 5am)
- There is no provision for limiting the number of people gathering outside the venue. This would make T Junction more hazardous just outside the pub where residents will have to cross the road without the aid of zebra crossing.

- There is no mention that customers will be barred from drinking in the proposed smoking area.
- There are no provisions to manage noise associated with late night rubbish collection.
- Increased antisocial behavior due to late night alcohol consumption will cause distress and disturbance to local residents, ultimately putting at risk the wellbeing, houses and cars of the residents.
- Concerns about drug dealing/taking already endemic in the area will cause distress and disturbance to local residents. Unfortunately this is very much a reality for local residents especially those in Alderney Road. There has been a number of complaints to the police about drug dealings just by the pub and we do believe that the extended opening hours will only further promote these types of behaviours.
- Extending opening hours will detrimentally impact on residents' parking. All residents in the area pay for a parking permit which guarantees a parking space close to home. Having to pay for a parking permit and not being able to park close to home is certainly not something that we would welcome.
- Extending opening hours will increase the number of delivery vehicles on a narrow, residential street, which has already had noise problems with delivery vehicles for Wetherspoons and the Cooperative Supermarket along Frimley Way not to mention the damage to cars that big trucks can and do to residents cars.

All these points are based on real experience following the Council's decision to extend the licensing hours The Horn of Plenty's 2009. We would urge you to consider very carefully the negative impact on the local community, which we believe outweigh the benefits of the proposed changes and ultimately reject the request from East London Leisure Ltd.

We welcome a friendly pub on this site with reasonable pub licensing hours (closing time 23.00) that can add value and vibe to the community by serving good food, holding quiz nights and providing a pleasant place to meet and make new friends (not just where people get drunk whilst watching match games). But as well as extending the opening hours, other areas of particular concern in this application are:

TV Sports

The Half Moon already provides this and we strongly believe that attracting a heavydrinking sports crowd to this street area is appropriate.

Outdoor Smoking Area

Creating this area will mean noise disturbance until at least midnight every day of the year for the local residents.

Picnic Baskets

The licence if passed in its current form would allow the licencee to sell alcohol for consumption "inside and outside the premises". Where are these people going to consume these picnic baskets mentioned in the application? On the street and in front of our houses? On the green at Carlton Square which, as the police are aware, already has a problem with litter and alcohol abuse? Who is going to collect the rubbish and deal with any resulting anti-social behaviour?

We truly hope that the committee will consider our concerns and reject the application in its current form.

Dear Licensing Team

As ward councillors for Bethnal Green, we are writing to oppose the application for an extension of the premises licence for The Horn of Plenty, 36 Globe Road, E1 4DU. We fully support local residents' concerns that extending the hours as applied for would undermine the licensing objectives, namely the prevention of public nuisance and the prevention of crime and disorder.

While we welcome and support community pubs where they are managed in a way that is sympathetic to the needs and character of the local vicinity, the application as currently conceived fails to take account of the densely residential area in which the premises is situated and the past problems residents have suffered due to the late operating hours and poor management of this premises. While we recognise this is new management, it is particularly concerning that in section M of the application the applicant gives barely any information about how they will promote the licensing objectives given the late hours applied for.

The hours currently applied for - opening until 12.30am on Sun-Weds and 1.30am Thurs-Sat - are highly disproportionate for the nature of the local

vicinity, which includes a residential nursing home adjacent on Globe Road, flats above and adjacent on Alderney Road, and terraced properties immediately opposite on Alderney Road. There are large numbers of pensioners and families living in the surrounding properties. When this premises was previously in operation until 1am on Friday-Sunday, residents regularly suffered from noise disturbance due to unacceptably loud music (live and recorded), late night rubbish disposal/collection, vehicles coming and going, and rowdy intoxicated patrons, including people smoking outside, shouting and even fighting on Alderney Road. If the premises is permitted to open until 12.30am Sun-Weds and 1.30am Thurs-Sun, with music until 12am and 1am respectively and a proposed new smoking area, it is likely such detrimental activity will happen throughout the week which will greatly increase public nuisance and undermine local residents' quality of life.

We are also concerned that granting the sale of alcohol until 12am Sun-Weds and 1am Thurs-Sat - including offsales - will increase antisocial behaviour and disorder in an area which is already suffering from high levels of drug dealing, directly adjacent to the pub on Alderney Road. Such late opening hours are likely to result in an increase in intoxicated patrons in the area every night of the week, leading to antisocial behaviour which will only add to the disturbance and distress caused to residents. Past experience of this premises gives a strong indication that such late opening hours will exacerbate antisocial behaviour and disorder immediately outside the premises and as residents leave down the various residential streets.

We strongly urge the Licensing Sub Committee to heed the concerns of residents and councillors before extending the licence further. As stated above, we would welcome a pub which respects the needs of its neighbours and adds valuable community amenities to the area. However, the application as it stands does not strike this balance. Given the highly residential nature of the area and past evidence of problems with late opening hours, we believe the hours the premises is open to the public and permitted to sell alcohol should be no greater than the licensing policy's framework hours and further consideration should be given to residents' suggestions for further restrictions on hours of operation.

We also urge the committee to place conditions on the licence which are proportionate to mitigate noise disturbance, including:

- No patrons to be permitted to smoke or congregate outside the entrance on Alderney Road

- A maximum limit to be placed on the number of patrons permitted to smoke or congregate outside the Globe Road entrance at any one time

- No patrons to be permitted to take drinks outside
- No rubbish to be disposed of outside between 10pm and 8am
- Restrictions on noise levels from live and recorded music to be agreed

Egil, I will make some comments on this as my department are concerned about noise issues. The pub has a long history of noise and anti-social behaviour linked to it. The pub is in a very dense

residential area and the hours you are looking for are excessive. I would expect recorded music to cease at 23.00 Sun – Thurs and midnight Friday and Saturday. I would also expect you to fit a sound limiting device and that all recorded music played at the premises be through the installed system. This system to be set by an officer from my department once installed. This is to ensure that Public Nuisance is kept to a minimum during sensitive hours of rest for local residents.

The idea of having more than 5 smokers in an enclosed courtyard that you intend to use throughout the operation of your premises also causes concern. I am presuming that the courtyard is at the east of your premise. At this point in time, I am willing to let you run with that, but if we start receiving complaints about noise from this area, we will request restrictions on the use of this area. Noise while the Premise is in Use

General Advice

If they conclude this is a problem Members should consider whether it is possible to carry out suitable and proportionate noise control measures so that noise leakage is prevented. In addition Members may consider that only certain activities are suitable.

The hours of operation also need to be considered (see below).

If Members believe that there is a substantial problem of noise while the premises are in use and it cannot be proportionately address by licensing conditions they should refuse the application.

Licensing Policy

The policy recognises that noise nuisance can be an issue, especially if a premises is open late at night. (See Sections 10 of the Licensing Policy).

The policy also recognises that staggered closing can help prevent problems at closure time (**See Section 15.1**).

However, while all applications will be considered on their merits, consideration will be given to imposing stricter conditions in respect of noise control where premises are situated close to local residents. (**See Section 15.5**).

The Licensing Authority expects the applicant to have addressed all nuisance issues relating to the premises in their operating schedule and to have sought appropriate advice from the Council's Environmental Health Officers. (See Sections 10.2 of the Licensing Policy).

The Licensing Authority will consider attaching conditions to prevent nuisance and these may include Conditions drawn from the Model Poll of Conditions relating to Public Nuisance. (**See Annex G of the Licensing Policy**). In particular Members may wish to consider (this list is not exhaustive):

- hours of opening (this needs to be balanced against potential disorder caused by artificially early closing times
- Whether certain parts should close earlier than the rest (for example a "beer garden", or restricted in their use
- Whether or not certain activities should have to close at an early hour, for example live music
- Conditions controlling noise or vibration (for example, noise limiters, keeping doors and windows closed).

- Prominent clear and legible notices at all exits requesting the public to respect the needs of local residents and leave the premises and area quietly
- Conditions controlling the use of explosives, pyrotechnics and fireworks
- Conditions controlling the placing of refuse
- Conditions controlling noxious smells
- Conditions controlling lighting (this needs to be balanced against potential crime prevention benefits)

Police Powers

Part 8 of the Licensing Act 2003 enables a senior police officer to close down a premises for up to 24hrs a premises causing a nuisance resulting from noise emanating from the premises.

Guidance Issued under Section 182 of the Licensing Act 2003

The prevention of public nuisance could include low-level nuisance, perhaps affecting a few people living locally as well as major disturbance affecting the whole community (2.19).

Licence conditions should not duplicate other legislation (1.16) Any conditions should be tailored to the type, nature and characteristics of the specific premises. Licensing authorities should be aware of the need to avoid inappropriate or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are very expensive to purchase and install and are likely to be a considerable burden for smaller venues. (2.20)

Necessary and appropriate conditions should normally focus on the most sensitive periods (2.22) and may address disturbance as customers enter or leave the premises but it is essential that conditions are focused on measures within the direct control of the licence holder.

Other Legislation

The Environmental Protection Act 1990, Part 111 gives Environmental Health Officers the power to deal with statutory nuisances.

The Anti-social Behaviour Act 2003, Sections 40 and 41 give Environmental Health Officers the power of closure up to 24 hours in certain circumstances

Noise Leakage from the Premises

General Advice

Extending hours may bring issues about noise leakage to the fore, as many premises are close to residential properties (or even sometimes commercial).

The obvious areas for Members to consider, if they believe there is a problem and it is proportionate to consider conditions are:

- Can internal works, actions or equipment reduce the noise leakage
- Does the problem justify curtailing the activities that are licensed. If Members are minded to do this they must ensure conditions are clear and readily enforceable. For example "Jazz Music Only" is not capable of legal definition and is unenforceable.
- Does the problem justify limiting the hours or place of particular activities. For example "no music in the beer garden at any time and no music past 22:30hrs" although the premises can stay open until 01:00hrs.

Members also need to bear in mind the statutory exemptions under the Act (see below).

Licensing Policy

The Licensing Authority expects applicants to have sought advice and to be able to explain how they will address problems. (See Sections 10.1-2), especially where a negative impact is likely on local residents or businesses (See 15.1 for core licensing hours).

The Licensing Policy recognises that staggered hours can make a positive contribution to alcohol related issues but that consideration will be given to imposing stricter conditions in respect of noise control where premises are close to residents. **(See 15.5).**

The Licensing Authority will consider attaching conditions to prevent nuisance and these may include Conditions drawn from the Model Pool of Conditions relating to public nuisance. (**See Annex G of the Licensing Policy**). In particular Members may wish to consider the following: (this list is not exhaustive):

- hours of opening (this needs to be balanced against potential disorder caused by artificially early closing times
- Whether certain parts should be restricted in their use
- Whether or not certain activities should have to close at an early hour, for example live music
- Conditions controlling noise or vibration (for example, noise limiters, keeping doors and windows closed).
- Prominent clear and legible notices at all exits requesting the public to respect the needs of local residents and leave the premises and area quietly
- Conditions controlling the use of explosives, pyrotechnics and fireworks

Police Powers

Part 8 of the Licensing Act 2003 enables a senior police officer to close down for up to 24hrs premises causing a nuisance resulting from noise emanating from the premises.

Licensing Act 2003

Schedule 1 Part 2 states that entertainment in churches, morris dancing and accompanying music if live and unamplified and incidental music are not licensable activities-that is no conditions can be set for them.

Section 177, (1) and (2) of the Act provides that where a premises (or club) is licensed for alcohol consumption on the premises and is primarily thus used, and the permitted capacity does not exceed 200 additional conditions relating to the performance of dance should only relate to public safety or the prevention of crime (or both). That is they should not relate to any "noise nuisance."

Section 177 (4) provides that where a premises licence (or club) has a capacity of not more than 200 and the only music is unamplified live music between 08:00hrs and 00:00hrs (midnight), no additional conditions should be set relating to the music.

Section 177 can be disapplied on a licence review if it is proportionate to do so.

<u>Public Nuisance Guidance issued under Section 182 of the Licensing Act 2003</u> The Licensing Policy has adopted the recommended Pool of Conditions The prevention of the public nuisance could include low level nuisance, perhaps affecting a few people living locally (2.19). Licence conditions should not duplicate other legislation (1.16).

Necessary and appropriate conditions should normally focus on the most sensitive periods and may address disturbance as customers enter or leave the premises (2.22), but it is essential that conditions are focused on measures within the direct control of the licence holder.

Other Legislation

Environmental Health Officers have extensive powers under the Environmental Protection Act 1990 to control a noise nuisance, including a power of immediate closure

Access and Egress Problems

Such as:

Disturbance from patrons arriving/leaving the premises on foot Disturbance from patrons arriving/leaving the premises by car Lack of adequate car parking facilities Close proximity to residential properties

Comment

The above have been grouped together as egress problems. Of course the particular facts will be different for each alleged problem.

Egress only is referred to-if necessary access can be added or substituted in.

General Advice

In considering concerns relating to disturbance from egress, Members need to be satisfied that the premises under consideration has been identified as the source of the actual or potential disturbance. If they are satisfied that this is a problem, then proportionate conditions should be considered.

The hours of operation also need to be considered.

If Members believe that there is a substantial problem concerning egress and it cannot be proportionately addressed by licensing conditions, they should refuse the application.

Licensing Policy

The policy recognises that noise nuisance can be an issue, especially if a premises is open late at night. (See Section 10 of the Licensing Policy).

The Licensing Authority expects the applicant to have addressed all nuisance issues relating to the premises in their operating schedule and to have sought appropriate advice from the Council's Environmental Health Officers. (See Section 10.2 of the Licensing Policy).

The policy also recognises that staggered closing can help prevent problems at closure time (**See Section 15.1**).

However, while all applications will be considered on their merits, consideration will be given to imposing stricter conditions in respect of noise control where premises are situated close to local residents. (See Section 15.5)

The Council has adopted a set of framework hours (**See 15.8 of the licensing policy**). This relates to potential disturbance caused by late night trading. The Licensing Authority will consider attaching conditions to prevent nuisance and these may include Conditions drawn from the Model Pool of Conditions relating to the prevention of Public Nuisance. (**See Annex G of the Licensing Policy**). In particular Members may wish to consider (this list is not exhaustive):

- hours of opening (this needs to be balanced against potential disorder caused by artificially early closing times
- Whether certain parts should close earlier than the rest (for example a "beer garden", or restricted in their use
- Whether or not certain activities should have to close at an early hour, for example live music
- Conditions controlling noise or vibration (for example, noise limiters, keeping doors and windows closed).
- Prominent clear and legible notices at all exits requesting the public to respect the needs of local residents and leave the premises and area quietly

Guidance Issued under Section 182 of the Licensing Act 2003

The prevention of public nuisance could include low-level nuisance, perhaps affecting a few people living locally as well as major disturbance affecting the whole community. (2.19).

Licence conditions should not duplicate other legislation (1.16).

Any conditions should be tailored to the type, nature and characteristics of the specific premises. Licensing authorities should be aware of the need to avoid inappropriate or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are very expensive to purchase and install and are likely to be a considerable burden for smaller venues. (2.20)

Measures can include ensuring the safe departure of customers, these can include:

- Providing information on the premises of local taxi companies who can provide safe transportation home; and
- Ensuring adequate lighting outside the premises, particularly on paths leading to and from the premises and in car parks

Necessary and appropriate conditions should normally focus on the most sensitive periods (2.22) and may address disturbance as customers enter or leave the premises but it is essential that conditions are focused on measures within the direct c

Licensing Policy Relating to Hours of Trading

All applications have to be considered on their own merits.

The Council has however adopted a set of framework hours as follows:Monday to Thursday06:00hrs to 23:30hrsFriday and Saturday06:00hrs to 00:00hrs (midnight)Sunday06:00hrs to 22:30hrs

(see 12.8 Of the licensing policy)

In considering the applicability of frame work hours to any particular application regard should be had to the following

- Location
- Proposed hours of regulated activities, and the proposed hours the premises are open to the public
- The adequacy of the applicants proposals to deal with issues of crime and disorder and public nuisance
- Previous history
- Access to public transport
- Proximity to other licensed premises, and their hours

(See 12.8 of the licensing policy)

Subject to any representations to the contrary in individual cases the following premises are not generally considered to contribute to late night anti-social behaviour and will therefore generally have greater freedom

- Theatres
- Cinemas
- Premises with club premises certificates
- Premises licensed for off sales only
