### 3.0 Review Application

3.1 This is an application for a review of the premises licence for Muhib Indian Restaurant, 73 Brick Lane, London, E1 6QL. The review was triggered by The Metropolitan Police Licensing Unit on the 15<sup>th</sup> January 2015.

3.2 A copy of the review application is attached in **Appendix 1**.

3.3 Additional statements have been provided by the Police in support of the review, these are detailed in **Appendix 2**.

### 4.0 The Premises

4.1 The premises licence was issued on 6<sup>th</sup> October 2005. A copy of the current licence is contained in **Appendix 3**.

4.2 **10<sup>th</sup> December 2007**, the licence was transferred (and variation of Designated Premises Supervisor) to Mr Abdul Ahad who is the director of the "Copper Chimney (London) Limited" (current licence holder).

4.3 **15<sup>th</sup> November 2011**, Trading Standards review hearing. At that time, the licence holder was Abdul Ahad. The members of the subcommittee made a decision to *suspend the Premises Licence for three days and add touting conditions*.

4.4 14<sup>th</sup> March 2012, the licence was transferred to Curry Choice Ltd and the name of the director was Elias Miah and the DPS was Rezzaur Rahman.

4.5 **8<sup>th</sup> November 2012**, Trading Standards review hearing. The members of the subcommittee made a decision to *suspend the licence for a period of ONE MONTH and Remove the current Designated Premises Supervisor*.

4.6 Vary DPS: Mr Mohammed Tonjob Ali has been the designated premises supervisor on the since 23<sup>rd</sup> November 2012.

4.7 **8<sup>th</sup> April 2014**, Police review hearing decided by the Councils Licensing Sub-Committee. *Members made a decision to add the Police CCTV conditions*.

4.8 Since the current review was triggered, we received an application to transfer the licence to "Copper Chimney (London) Limited" on the 23<sup>rd</sup> January 2015. The company director is Abdul Ahad who has been a licence holder previously as mentioned above. This transfer application has been included in **Appendix 4** for Member's information. The Police review documents were forwarded to the new licence holders.

4.9 Maps showing the premises are included in **Appendix 5**.

## 5.0 Representations

- 5.1 This hearing is required by the Licensing Act 2003, because a review has been triggered by the Metropolitan Police. The review is further supported by Residents Associations.
- 5.2 Please see **Appendix 6** for the representation of Conor McLernon (Spitalfields Society).
- 5.3 Please see **Appendix 7** for the representation of John Shapiro (SPIRE).
- 5.4 Please see **Appendix 8** for the representation of Margaret Gordon (St George Residents' Association).
- 5.5 Only representations that relate to the following licensing objectives are relevant:
  - the prevention of crime and disorder
  - public safety
  - the prevention of public nuisance
  - the protection of children from harm
- 5.6 In the view of the interested party and the responsible authorities it is necessary to achieve the licensing objectives of the prevention of public nuisance, prevention of crime & disorder and public safety.

## 6.0 Review Explained

- 6.1 The Licensing Act 2003 was described by the Government at the time as “light touch” but as Baroness Blackstone stated in the Lords at the time of the second reading “Local residents and businesses as well as expert bodies, will have the power to request that the licensing authority review existing licences where problems arise. Such a review could result in the modification of the licence, its suspension, or ultimately, revocation.”
- 6.2 The Home Office has issued guidance under Section 182 of the Licensing Act 2003 in relation to reviews and that is contained in **Appendix 9**. It is available on the Government’s website, [www.homeoffice.gov.uk](http://www.homeoffice.gov.uk). It was last revised March 2015.
- 6.3 Members are particularly asked to note the comments in relation Crime and Disorder. In particular the home office advice is that “The role of the licensing authority when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure that the crime prevention objective is promoted.”
- 6.4 In relation to its advice on representations the home office has also advised that “there is no requirement for an interested party or responsible authority to produce a recorded history of problems at a

premises to support their representations.” It has also issued revised guidance about Crime and Disorder, and the pool of conditions which might be considered in relation to any identified problems. **See Appendix 10.**

- 6.5 The home office has also issued guidance about the prevention of public nuisance and the pool of conditions which might be considered in relation to any identified problems is contained in **Appendix 11.**
- 6.6 Members should also note the Council’s Licensing Policy in relation to Crime and Disorder, the relevant parts of which are contained in **Appendix 12.** The Council’s Police on Public Nuisance is contained in **Appendix 13.**
- 6.7 The Home Office has advised that in relation to reviews “It is important to recognise that the promotion of licensing objectives relies heavily on a partnership between licence holders, authorised persons, interested parties and responsible authorities in pursuit of common aims. It is therefore equally important that reviews are not used to drive a wedge between those groups in a way that would undermine the benefits of co-operation. It would be good practice for authorised persons and responsible authorities to give licence holders early warning of their concerns about problems identified at the premises concerned and of the need for improvement. It is expected that a failure to respond to such warnings would lead to a decision to request a review.”
- 6.8 The licensing authority itself cannot trigger a review; that can only be done by a responsible authority or an interested party (local resident, business or member of the Licensing Authority).
- 6.9 An interested party or a responsible authority can trigger a review at any time, but the grounds must be relevant to the licensing objectives. The form of the application, and the advertisement of the review are the subject of regulations (The Licensing Act 2003 (Premises Licences and Club Premises Certificate) Regulations 2005). In addition, the licensing authority has to satisfy itself of certain matters in relation to the Licensing Act 2003. The Licensing Services Manager Ms Jacqueline Randall is the delegated officer who deals with this on behalf of the licensing authority. All the matters stated in 5.0 were considered before any representations were accepted for inclusion in this report.
- 6.10 The Licensing Act 2003 requires that the Licensing Authority satisfies itself that it should reject the grounds for a review because:
  - The ground is not relevant to one or more of the licensing objectives
  - In the case of an application by a local resident that the application is frivolous, vexatious or repetitious.

## 7.0 **Review Advertisement**

- 7.1 The review was advertised by a blue poster, next to the premises, by the Licensing Section. This was periodically monitored by the Section to ensure it was on continuous display, and replaced as necessary. It was also advertised at Mulberry Place, 5 Clove Crescent, London E14 2BG.
- 7.2 There was a technical error on the public notice so the consultation date ended on the 23<sup>rd</sup> March 2015.
- 7.3 The party that triggers the review must notify the licence holder and responsible authorities. The review documents were sent to the licence holders.
- 7.4 The procedure for a review can be summarised as follows:
- A review is triggered by a responsible authority or interested party
  - Consultation is conducted for 28 full days
  - Other responsible authorities or interested parties may join in the review
  - Members conduct a hearing
  - Members make a determination
  - All the parties to the review have the right of appeal to the magistrates court (i.e. the licence holder, the person who triggered the review and those who have made a representation).

## 8.0 Licensing Officer Comments

8.1 The Governments advice in relation to reviews is contained in **Appendix 9**. Members must consider all the evidence and then decide from the following alternatives:

- Take no further action as they do not consider it proportionate to do so
- Impose conditions (including altering existing permissions) that relate to problems which they consider have been identified and which are necessary and proportionate to ensure that the licensing objectives are met
- Suspend the licence for a period
- Revoke the licence completely

8.2 The licence should only be suspended or revoked if Members believe that alterations to the existing licence, including imposing new conditions does not have a reasonable prospect of ensuring that the licensing objectives are met.

8.3 Members should bear in mind that conditions may not be imposed for any purpose other than to meet the licensing objectives.

8.4 In all cases the Members should make their decision on the civil burden of proof that is “the balance of probability.”

8.5 In all cases Members should consider whether or not primary legislation is the appropriate method of regulation and should only consider licence conditions when the circumstances in their view are not already adequately covered elsewhere.

## 9.0 Legal Comments
