Scrutiny Challenge Session Report

- The Scrutiny Challenge Session Report on Premises Charges and the Community Benefit Rent Reduction Scheme is scheduled to be presented at the Overview and Scrutiny Committee on 24 February.
- This report is the outcome of the challenge session held in November 2019 which was attended by council officers, partners and community organisations.
- There are currently six recommendations resulting from the session relating to the community benefit rent reduction scheme, community buildings, capacity building and community hubs.
- The Overview and Scrutiny Committee are being asked to agree the recommendations made.

Grants Determination Sub-Committee Meeting

- The Grants Determination Sub-Committee meeting was held on 16 January with all items agreed. Scrutiny attended the session and requested further information on two of the three items.
- The next meeting of the sub-committee is scheduled for Wednesday 4 March and the agenda and accompanying reports will be circulated the week before. Scrutiny members are encouraged to send any questions on these items to Katy McGinity by mid-day Monday 2 March in order for further information to be requested from services before the meeting.

Scrutiny Lead for Environment and Community Safety Cllr Bex White

The Action Plan from the Community Safety Challenge Session on Resident Engagement in Safer Neighbourhood Panels is almost complete, pending input from Police, Public Realm and Youth Council. We have had productive engagement with Comms, Safer Neighbourhood Board, Mayor's Office and Lead Member for Community Safety.

We have scoped the next scrutiny challenge session on behaviour change within Environment and details will be circulated to members shortly. I intend to involve residents as much as possible in this session.

I've had meetings with 3 Cabinet Members for Community Safety, Air Quality and Environment.

In the coming weeks I will be scrutinising the reports from the waste service on missed collections and will provide an update on this at the next OSC.

I have participated in an organisational self-assessment for the Equality Framework for Local Government examining how the organisation's leadership promotes a meaningful commitment to equality within the OSC.

Scrutiny lead for Health and Adults Kahar Chowdhury

The next Health & Adults Scrutiny sub-committee meeting is scheduled for 12 March 2020 and the following is expected:

- The committee will hear about the PAN-London Sexual Health contract and assess the benefits of the new model. Health Watch have been undertaking insight work on sexual health services and the early findings will inform a joint approach with Barts' Health and GP Care Group in terms of abortion services, primary care and hospital based gynaecology services. This is an opportunity for the committee to get involved early on in the development work to support service improvement. Barts health have offered to host the next meeting at their Ambrose King Sexual Health centre. This is an exciting opportunity for the committee to visit the centre and see how the multimillion pound investment has improved patient and clinical environment. This also means the committee will be more accessible to the community as it intends to host more meetings outside of the town hall.
- The Joint Commissioning Team (Council and CCG) will set out how integration is structured in Tower Hamlets and North East London landscape and show practical examples of how this is being delivered and outlining priorities and plans for the future.
- A key part of the NHS long-term plan, primary care networks (PCNs) will bring general
 practices together to work at scale. But what are they? How are they funded and held
 accountable? And what difference will they make? We hope a report from the GP
 Care Group in Tower Hamlets will help us understand this better.
- The ASC Charging Impact Assessment has been of great interest to the committee
 and has generated a lot of discussion and information requests. This report will collate
 and summarise the requests and responses from the committee into one place to
 inform a discussion on the issue at the March 2020 meeting. It will also provide an
 update on the July 2019 request for more information on financial modelling in relation
 to respite.
- The committee has made a request to adult social care to present their savings proposal to merge physical disability day opportunities service with Riverside Day service so that we can better understand any potential changes and impact to the service offer.

Scrutiny Challenge Session: Learning Disability

- The committee feel outcomes are not improving fast enough for adults with Learning
 Disability and would like to investigate how services are responding to the needs of
 the service users and the wider community. The aim of the annual review is 'to
 examine how services are supporting adults with Learning Disability to live
 independent lives'. We will be focusing on the following there areas
 - How services are addressing physical health management of adults with learning disability?
 - How are adults with learning disability supported into paid employment?

- How adults are supported to live locally?
- This review will inform the refresh of the Learning Disability Strategy 2020-25 and any other broader concerns related to Learning Disability provision will be picked up as part of the strategy development work. We have provisionally agreed a date to hold a challenge session with relevant officers on Tuesday 10 March, 6pm in the Town Hall. We would like to extend the invite to members and will be grateful if you can come along and support this review.
