Dear Sir/Madam,

I am wiring in support of E1's application for a temporary outside space.

The last few months have been a desperate time for almost everyone. For those who work in the hospitality and entertainment sectors, it has been particularly dreadful. Many of those who work in this industry are young and likely to be employed on zero-hour contracts or a freelance basis. The government's furlough scheme has been of limited use for many of them. If E1 can open this site and provide employment opportunities for many of those hit hardest by this pandemic, then it is important that they are allowed to do so, as long as distancing requirements are met of course.

Moreover, it is important that the entertainment and music industry returns for the enjoyment of the public. We have seen in recent weeks illegal gatherings of young people taking place, without any distancing or registration of guests, often in dangerous environments with no security staff or emergency protocols. E1's Site 5 will allow people to enjoy themselves - something that many people deserve after such a long time - in a safe and secure manner.

Rather than increase crime or disorder in London, initiatives such as this will actually help avoid it.

I am a regular visitor to E1 and I have never yet seen trouble there. It is an important feature of the community in Wapping and has been for many years. It would be a crying shame were it to close permanently as a result of this pandemic. We should be doing all we can to support cultural and entertainment venues at this time.

Dear Hamlet Towers Licensing commission,

I hope this email finds you well.

I write to you today to show my support towards E1 and their new venture, Site 5, with the hope that its license can be approved.

E1 is a place that many of us hold dear to our hearts. It's a place of gathering for a community of people who live and breathe music, that go there to enjoy the work of true artists, amongst the best in the world in what they do, alongside like-minded Londoners and tourists who recognise it as place worth visiting if electronic music is your thing.

It also happens to be the livelihood of several people who work there, from full-time staff working in all areas of the business, as well as part-timers, freelancers, artists and many others.

Given that social distancing restrictions don't allow for indoor music venues to open their doors just yet, as well as the uncertainty as to how long this situation could go on for, E1, very resiliently and cleverly have managed to reinvent themselves through the opening of the outdoor space they've named Site 5, as to have some sort of income to help weather the storm we're all going through at the moment. It's worth noting that despite many sectors of the economy having received financial support from the government, the nightlife sector, especially nightclubs and live music venues have seemed to be forgotten and have received very little, if any help at all, making them rely, now more than ever, on their creativity to exploit all of their resources at hand.

What E1 are proposing to offer is basically an outdoor drinking terrace, like the ones we find in pubs all across London and especially in the area. For quite a few years a similar space has operated in Tobacco Dock without any major issue (crime, noise, nuisances, etc) whatsoever having been suffered by the community around it, therefore there's no reason why E1 shouldn't be allowed to have a shot at running this open-air bar to sustain themselves whilst they're able to go back to doing what they do best, throwing world class live music events that enrich London's nightlife and culture in general.

Not letting Site 5 operate is almost a killer blow to E1's hopes of surviving the Covid-19 crisis, one swift blow that could result in a considerable amount of people out of their jobs, unable to sustain themselves and further damaging the country's economy. From the cultural point of view, the closure of E1 would be a huge loss towards the world-leading electronic music scene London prides itself on having and that before this crisis was a yearly multibillion industry nationwide.

All in all, sentencing this place to its death can't have but a negative impact on the community it's surrounded by, impoverishing it at a cultural as well as an economical level. Some people think that live music venues can cause undesired situations, such as crime to rise, however there is no evidence that supports this. On the other hand it's well known that what does cause crime to worsen is joblessness and people being unable to sustain themselves through their own means. Without there being any tangible gain or benefit from its closure, which there doesn't seem to be, not letting Site 5 operate and therefore sealing E1's fate in such a negative way, would be a rather unfortunate and retrograde course of action that could be easily avoided.

Hoping this doesn't not fall on deaf ears and common sense prevails, I thank you for your time, attention and comprehension on the matter.

I am writing to express my disappointment at the council's recent decision to contest the licensing for the E1/Sit 5 Licensing application.

Given the difficult situation facing the hospitality industry at the moment, we have seen many different establishments try to secure revenue to stay afloat however they can, legally, within the laws imposed by our government.

E1 is not unlike any other firm here, and have entrepreneurially acquired an outdoor space to provide food, drinks, entertainment, and social respite to the community of Tower Hamlets in a way that enriches our local and social life to the utmost.

There are numerous benefits to this, which include the ability to cease furlough of staff, allow one of London's most important nightclubbing institutions to remain afloat, and also to provide positive economic externalities to local food and drink vendors by giving an additional opportunity to sell their wares.

I live close to this site [REDACTED] and strongly support the application to enable Tower Hamlets' open space to be used for legitimate and legal socially distanced socialising.

Too many of the area's parks and green spaces are no go areas caused by people - often younger - wanting to socialise but lacking licenced and legal areas to do so. In short: without appropriate licenced venues, people move to the parks. And in the parks they do drugs as well drinking alcohol. It's not about drugs for them, it's about being able to socialise.

Enabling the use of this space for the kind of social interaction that young people want would be a crucial step towards freeing the area's communal space for those who simply want to enjoy nature.
